Notes to Financial Statements

Note 1: Description of Plan

The following description of the Human Development Center 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all qualified non-union employees of Human Development Center (Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligible employees include all regular, full-time non-union employees who have attained age 21. Employees are eligible to participate in the Plan following the satisfaction of completing 1 hour of service within 30 days. Employees are eligible to receive Sponsor contributions upon completing 1 hour of service within 30 days.

In December 2022, Securing a Strong Retirement Act (SECURE 2.0) was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2019 CARES Act. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Plan management will determine the optional provisions to elect in the future.

Contributions

Each year, participants may contribute a dollar amount of annual compensation, as defined in the Plan, up to the maximum allowed by the IRS. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Plan also includes an automatic enrollment provision whereby all newly eligible employees are enrolled in the Plan at a 5% pre-tax deferral rate unless they make a different election. Additionally, the Sponsor makes a safe harbor matching contribution equal to 100% of a participant's elective deferral not exceeding 3% of the participant's compensation, plus 50% of deferrals in excess of 3% but not in excess of 5% of the participant's compensation. The Sponsor may, at its discretion, make an additional contribution to the Plan. The Sponsor did not make any additional discretionary contributions to the Plan for the year ended December 31, 2024. Participants direct the investment of contributions into various investment options offered by the Plan.

Note 1: Description of Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions, the Sponsor's safe harbor contribution, and allocations of (a) the Sponsor's discretionary contribution and (b) Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, Sponsor safe harbor contributions, Sponsor discretionary contributions, rollover contributions, and earnings (losses), thereon.

Payment of Benefits

On termination of service, a participant may elect to receive a lump-sum amount equal to the vested balance in his or her account, or the participant may defer receipt of any distribution until retirement if their account balance is greater than \$7,000. However, when a request is not received, accounts with balances less than \$7,000 will be automatically distributed to the participant in a lump sum. In addition, in-service distributions are allowed for participants upon attaining age 59 1/2.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account and bear interest at a rate equal to the Wall Street Journal prime interest rate plus 1%. Interest on existing loans range from 4.25% to 9.50%. Principal and interest is paid ratably through regular payroll deductions.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Note 2: Summary of Significant Accounting Policies (Continued)

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as they are incurred. No allowances for credit losses have been reported at December 31, 2024 and 2023. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to Plan participants based on their respective account balances and are included in net investment income.

Subsequent Events

The Plan administrator has evaluated subsequent events through January 5, 2026, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Money market fund: Valued at cost which approximates fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 3: Fair Value Measurements (Continued)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth by level the Plan's assets at fair value on a recurring basis as of December 31, 2024 and 2023.

Note 4: Information Prepared and Certified by the Trustee

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments, noninterest-bearing cash, and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year then ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Alerus Financial, N.A., the Trustee of the Plan.

Note 5: Tax Status

The Sponsor adopted a non-standardized pre-approved profit-sharing plan document with an IRS opinion letter, which states the pre-approved plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since the date of the opinion letter; however, the Plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Sponsor may determine.

Note 7: Party-in-Interest Transactions

Alerus Financial, N.A., Trustee of the Plan, managed Plan investments in money market and mutual funds. These transactions qualify as party-in-interest transactions. Fees paid to Alerus Financial, N.A. for investment management services are included in net appreciation in fair value of investments. Fees incurred and paid to Alerus Financial, N.A. by the Plan for recordkeeping services were \$6,753 for the year ended December 31, 2024, and are recorded in administrative expenses.

Notes receivable from participants also qualify as party in interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9: Plan Transfers

The Plan allows participants, with the approval of the Plan administrator, to transfer balances to and from the Human Development Center Union 401(k) Profit Sharing Plan. The Plan provisions allow vesting percentages and schedules to be retained after a Plan-to-Plan transfer occurs. Assets of \$586,652 were transferred from the Human Development Center Union 401(k) Plan during the year ended December 31, 2024, and assets of \$14,563 were transferred to the Human Development Center Union 401(k) Plan during the year ended December 31, 2024. As of December 31, 2024, the Plan has recorded a receivable of \$414,200 related to pending transfers due from the Human Development Center Union 401(k) Plan.

Note 10: Prohibited Transactions

Under DOL Reg. 2510.3-102(b), the Sponsor is required to remit the employee contributions to the Plan at the earliest date such amounts can be reasonably segregated from the Sponsor's general assets, but no later than the fifteenth business day of the month following the date that participant contributions are withheld by the Sponsor. As reported on Schedule H, Line 4a – Schedule of Delinquent Participant Contributions, certain contributions were incorrectly calculated due to errors in compensation totaling \$1,736 for the year ended December 31, 2024.

These transactions constitutes a prohibited transaction as defined by ERISA. The Sponsor voluntarily corrected these deposits subsequent to year end.
