Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2021 Financial Statements

We have performed an audit of the financial statements of Southeast Utilities of Georgia, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2021, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Financial Statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2021, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Emphasis of Matter – Plan Termination

As discussed in Note 9 to the financial statements, the Company approved the termination of the Plan subsequent to the plan year-end, and the Plan Administrator initiated the termination process with John Hancock Life Insurance Company (U.S.A.). Our opinion is not modified with respect to this matter.

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Southeast Utilities of Georgia, Inc. 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Note 1. Description of Plan

The following description of the Southeast Utilities of Georgia, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document and Adoption Agreement for a complete description of the Plan’s provisions.

General – The Plan is a defined contribution 401(k) retirement plan established effective January 1, 2017 and is sponsored by Southeast Utilities of Georgia, Inc. (the “Company”). The Plan is intended to provide eligible employees with the opportunity to accumulate retirement savings through employee elective deferrals and Company contributions. The Plan is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

The Plan’s investments are held under a group annuity contract with John Hancock Life Insurance Company (U.S.A.) (“John Hancock”), which also serves as the Plan’s recordkeeper. Plan investments are held in pooled separate accounts offered through John Hancock’s investment platform.

Eligibility – Employees, excluding nonresident aliens with no U.S.-source earned income and any employees covered by a collective bargaining agreement in which retirement benefits were bargained in good faith, are eligible to participate in the Plan upon attaining age 21 and completing one year of service (defined as at least 1,000 hours of service during a twelve-month eligibility period). Eligible employees enter the Plan on the first day of the Plan Year (January 1) or the first day of the seventh month of the Plan Year (July 1) coinciding with or next following satisfaction of the eligibility requirements.

The Plan contains an Eligible Automatic Contribution Arrangement (EACA). Employees who meet the eligibility requirements and do not make an affirmative election are automatically enrolled at a 1 percent elective deferral rate, which automatically increases by 1 percent each Plan Year to a maximum automatic rate of 3 percent, unless the participant opts out of automatic enrollment or elects a different contribution percentage.

Contributions – Participants may contribute a portion of their eligible compensation to the Plan as pre-tax elective deferrals or Roth elective deferrals, subject to the annual limitations established under the Internal Revenue Code (“IRC”). Participants who are age 50 or older by the end of the year are permitted to make catch-up contributions in accordance with IRC limits (\$6,500 for 2021). The Plan also allows participants to contribute rollover amounts from other qualified retirement plans or individual retirement accounts, subject to applicable laws and Plan provisions, including in cases where the employee has not yet satisfied the Plan’s general eligibility requirements.

The Company may make discretionary employer matching contributions and discretionary nonelective (profit-sharing) contributions to the Plan, as determined annually by the Company. Employer contributions, when made, are allocated in accordance with the terms of the Plan and are subject to the Plan's vesting provisions.

Participant Accounts – Each participant's account is credited with the participant's contributions, employer's contributions, and allocations of Plan net earnings depending on the investment options selected by the participant. Participant accounts are also charged with distributions and an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific transactions, as defined. Upon enrollment in the Plan, participants may direct their contributions into any of the investment options available. A separate account is maintained for each participant, and interest and dividends earned by each fund may be reinvested in that fund. Participants may change their investment options at their discretion.

Vesting – Participants are immediately vested in their contributions and rollover contributions, plus actual earnings thereon. Discretionary employer contributions are based on years of service as defined. A participant is 100% vested after five years of credited service as follows:

Forfeitures – Forfeited, nonvested accounts which have not been used to pay plan expenses or offset future contributions are added to the Plan's discretionary contributions and divided in the same manner as discretionary contributions. At December 31, 2021 and 2020, forfeited account balances totaled \$1,230 and \$0, respectively.

Notes Receivable from Participants – Participants may borrow from their account balance a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest rate equal to the Prime Rate plus 2 percent, as defined in the Plan. Loan repayments of principal and interest are made through payroll deductions, and interest rates remain fixed for the duration of the loan. Loans that become uncollectible are treated as deemed distributions in accordance with Internal Revenue Service regulations; therefore, no allowance for uncollectible loans is recorded.

Payment of Benefits – Upon termination of employment due to death, disability, or retirement, a participant may elect to receive a lump sum amount equal to the value of the Participant's vested interest in their account or annual installments. For termination of services due to other reasons, a participant may receive the value of the vested interest in their account as a lump sum distribution. Additionally, the Plan provides for in-service distributions at age 59 ½ and hardship withdrawals, as defined, if certain criteria are met.

Terminated participants with balances greater than \$5,000, may choose to keep their funds in the Plan. Participant consent for distribution is not required for terminated participants with vested account balances under \$5,000.

Retirement Age – The Plan's normal retirement age is 62.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting – The financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investments are held in pooled separate accounts offered through John Hancock Life Insurance Company (U.S.A.). The fair value of these pooled separate accounts is based on the net asset value (NAV) per unit as determined by the issuer, which is derived from the fair value of the underlying investments held within each account. The Plan's management determines the valuation policies using information provided by the investment custodian. See Note 4 for additional information on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefits – Benefits are recorded when paid.

Administrative Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) of fair value investments.

Note 3. Certified Investment Information

The following information disclosed in the accompanying financial statements and ERISA-required supplemental schedules was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (U.S.A), the custodian of the Plan:

- Investments, as shown in the Statements of Net Assets Available for Benefits as of December 31, 2021;
- Investment amounts and activity, as shown in Note 4;
- Interest income on notes receivable from participants;
- Investment income (loss), as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2021; and
- The investment information in the Schedule of Assets (Held at End of Year) as of December 31, 2021, as shown as a supplemental schedule.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2021 and 2020.

Pooled Separate Accounts: Valued daily using either the quoted market price of underlying mutual funds or using the pricing data provided by outside valuation service providers for underlying fixed maturity securities. The underlying assets are then unitized using the determined market value. The accounting unit value is determined in a manner similar to a mutual fund net asset value (NAV calculation). Since the pooled separate accounts have a readily determinable fair value the investment is valued at fair value rather than using the net asset value as the practical expedient.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Risks and Uncertainties

The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 6. Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the applicable provisions of ERISA. In the event of Plan termination, participants' accounts will become fully vested and non-forfeitable.

Note 7. Tax Status

The Company has adopted a pre-approved plan document subject to a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020. The plan administrator believes the Plan has been operated in accordance with the applicable provisions of the Internal Revenue Code (IRC). The Company routinely self-reviews the administration of the Plan and self-corrects any compliance issues in accordance with the Employee Plan Compliance Resolution System. Accordingly, the plan administrator believes that the Plan is designed in accordance with applicable sections of the IRC and, accordingly, is exempt from income taxes.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or other applicable taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2021 and 2020, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Party-in-Interest Transactions

Certain parties are considered parties-in-interest to the Plan, as defined by ERISA. John Hancock Life Insurance Company (U.S.A.), the Plan's recordkeeper and custodian, and the Company, as the Plan sponsor, are considered parties-in-interest. Transactions with these entities qualify as party-in-interest transactions.

The Plan's investments are held in pooled separate accounts offered through John Hancock. John Hancock provides recordkeeping, custodial, and administrative services to the Plan, for which certain fees are paid by the Plan or by participants, as allowed under the terms of the Plan. Such transactions are permitted under ERISA and are not considered prohibited transactions.

Note 9. Subsequent Events

In preparing these financial statements, management evaluated events and transactions occurring after December 31, 2021, for potential recognition or disclosure. Subsequent to year-end, the Company approved the termination of the Plan. On April 24, 2024, the Plan Administrator submitted a formal Request for Contract Termination to John Hancock Life Insurance Company (U.S.A.), and a trustee authorized the termination on May 16, 2024. John Hancock established a discontinuance date of July 29, 2024, and subsequently began processing the liquidation and distribution of participant accounts as part of the Plan's wind-down. Because the termination occurred after the 2021 plan year-end, no adjustments related to this event have been made to the accompanying financial statements.

These events and transactions were evaluated through December 30, 2025, the date that the financial statements were available to be issued.
