Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the financial statements of Georgia Eye Institute of the SE, LLC Employee Savings Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution.)

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the 2024 Financial Statements

In our opinion, based on our audit and the procedures performed as described in the Auditors' Responsibilities for the Audit of the 2024 Financial Statements section:

- the amounts and disclosures in the accompanying 2024 financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the information in the accompanying 2024 financial statements related to assets held by and certified by a qualified institution agrees to, or is derived from, in all material respects, the information prepared by and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the 2024 Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion on the 2024 financial statements.

Emphasis of Matter – Plan Merger

As disclosed in Note 1 to the financial statements, the Plan merged into Choice Pooled Employer Plan III, effective December 31, 2024, and all assets were transferred as of December 31, 2024. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the 2024 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the 2024 Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the 2024 financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the 2024 financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. Notes to Financial Statements

1. Description of the Plan

The following brief description of the Georgia Eye Institute of the SE, LLC Employee Savings Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution, safe harbor 401(k) plan, covering employees of the Georgia Eye Institute of the SE, LLC and its participating employers (the Company), originally effective January 1, 2009, and restated January 1, 2023. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan merged into the Choice Pooled Employer Plan III sponsored by Administrative Group, LLC dba Transamerica Fiduciary Services, effective December 31, 2024, and all assets were transferred out of the Plan.

Eligibility

All employees that had completed three consecutive months of service were eligible to participate in the Plan. The effective date of participation in the Plan was the first day of the month coincident with or immediately subsequent to the above condition being met.

Participant Contributions

Participants may have elected to make contributions through payroll deductions on a pre-tax basis, an after-tax basis (Roth deferral contributions), or a combination of the two, up to 100% of their eligible compensation and not to exceed the limit under the Internal Revenue Code (IRC). In addition, eligible participants who had attained age 50, before the close of the Plan year, were permitted to make catch-up contributions up to the maximum allowed by the IRC.

Participants may have also contributed amounts representing distributions from other qualified defined contribution plans (rollovers). Participants directed the investment of their contributions into various investment options offered by the Plan. A current description of the investment funds may have been obtained from the Plan administrator.

Company Contributions

The Company contributed each pay period, as a safe harbor match (safe harbor contribution), 100% of the first 3% of eligible earnings that a participant contributed to the Plan and an additional 50% of the next 2% that a participant contributed to the Plan.

The Company may have also made a discretionary additional contribution (nonelective profit-sharing contribution) on behalf of all eligible participants. Any discretionary additional contribution would have been allocated among the participants' accounts based on the individual participant's eligible earnings within the computation period. No discretionary additional contribution were made to the Plan for the Plan year ended December 31, 2024.

Notes to Financial Statements

1. Description of the Plan (cont.)

Participant Accounts

Each participant's account was credited with the participant's salary deferral contributions, allocations of any Company contributions, and his or her share of the Plan's earnings (losses). The Plan's earnings (losses), with respect to each investment fund, was allocated daily based on the proportion that each participant's account balance invested in such fund had to the total of all participants' account balances invested in such fund. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account balance. All contributions made to these accounts were directed by the participants into a particular investment offered by the Plan and the allocations between investments could have been changed.

Notes Receivable from Participants

A participant may have borrowed from their account a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of his or her vested account balance. Participants may have had only one loan outstanding at any given time. Loans must have been repaid from payroll deductions within 5 years, except for loans for the purchase of a primary residence which must have been repaid within 30 years. The loans were secured by the balance in the participant's account, and the interest rate was based on prevailing market conditions and was fixed over the life of the note (4.25% to 9.50% as of December 31, 2024). Principal and interest were paid ratably based on an amortization schedule.

Vesting

Participants were immediately vested in all employee deferrals and safe harbor contribution plus actual earnings thereon.

After the first year of qualifying service, for each subsequent year of qualifying service, a participant was 20% vested in the nonelective profit-sharing contributions to his or her account, plus the earnings (losses) thereon, resulting in each participant becoming fully vested after six years of qualifying service. In addition, a participant became fully vested in these funds in the event that the participant died or became disabled while employed by the Company or attained the Plan's normal retirement age of 65.

Benefit Payments

The distribution to which a participant was entitled was the total that could have been provided from the vested portion of the participant's account. Upon termination, if the participant's vested account balance was \$5,000 or less, the Company may have cashed out the entire balance if not otherwise directed by the participant.

Upon termination, if the participant's vested account balance was greater than \$5,000, the participant may have elected to receive payment in the form of a lump-sum distribution paid either directly to the participant or rolled over to another qualified retirement plan. Upon death of a participant before termination of employment and before other distribution of his or her benefits, the participant's account became 100% vested and the participant's beneficiary may have elected to receive a lump-sum payment or rollover the account to another qualified plan or an IRA. Certain hardship distributions were also allowed of employee deferral contributions and non-elective contributions in accordance with Internal Revenue Service (IRS) rules.

1. Description of the Plan (cont.)

Forfeitures

Forfeited non-vested accounts at December 31, 2024 and 2023 totaled \$0. Forfeited balances of terminated participants' non-vested accounts could have been used to reduce future Company contributions or to offset Plan expenses. During the year ended December 31, 2024, no forfeited funds were used to reduce Plan expenses.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting. The Plan followed accounting standards set by the Financial Accounting Standards Board (FASB). The FASB sets accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

The investments of the Plan were reported at fair value, except for the fully benefit-responsive investment contract, which was reported at contract value. Contract value was the relevant measurement for that portion of the net assets available for benefits because contract value was the amount participants normally would receive if they initiated permitted transactions under the terms of the Plan.

The fair value of a financial instrument was the amount that would have been received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). The Plan's investment committee determined the Plan's valuation policies utilizing information provided by the investment advisor, custodian, and insurance company.

Purchases and sales of securities were recorded on a trade-date basis. Dividends were recorded on the ex-dividend date. Interest income was recorded on the accrual basis. Net appreciation (depreciation) in fair value of investments included the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the Company contributions were recorded in the year in which the employee contributions were withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. No allowance for credit losses had been recorded as of December 31, 2024 and 2023. If a participant ceased making loan repayments and the Plan administrator deemed the participant loan to have been in default, the participant loan balance was reduced, and a benefit payment was recorded.

2. Summary of Significant Accounting Policies (cont.)

Payment of Benefits

Benefit payments to participants were recorded upon distribution.

Plan Administrative Expenses

Certain administrative expenses of the Plan were paid by the Company and are excluded from these financial statements. Certain administrative expenses of the Plan may have been paid by the Plan as provided in the Plan agreement. Investment fees were paid by the Plan in the form of reductions of net investment income earned by Plan participants.

3. Certified Information

The Plan administrator had elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Nationwide Trust Company, FSB (Nationwide), the Custodian of the Plan, had certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

4. Guaranteed Investment Contract

The Plan held a fully benefit-responsive traditional investment contract (FBRIC) that was reported at contract value, which was generally the amount a participant would have received if he or she initiated a withdrawal or transfer from the contract under the provisions of the Plan. As of December 31, 2024, the Plan did not have assets invested in the FBRIC.

The Plan's FBRIC was a group annuity contract with Nationwide Life Insurance Company (Nationwide Life) and contributions were maintained in a general account. The account was credited with earnings (losses) on the underlying investments and charged for participant withdrawals and administrative expenses. The contract was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan.

The guaranteed investment contract was fully benefit-responsive, and contract value was the relevant measurement attributable for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Nationwide Life, represented contributions made under the contract, plus earnings (losses), less participant withdrawals and administrative expenses. Participants may have ordinarily directed the withdrawal or transfer of all, or a portion of, their investment at contract value.

There were no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest was based on a formula agreed upon with the issuer but may have not been less than 0%. Such interest rates were reviewed on a quarterly basis for resetting.

Certain events would have allowed the issuer to have terminated the contract with the Plan and settle at an amount different from contract value. Examples of such events included (1) amendments or modification to the Plan, (2) changes in the administrative practices adhered to by the Plan, (3) change in the investment options offered by the Plan, (4) reduction in number of Plan participants, (5) full or partial Plan termination, or (6) merger of the Plan with another plan for all or a class of participants. The Plan administrator did not believe that any events that would have limited the Plan's ability to transact at contract value with participants was probable of occurring.

5. Fair Value Measurement

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs in which little or no market data exists (Level 3 measurements). The three levels of the fair value hierarchy under GAAP are described below:

Basis of Fair Value Measurement

Level 1 - Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

Level 2 - Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;

Level 3 - Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered Investment Companies - Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-Directed Brokerage Accounts - Investments included in the self-directed brokerage accounts include common stocks and insured deposit accounts (IDA). Common stocks are valued at the closing price reported on the active market on which the individual securities are traded. IDA's are valued using the amortized cost or penny rounding method as permitted by Rule 2a-7, which approximates its fair value.

The following table set forth by level, within the fair value hierarchy, the Plan's investment assets at fair value as of December 31, 2023. As of December 31, 2024, the Plan did not have assets held for investments.

6. Tax Status

The Plan had adopted a Non-Standardized Pre-Approved Profit Sharing Plan with CODA (pre-approved plan) sponsored by NWRPC LLC (Northwest Retirement Plan Consultants). The Internal Revenue Service (IRS) has opined and informed Northwest Retirement Plan Consultants by a letter dated September 23, 2022, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the Plan had been amended since adopting the pre-approved plan document, the Plan administrator believed the Plan was designed, and was being operated, in compliance with the applicable requirements of the IRC and, therefore, believed the Plan was qualified, and the related trust was tax-exempt.

GAAP requires Plan management to evaluate uncertain tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Party-In-Interest Transactions

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Company, and certain others. Certain administrative functions were performed by officers or employees of the Company. No such officer or employee received compensation from the Plan. Some administrative expenses were paid directly by the Company. Notes receivable from participants are defined by ERISA as party-in-interest transactions. Such transactions were exempt from the prohibited transaction rules.

8. Risks and Uncertainties

The Plan's investments were exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and amounts reported in the statements of net assets available for benefits.

At December 31, 2023, approximately 22% of the Plan investments were invested in the Vanguard 500 Index Admiral Fund.

9. Delinquent Participant Contributions

During 2024, employee withholdings of \$274 were not remitted within the appropriate time period by the Company. The Company remitted all delinquent contributions to the Plan in 2024 and 2025 and plans to remit lost earnings in 2026. These transactions constituted prohibited transactions as defined by ERISA.

10. SECURE 2.0 Act of 2022

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the period ended December 31, 2024. The application of SECURE 2.0 Act of 2022 did not have a material effect on the Plan's financial statements.

11. Subsequent Events

The Plan has evaluated, for consideration of recognition or disclosure, subsequent events that have occurred through the date of issuance, January 21, 2026, and has determined that no significant events occurred after December 31, 2024, but prior to the issuance of these financial statements, that would have a material impact on these financial statements.
