## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of the  
403(b) Thrift Plan for Employees of The Springfield Urban League, Inc.

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed an audit of the financial statements of the 403(b) Thrift Plan for Employees of the Springfield Urban League, Inc. (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of June 30, 2025 and 2024, the related statement of changes in net assets available for benefits for the year ended June 30, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended June 30, 2025, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### *Opinion on the Financial Statements*

In our opinion, based on our audit and the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion on the Financial Statements***

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Note 1. Description of the Plan**

*General*

The following brief description of the 403(b) Thrift Plan for Employees of the Springfield Urban League, Inc. (the Plan) is provided for general information purposes only. Participants should refer to the plan document for more complete information.

The Springfield Urban League, Inc. (SUL or Organization) established the Plan effective January 1, 2005. The Plan is underwritten by Mutual of America Life Insurance Company (Custodian). The Plan is to enable employees to accumulate long term savings for retirement while benefiting from favorable tax treatment. Incorporated under this 403(b) Thrift Plan is the Tax-Deferred Annuity (TDA) contract. The 403(b) Thrift Plan is intended to comply with Sections 401(a) and 403(b) of the Internal Revenue Code of 1986, as amended (the Code) and Treasury Regulations promulgated thereunder, and all other applicable statutory and regulatory requirements.

This voluntary retirement savings program offers employees the advantage of making contributions from a pre-tax or after-tax salary. Employees defer payment of federal income taxes on amounts contributed until they are withdrawn or paid as benefits. Moreover, any interest and investment earnings accumulate on a tax-deferred basis until withdrawn or paid as benefits.

Every employee who satisfies the requirements in the Eligibility section of the plan document has an opportunity to enroll in and contribute to the plan. The Plan is administered in accordance with the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA), and the Code.

*Contributions*

SUL will make an employer base contribution equal to 5%, 8%, or 10% of an employee's compensation for the year based on number of years served. Employees must be at least 21 years old and one year of service. Employee contributions are made each payroll period by salary reduction. The employer base contribution will be made whether or not an employee makes an employee contribution.

*Participant Accounts*

An account is maintained for each participant for the participant's share of contributions plus income and gains or losses from investment of such contributions. Participants allocating contributions to fixed annuity contracts are guaranteed a specified rate of interest. Participants allocating contributions to other accounts are not guaranteed either the principal or earnings on their accumulations. The value of a participant's accumulation in an account varies proportionately with the returns on the investments in the account's portfolio.

***Investment Options***

Employer contributions can be invested in various funds sponsored by Mutual of America at the option of the individual participant in any proportion resulting in a whole percentage.

***Administrative Expenses***

The Plan pays administrative expenses to the extent that SUL does not pay them.

***Vesting***

Vesting is determined by each participant's years of service from the date of hire to termination. The value of each participant's account attributable to employer contributions is fully vested when the participant has completed three (3) years of vesting service. The account value of contributions is fully and automatically vested when a participant reaches age fifty-five (55) or if they are totally and permanently disabled or die.

***Benefit Payments***

Distributions are payable upon retirement, death, disability, or termination of employment in the form of a lump-sum amount equal to the vested balance of the participant's account.

***Forfeitures***

Individual participants that are terminated and the entire account is forfeited because the individual was not vested at the time of termination, the forfeited account will be restored upon reemployment if the break-in-services does not exceed five (5) years. For individual participants that are terminated and have received a distribution of their vested account but had a portion of the account forfeited because it was not vested, the forfeited portion will be restored, if the participant is reemployed before incurring the five-year-break-in-service and the individual repays to the plan the total amount of the distribution within five years (5) of the date of reemployment.

Forfeited nonvested accounts will first be used to pay certain Plan administrative expenses with any remaining forfeitures used to reduce employer contributions. Forfeited nonvested accounts that were used to reduce employer contributions during the year ended June 30, 2025 was \$21,870. As of June 30, 2025, the forfeited balance was \$1.

***Plan Termination***

Although it has not expressed any intent to do so, SUL has the right to amend, modify, or terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants are entitled to their entire account balance.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

***Investment Valuation and Income Recognition***

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Plan Loans***

Participants may borrow from Mutual of America using their Mutual of America Interest Accumulation account balances as collateral for the loan. Collateral is required in an amount equal to 120 percent of the outstanding loan balance. Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance, subject to annuity contract and plan provisions. Loan terms range from one (1) to five (5) years or up to 10 years for the purchase of the participant's primary residence. Loans bear interest at market rates. Principal and interest are paid ratably by the participant to the insurance company and each payment will reduce amounts collateralized by the participant's Mutual of America Interest Accumulation account balance. The amount of these outstanding loans was \$201,813 and \$121,387 as of June 30, 2025, and 2024, respectively. These loans are not included as assets in the accompanying financial statements. As of June 30, 2025 and June 30, 2024, there were \$0 and \$0 defaulted loans, respectively.

***Benefit Payments***

Benefits are recorded when paid.

***Administrative Expenses***

Various administrative costs are recorded when paid.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**Note 3. Fair Value of Financial Instruments**

In determining fair value, the Plan uses various valuation approaches within the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820-10 “Fair Value Measurements and Disclosures” fair value measurement network. Fair value measurements are determined based on the assumptions that market participants would use in pricing an asset or liability.

FASB ASC 820-10 establishes a hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizing the use of unobservable inputs by requiring that the most observable inputs be used when available. FASB ASC 820-10 defines the levels within hierarchy based on the reliability of inputs as follows:

- Level 1 - Valuations based on adjusted quoted prices for identical assets or liabilities in active markets.
- Level 2 - Valuations based on quoted prices for similar assets or liabilities or identical assets or liabilities in less active markets, such as dealer or broker markets.
- Level 3 - Valuations derived from the valuation techniques in which one or more of significant inputs of significant value drivers are unobservable, such as pricing models, discounted cash flow models and similar techniques not based on market, exchange, dealer or broker-traded transactions.

**Note 3. Fair Value of Financial Instruments (continued)**

The guaranteed interest account is a fully benefit-responsive group annuity contract with Mutual of America that invests in the general assets of Mutual of America. The guaranteed interest account is valued at contract value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

The pooled separate accounts are valued at net asset value per share (NAV) of the funds, which is based on the fair value of the funds' underlying assets. There are no redemption restrictions or unfunded commitments on these investments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 4. Guaranteed Interest Account**

The Plan has a benefit-responsive investment contract with Mutual of America Life Insurance Company. Mutual of America maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest is credited on contract balances using a single "portfolio rate" approach. Under this methodology, a single interest rate is applied to all contributions made to the product, regardless of the timing of those contributions. Interest crediting rates are reviewed on a semiannual basis

for resetting, but may not be less than 3 percent. When establishing interest crediting rates for this product, Mutual of America considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account.

Generally, there are no events that could limit the ability of the Plan to transact at contract value paid within 90 days or, in rare circumstances, contract value paid over time. There are no events that allow the issuer to terminate the contract and that require the plan sponsor to settle an amount different than contract value paid either within ninety (90) days or over time.

**Note 5. Information Certified by Custodian**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at June 30, 2025 and 2024, and net appreciation in fair value of investments, and interest for the year ended June 30, 2025, was obtained by management and agreed to or derived from information certified as complete and accurate by Mutual of America Life Insurance Company (the custodian of the Plan).

**Note 6. Party-in-Interest Transactions**

Certain plan assets are invested in investment funds managed by Mutual of America. Mutual of America is a custodian and recordkeeper of the Plan, therefore, transactions related to these investments qualify as party-in-interest transactions.

**Note 7. Income Tax Status**

The Plan adopted a prototype non-standardized 403(b) plan and has been designed to qualify under Section 403(b) of the Internal Revenue Code (Code). The prototype received an opinion letter on March 31, 2017. The plan administrator believes that terms of the Plan have been prepared to conform with the written plan requirements of Regulation 1.403(b)-3 of the Code. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Section 403(b).

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8. Risks and Uncertainties**

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

**Note 9. Delinquent Participant Contributions**

During the year 2022, the Plan remitted certain participant contributions in the amount of \$32,713, in an untimely manner. Late remittances of participant contributions constitute a prohibited transaction under ERISA Section 406, regardless of materiality. The Organization had remitted the lost earnings on March 12, 2024.

**Note 10. Subsequent Events**

For the fiscal year ending June 30, 2025, the Plan's management has evaluated subsequent events through January 21, 2026, which is the date the financial statements were available to be issued.
