To Whom It May Concern,

We sincerely apologize for the late filing of Form 5500-SF for the 2023 plan year and appreciate the opportunity to explain the circumstances.

We genuinely believed that our payroll provider, Paychex, was responsible for preparing and filing Form 5500-SF on our behalf, as they manage many of our payroll and retirement-related obligations. Unfortunately, we later learned that this filing had not been completed and that the responsibility remained with us. This misunderstanding was unintentional, and we regret the oversight.

During this same period, together with the pandemic, our family was dealing with unexpected personal matters that caused significant stress and distraction. My mom was in and out of the hospital getting treated for cancer, my daughter was autistic, my husband was struggling looking for a job and I had to call 911 a few times for some panic attacks. While this is not an excuse, it did contribute to the delay and made it difficult for us to recognize the issue sooner.

As soon as we became aware that the form had not been filed, we took immediate action to complete and submit it as quickly as possible. We have always made a good-faith effort to comply with all filing requirements and remain committed to meeting our obligations going forward.

We respectfully request that any penalties associated with this late filing be waived, as the delay was unintentional and occurred due to a misunderstanding and difficult personal circumstances.
