Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Reserve Management Group 401(k) Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audits.

NOTE 1 - SUMMARY OF THE PLAN

Formation of Plan

Effective January 1, 2013, RMG Investment Group LLC formed the Reserve Management Group 401(k) Plan (the "Plan"). The Plan was formed by merging several defined contribution plans which had previously been separately maintained by RMG Investment Group LLC and its affiliated entities. Participating employers (herein collectively referred to as the "Company") are as follows:

General

The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan covering all eligible employees of the Company who have 3 months of service, as defined, and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Contributions

Each year, participants may contribute a percentage of pretax annual compensation, as defined in the Plan, subject to limitations imposed by the Internal Revenue Code ("IRC"). Additionally, participants may make after-tax ("Roth") contributions, subject to the provisions of the Plan. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions, as defined.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company contributes as a safe harbor matching contribution an amount equal to 100 percent of the participants' contributions that are not in excess of 3 percent of the participants'

compensation, plus 50 percent of the participants' contributions that exceed 3 percent but do not exceed 5 percent of the participants' compensation. The matching Company contribution is invested in the same investment options elected by the participant.

Additional Company contributions may be paid at the discretion of the Company and are invested in the same portfolio of investments as directed by the participants. No such discretionary contributions were paid during the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's deferral contributions, the Company's matching contributions and any discretionary contributions, and Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and Company matching contributions, plus actual earnings thereon. Vesting in any discretionary Company contributions is based on years of continuous service, subject to Plan provisions. The Company uses a graded vesting schedule for discretionary Company contributions, as follows:

6	100%

The balance of unallocated forfeitures was \$283 and \$1 at December 31, 2024 and 2023, respectively. The Plan provides that any forfeited amounts are to be applied to safe harbor matching contributions and Plan expenses.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loans may have a repayment term of up to five years, or up to ten years if the loan is used to purchase a primary residence. The loans bear interest at rates ranging from 5.25% to 10.5% at December 31, 2024 and 2023. Principal and interest are paid ratably through regular payroll deductions. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Upon termination of service, a participant may elect to receive a lump-sum amount or installment payments from the participant's account. If the participant's vested balance is less than \$1,000, such balance will be automatically distributed in a lump-sum payment. If the participant's vested balance is greater than \$1,000 but less than \$5,000, the balance will be rolled over into an Individual Retirement Account ("IRA"). If the participant's vested balance exceeds \$5,000, the participant may elect to: receive a lump-sum or installment payments from the participant's account; roll the funds into an IRA or another employer's qualified plan; or leave the funds in the Plan until the participant's required beginning date, as defined. Additionally, participants may elect to receive in-service distributions upon attaining age 59-1/2 or in the event of financial hardship, as defined by the Plan.

The liability of the Plan for benefits to participants is limited to the value of the participants' vested interest in their accounts.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

The financial statements of the Plan have been prepared in conformity with accounting principles generally accepted in the United States of America as applied to defined contribution plans, and in accordance with the terms of the Plan agreement. A summary of the significant accounting policies applied in the preparation of the accompanying financial statements follows.

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes realized gains and losses and unrealized appreciation and depreciation on those investments.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative expenses are paid by the Plan directly and are reflected in the accompanying Statement of Changes in Net Assets Available for Benefits.

Parties-In-Interest

Associated Trust Company, National Association (“Associated”) and certain affiliated entities provide custodial, recordkeeping, and other administrative services to the Plan. Additionally, Associated maintains all of the Plan’s current investments, some of which are managed by Associated-affiliated entities, thereby creating a party-in-interest relationship. There were no prohibited transactions with a party-in-interest.

Subsequent Events

Management has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

NOTE 3 - INFORMATION CERTIFIED BY THE TRUSTEE

As permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA, and as instructed by the Plan administrator, no audit procedures have been performed on investment information certified by Associated, the trustee of the Plan, except to compare such information to the information included in the accompanying financial statements and schedule. Information certified by the trustee includes investments, notes receivable from participants, and cash included in the Statements of Net Assets Available for Benefits at December 31, 2024 and 2023, investment income and interest on notes receivable from participants included in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024 and investments included in the Schedule of Assets (Held at End of Year).

NOTE 4 - FAIR VALUE MEASUREMENTS

FASB ASC 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below.

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for the identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

The valuation of investments has been provided by Associated, the trustee, and represents fair value. Mutual funds are valued at published market prices of shares held by the Plan at year end. Investments in common trust funds are valued at the net asset value (NAV) of the underlying investments held by the funds, less their liabilities. Net asset value is used as a practical expedient to estimate fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's investments in common trust funds may be redeemed on a daily basis and have a daily redemption notice period. There are no unfunded commitments related to these common trust funds.

NOTE 5 - PLAN TERMINATION

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their account balances.

NOTE 6 - TAX STATUS

The Company has adopted a prototype non-standardized plan sponsored by Associated. Associated has received an opinion letter dated June 30, 2020 from the Internal Revenue Service on its prototype plan.

The Plan administrator believes that the Plan is currently being operated in compliance with the applicable provisions of the IRC and, therefore, no taxes have been provided on Plan earnings.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded

that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the Statements of Net Assets Available for Benefits.
