## INDEPENDENT AUDITORS' REPORT

To the Participants and Plan Administrator of

### ***Report on the Financial Statements***

We have performed audits of the accompanying financial statements of Community Solutions, Inc. Prototype 401(k) Profit-Sharing Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). In our opinion, based on our audits and on the procedures performed as described in the Auditors’ Responsibilities for the Audit of the Financial Statements section —

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

### ***Basis for Opinion***

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditors' Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

***Other Matter - Supplemental Schedule Required by ERISA***

The supplemental schedule of assets (held at year end) as of June 30, 2025 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 1 – DESCRIPTION OF THE PLAN**

The following description of Community Solutions, Inc. Prototype 401(k) Profit-Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document and any related amendments, for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution 401(k) and profit-sharing plan covering all eligible employees of Community Solutions, Inc. and its subsidiaries: CSI Connecticut, Inc., Collins Group, Inc. and Living in Safe Alternatives, Inc. Southington, CT (“LISA”) (collectively referred to as the “Organization” or “Employer”). Employees are immediately eligible to participate in the Plan on their date of hire. Union employees, leased employees and employees who are non-resident aliens are not eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Contributions

Each year, participants may contribute up to 90% of compensation on a pre-tax and Roth basis, subject to the limitations prescribed by the Internal Revenue Service (“IRS”), as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan has an automatic enrollment provision set at 1% with no escalation clause. The Plan currently offers a variety of mutual funds through registered investment companies and a fixed interest investment contract as investment options for participants. The Plan requires the Organization to match 100% of elective deferrals, up to a maximum contribution equal to 4% of eligible compensation, as defined by the Plan. Contributions are subject to certain IRS limitations.

Participant accounts

Each participant’s account is credited with the participant’s contributions and allocations of the Organization’s contributions and Plan earnings, and charged with an allocation of investment management expenses. Allocations are based on participant compensation, participant contributions or account balances, as defined. Administrative charges and recordkeeping fees related to participant loans and distributions are deducted directly from the respective participant’s account.

Payment of benefits

On termination of service for any reason, participants may receive a lump-sum payment, substantially equal payments or partial withdrawals. Participants with a vested account balance less than \$7,000 will receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account. Participants with a vested account balance greater than \$7,000 may defer payment of benefits until a later date.

Withdrawals from any portion of a participant’s vested account may also be made in the event of a financial hardship, with a minimum amount of \$500, or as an age 59 ½ in-service distribution, in accordance with the provisions specified in the Plan.

## NOTE 1 – DESCRIPTION OF THE PLAN (CONTINUED)

### Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. In the event of termination due to death, total and permanent disability or normal retirement, participants shall become 100% vested in the Organization contribution portion of their account. For all other participants, vesting in the Organization contribution portion of their account is based on credited years of service, as defined in the Plan, according to the following schedule:

### Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. Participants may only have two outstanding loans at any time. The loans are secured by the vested balance in the participant's account and bear interest at the prime rate plus 1%, which are commensurate with local prevailing rates as determined by the Plan administrator upon loan issuance. Principal and interest are paid ratably through payroll deductions. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan document.

### Forfeited accounts

At June 30, 2025 and 2024, forfeited nonvested Employer contribution accounts totaled \$34,604 and \$2,714, respectively. These amounts may be used to pay Plan expenses or to reduce future Employer matching contributions, at the discretion of the Organization. During the year ended June 30, 2025, \$24,599 of forfeitures were utilized to reduce expenses and \$113,331 of forfeitures were utilized to fund Employer matching contributions.

## NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### Basis of accounting

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

### Investment valuation and income recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisers, the trustee, and insurance company. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

## **NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

### Notes receivable from participants

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a deemed distribution benefit payment is recorded.

### Payment of benefits

Benefits are recorded when paid.

### Expenses

The Plan is sponsored by the Organization. Personnel within the Organization perform various administrative services for the Plan, including maintenance of participant records. The payroll and related overhead costs associated with these services are not included as Plan expenses, but are paid by the Organization. Expenses paid by the Plan consist of transaction-based fees, Plan administration fees, Plan investment fees, and investment advisory fees, which are charged to the participant's account. Investment related expenses are included in net appreciation in fair value in investments.

### Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Subsequent events

The Plan monitored and evaluated subsequent events for footnote disclosures or adjustments required in its financial statements for the year ended June 30, 2025 through December 4, 2025, the date on which the financial statements were available to be issued.

## **NOTE 3 – FAIR VALUE MEASUREMENTS**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the input to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented and there were no changes in the methods used to measure fair value at June 30, 2025 and 2024.

### Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value (NAV) and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

## Level 2 Fair Value Measurements

The fair value of the fixed interest fund (guaranteed interest account) is based on a six-month basis by a crediting rate that assumes market, credit and interest rate risks for the underlying assets of the fund. Any market value adjustment or contract surrender charge is based on set formulas in the contract. These values are observable through the contract and provided on statements.

## NOTE 4 – CERTIFIED INFORMATION

Information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including all investments and notes receivable from participants held at June 30, 2025 and 2024, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended June 30, 2025, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (“Reliance”), the trustee of the Plan.

## NOTE 5 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

## **NOTE 6 – TAX STATUS**

The prototype Plan document, which the Plan has adopted via a non-standardized adoption agreement, obtained its latest opinion letter dated October 6, 2020, in which the IRS stated that the form of the prototype Plan, as then designed, was acceptable under the applicable requirements of the Internal Revenue Code (“IRC”). The Plan has been amended since receiving the opinion letter. However, the Plan’s administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, the Plan qualifies under Section 401(a) and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **NOTE 7 – PARTY-IN-INTEREST TRANSACTIONS**

Plan investments include mutual funds and a fixed interest investment contract that are managed by Reliance. ADP Retirement Services (“ADP”), the recordkeeper is considered a party-in-interest for the Plan. Fees charged by the trustee and recordkeeper qualify as parties-in-interest. Amounts paid to ADP were \$105,361 for the year ended June 30, 2025, respectively.

Additionally, the Plan provides for participant loans. Transactions as such are considered exempt party-in-interest transactions.

## **NOTE 8 – RISKS AND UNCERTAINTIES**

The Plan invests in various mutual funds and other investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.
