INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Christian Retirement Services, Inc. Tax Deferred Savings and Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended June 30, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Christian Retirement Services, Inc. Tax Deferred Savings and Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2025 and 2024, and for the year ended June 30, 2025, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Christian Retirement Services, Inc. Tax Deferred Savings and Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Christian Retirement Services, Inc. Tax Deferred Savings and Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Christian Retirement Services, Inc. Tax Deferred Savings and Retirement Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a single-employer defined contribution plan covering substantially all employees of Christian Retirement Services, Inc. (Organization and Plan Sponsor). Employees of the Organization are eligible to make elective deferrals immediately upon employment commencement date under a salary reduction agreement. To qualify for employer contributions, employees must have completed one year, as defined in the Plan, with at least 1,000 hours worked, contribute at least 2% of their compensation to the Plan in the given year, and have attained the age 19. The Plan is subject to the Employment Retirement Income Security Act of 1974 (ERISA).

Contributions

Eligible employees may make elective deferral contributions from pretax compensation as defined by the Plan, subject to certain limitations under the Internal Revenue Code. Participants may change their contribution percentage periodically. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Eligible participants are automatically enrolled in the Plan at 2% of eligible compensation deferral rate, unless they have affirmatively elected otherwise.

The Organization may make a discretionary matching contribution equal to a uniform percentage or dollar amount of employee deferrals, determined annually by the Organization’s Board of Directors. Each year, the Organization will determine the formula for the discretionary matching contribution. In order to share in the matching contribution, the participant must be employed with the Organization on the last day of the Plan Year and complete at least 1,000 hours of service during the Plan Year. The Organization’s discretionary matching contribution was \$406,918 for the year ended June 30, 2025.

Participant Accounts

Individual accounts are maintained for each of the Plan’s participants to reflect the participant’s contributions and related employer contributions, as well as the participant’s share of the Plan’s income and any related administrative expenses. Allocations of income and expenses are based on the proportion that each participant’s account balance bears the total of all participant account balances.

Vesting

Participants are vested immediately in all contributions plus actual earnings thereon.

Participant Investment Options

Upon enrollment in the Plan, a participant may direct all contributions to selected investments as made available and determined by the Plan. Participants may change their investment options daily. If no investment election is made by the participant, their contributions will be deposited into the Plan’s default investment option.

Payment of Benefits

On retirement, death, disability or termination of service, a participant (or a participant’s beneficiary in the event of death) may elect to receive a lump sum payment equal to the value of the participant’s vested account balance, installment payments or an annuity contract over the life expectancy of the participant or beneficiary. Participant accounts less than or equal to \$1,000 prior to the commencement of benefits shall be distributed in a single lump sum.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting and Use of Estimates

The financial statements of the Plan are prepared using the accrual basis of accounting. The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on trade-date basis. Interest income is recorded on the accrual basis, and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Net Appreciation (Depreciation) in Fair Value of Investments

Net realized and unrealized appreciation (depreciation) is recorded in the accompanying statement of changes in net assets available for benefits as net appreciation (depreciation) in fair value of investments.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative functions are performed by officers or employees of the Organization. No such officer or employee receives compensation from the Plan. Fees and expenses for the management of funds by external service providers are paid from Plan assets.

NOTE 3 - FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 3 inputs for the periods presented and there were no changes in the methods used to measure fair value at June 30, 2025.

Level 1 Fair Value Measurements

Fair values of mutual funds are determined by reference to quoted market prices and other relevant information generated by market transactions.

Level 2 Fair Value Measurements

Fair values of fixed annuities are observable inputs based on the valuation method disclosed in the annuity contract, as calculated by the annuity provider.

NOTE 4 - RELATED PARTY TRANSACTIONS

Certain administrative functions are performed by officers or employees of the Organization. No such employees receive compensation from the Plan. Certain administrative expenses for the Plan are paid directly by the Organization.

The Plan pays fees to Empower Advisory Group, LLC for investment management services. For the year ended June 30, 2025, the Plan directly paid fees of \$9,084.

The Plan directly pays fees to Empower Annuity Insurance Company of America for recordkeeping services. For the year ended June 30, 2025, the Plan directly paid fees of \$30,616, of which \$2,652 is included in benefits paid to participants on the statement of changes in net assets available for benefits.

The Plan pays fees to LeafHouse Financial Advisors, LLC for services. For the year ended June 30, 2025, the Plan directly paid fees of \$2,225.

Certain Plan investments are mutual funds managed by Empower Annuity Insurance Company of America. Empower Annuity Insurance Company of America is the custodian, as defined by the Plan. Therefore, these transactions qualify as party in interest transactions.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 6 - TAX STATUS

The Plan has adopted a volume submitter plan sponsored by Newport Group, Inc. The volume submitter plan has received an advisory letter from the Internal Revenue Service as to the volume submitter plan's qualified status. The volume submitter plan advisory letter has been relied upon by the Plan. The Plan has been amended since the volume submitter plan received the advisory letter. The Plan management believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon an examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

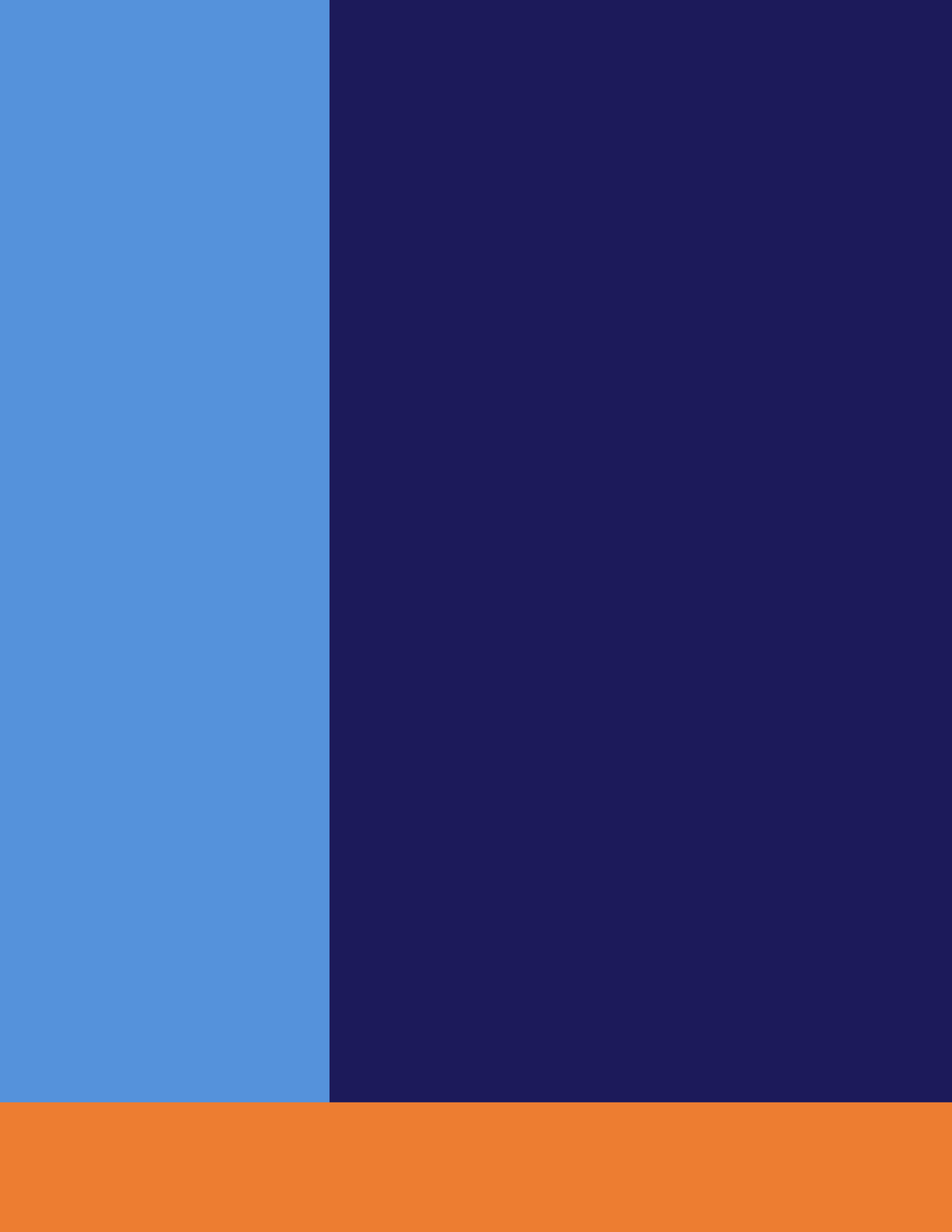
