Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audits of the accompanying financial statements of the Paul Miller Ford and Associates Retirement and Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of June 29, 2025 and 2024 and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Opinion

NOTES TO FINANCIAL STATEMENTS

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Paul Miller Ford and Associates Retirement and Savings Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions. The initial effective date of the Plan was June 30, 1984.

General - The Plan is a defined contribution plan and covers substantially all employees of Paul Miller Ford and Associates (the Plan Sponsor) and is designed to allow eligible employees to defer a portion of their compensation in order to save for retirement. Employees at least 20½ years of age become eligible for participation on the first plan anniversary date (June 30th or January 1st) coinciding with or following the completion of one year of service.

Automatic Deferrals - On June 30, 2011, employees meeting eligibility requirements automatically had 3% of compensation withheld and contributed into the Plan on their behalf. Participants can change this automatic withdrawal or elect not to contribute at any time.

Contributions - Subject to applicable limitations, participating employees may contribute up to 100% of their salaries or wages to the Plan. The Plan Sponsor may make matching contributions at its discretion determined annually. Participants may make contributions into a combination of several investment options. A participant may receive matching contributions if he/she completed 1,000 hours of service during the plan year and he/she is employed on the last day of the plan year. The Plan Sponsor did not make matching contributions during the fiscal years ended June 29, 2025 and 2024.

Participant Accounts - Each participant's account is credited with the participant's deferral contributions along with the corresponding matching contributions from the Plan Sponsor, if applicable, and is adjusted daily for any change in the fair values of the account's investments. The participants may transfer existing assets between investment options.

Vesting - Participants are immediately 100% vested in their qualifying deferral contributions plus applicable earnings. Vesting in the remainder of their accounts is based upon years of service in which the participant works more than 1,000 hours. The vesting schedule is graduated with 100% vesting occurring after six years of credited service as follows: Less than one year - 0%; One year - 10%, Two years - 20%, Three years - 40%; Four years - 60%; Five years - 80%; Six years - 100%.

Payment of Benefits - Upon normal retirement age of 65, death, or disability, the participants become fully vested in contributions made by the Plan Sponsor. Participants who terminate for any other reason are entitled to receive a lump-sum distribution, installment payments, or a combination of both equivalent to the vested portion of their account.

Forfeitures - Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures are used to reduce employer contributions, non-elective contributions, and administrative expenses. At June 29, 2025 and 2024, there was \$0 and \$7,484, respectively, available to reduce future employer contributions. During the year ended June 29, 2025 and 2024, \$6 and \$4 were used to pay plan expenses.

NOTE 1 - DESCRIPTION OF PLAN - continued

ERISA Account – The Company has entered into an agreement with Transamerica Retirement Solutions Corporation ("TRS"), an affiliate of Transamerica Financial Life Insurance Company Inc. ("TFLIC"), to create a Plan expense account ("ERISA Account") to hold revenue sharing funds the Plan receives from TRS pursuant to an agreement. These funds are available to pay qualified Plan administrative expenses or may be reallocated to Plan participants. The amount credited to the ERISA Account is determined on a monthly basis by TRS and is reported as an addition of net appreciation in fair value of investments on the statement of changes in net assets available for benefits. At June 29, 2025 and 2024, the ERISA Account balance was \$0 and \$0, respectively. The ERISA Account was used to pay Plan expenses totaling \$19,463 and \$17,739 during the years ended June 29, 2025 and 2024, respectively.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Basis of Accounting

The accounting records of the Plan are maintained on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America.

Investment Valuation and Income Recognition

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is reported on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Participants' contributions are recorded by the Plan as of the date such participants' elected contributions are withheld by the Plan Sponsor. Sponsor contributions are recorded by the Plan when committed by the Sponsor.

Payment of Benefits

Benefits are recorded when paid.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2025 contributions to the applicable participants prior to March 15th of the following year.

Operating Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to administration are charged directly to the participants' accounts and are included in administrative expenses.

Date of Management's Review

Subsequent events were evaluated through December 4, 2025, which is the date the financial statements were available to be issued.

NOTE 3 - UNAUDITED INFORMATION CERTIFIED BY TRUSTEE

Certain information related to investments from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at June 29, and , was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Transamerica Life Insurance Company, the trustee of the Plan. This information has not been audited by independent accountants.

NOTE 4 - FAIR VALUE MEASUREMENTS

FASB Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis. There have been no changes in the methodologies used at June 29, 2025 and 2024:

Pooled Separate Accounts ("PSAs") – Valued at the net asset value ("NAV") of units held by the Plan at year end provided by the issuer of the account. NAV is used as a practical expedient to estimate fair value and is based on the value of the underlying investment assets held through subaccounts of an insurance company. This practical expedient is not used when it is determined to be probable that the account will sell the investment for an amount different than the reported NAV. PSAs are comprised, primarily, of shares of mutual funds. The PSAs seek to mirror the investment objectives and strategies of the underlying mutual fund for which the PSA is named. Certain PSAs are target date funds which seek capital appreciation and current income consistent with asset allocation that become more conservative over time to the specified retirement date. The investments are redeemable at the adjusted NAV on a daily basis under agreements with the insurance company. There are currently no redemption restrictions or unfunded commitments on these investments.

Stable value option: Valued at NAV as it is a readily determinable fair value and the basis for current transactions.

NOTE 5 - INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has a benefit-responsive investment contract with Transamerica Life Insurance Company. Transamerica Life Insurance Company maintains the contributions in a general account. The account is credited with actual earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

Because the investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contract. The investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Transamerica, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the Plan's ability to transact at contract value with Transamerica. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include: (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with plan participants or the issuer are probable of occurring.

The average yield for the Plan as of June 29, 2025 and 2024 was 1.20% and 1.00%, respectively. Prior to January 1st and July 1st each year, the effective annual rate of interest is established for the corresponding six-month period. Interest is credited, based upon the daily balance, at a rate that is the daily equivalent of the effective annual rate of interest applicable for the six-month period. There is no stated minimum or maximum interest rate.

NOTE 6 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are managed by Transamerica Life Insurance Company and certain administrative expenses, indirect fees, and costs of the Plan are paid to Transamerica Life Insurance Company. Transamerica Life Insurance Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 7 - INCOME TAX STATUS OF THE PLAN

The Plan uses a prototype plan document sponsored by McGregor & Associates, Inc. McGregor & Associates, Inc. received an opinion letter from the Internal Revenue Service (IRS), dated March 31, 2014, which states that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service.

NOTE 7 - INCOME TAX STATUS OF THE PLAN - continued

The Plan has analyzed its tax positions taken and has concluded that as of June 29, 2025 and 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan is generally subject to income tax examinations for three years after filing.

NOTE 8 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan should be allocated to participant accounts and distributed in such a manner as the Plan Sponsor may determine.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan provides for various participant-directed investment options, which are exposed to various risks, such as interest rate, credit risks and market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the financial statements.
