### ***Opinion***

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**Note 1. Description of the Plan**

***General***

The following description of Majors Plastics, Inc. Employee Stock Ownership Plan (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

Majors Plastics, Inc. (Company) established the Plan effective as of May 1, 1992. The Plan operates, in relevant part, as a leveraged employee stock ownership plan (ESOP), and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986 as amended (Code) and is subject to the applicable provisions of the *Employee Retirement Income Security Act of 1974* as amended (ERISA). The Plan is administered by an ESOP Administrative Committee (Committee) comprised of no less than three persons, including the President of the Company, appointed by the Sponsor Company's Board of Directors. GreatBanc Trust Company, an independent third party, serves as the Plan's trustee.

On December 4, 2012, the Plan purchased 48,900 shares of the Company's common stock with a loan from Majors Plastics, Inc. totaling \$25,646,002 and holds the common stock in a trust established under the Plan. The stock was purchased at a price of \$524 per share. See Note 7 for additional information on the loan.

***Unallocated and Allocated Shares***

The borrowing is collateralized by the unallocated shares of common stock and is guaranteed by the Company. The lender has no rights against shares once they are allocated to participants in accordance with the terms of the ESOP. Accordingly, the financial statements of the Plan as of December 31, 2024 and 2023, and for the years then ended present separately the assets and liabilities and changes therein pertaining to:

- (A) The accounts of employees with vested rights in allocated common stock (Allocated), and
- (B) Common stock not yet allocated to employees (Unallocated)

***Eligibility***

Employees of the Company that are at least 21 years of age are generally eligible to participate in the Plan after one year of service providing they worked at least 1,000 hours during such plan year. Participants who do not have at least 1,000 hours of service during such plan year and are not employed on the last working day of a plan year unless their termination is due to normal retirement, death or disability are generally not eligible for an allocation of Company contributions for such year.

***Employer Contributions***

The Company is obligated to make contributions in cash to the Plan which, when aggregated with the Plan's dividends and interest earnings (if any), equal the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its term loan. The Company may also make discretionary supplemental contributions as determined by the Company's board of directors. Discretionary contributions totaled \$128,301 and \$3,629 in 2024 or 2023, respectively.

***Participant Accounts***

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of the plan year with an allocation of shares of the Company's common stock released by the Trustee from the unallocated account and forfeitures of terminated participants' nonvested accounts. Only those participants who are eligible employees of the Company as of the last day of the plan year will receive an allocation. Allocations and employer contributions are based on a

participant's eligible compensation, relative to total eligible compensation. Plan earnings are allocated to each participant's account based on the ratio of the Participant's beginning of year account balance to all participant's beginning of year account balances.

***Vesting***

Participants vest in the Company's contributions and earnings thereon based on years of service. Employees are 20% vested after two years of service and 20% for each year of service thereafter, becoming fully vested after six years of service. Participants terminating due to normal retirement, death, or disability will be 100% vested.

***Put Option***

Under federal income tax regulations, Sponsor Company stock that is held by the Plan and its participants and is not readily tradable on an established market or is subject to trading limitations includes a put option. The put option is a right to demand the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. For purchases in excess of \$12,000, the Company can pay for the purchase with interest over a period of five years. For purchases of \$12,000 or less, the Company will make payment in a single lump sum. The purpose of the put option is to ensure the participant has the ability to ultimately obtain cash.

***Payment of Benefits***

No distributions from the Plan will be made until a participant retires, dies (in which case, payment shall be made to the participant's beneficiary or, if none, his or her legal representatives), or otherwise terminates employment with the Company. Distributions are made in the form of Company common shares, cash, or both. Benefit obligations paid by the Company, subject to the put option exercised by participants, may be paid out in a lump sum or over a period of five years.

At December 31, 2024 and 2023, plan assets include \$307 allocated to accounts of terminated or retired participants who have elected to withdraw from the Plan but have not yet been paid.

Under the provisions of the Plan, the Company is obligated to repurchase participant shares, which have been distributed under the terms of the Plan if the shares are not publicly traded or if the shares are subject to trading limitations. During 2024 and 2023, the Plan distributed and the Company repurchased from participants 3,333 and 3,614 shares, respectively, at the current appraised value.

***Voting Rights***

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account for certain qualifying actions affecting the Company and Plan and is notified by the Trustee prior to the time that such rights are to be exercised. The trustee will vote the shares of Company stock held in the Plan on all other matters as directed by the ESOP Administrative Committee. If the Committee fails or refuses to give the trustee timely instructions, the trustee shall not exercise its power to vote such stock.

***Forfeitures***

Plan forfeitures are allocated to each participant's account based upon the relation of the participant's eligible compensation to total eligible compensation for the Plan year or reducing future plan administrative expenses. Forfeitures of terminated nonvested account balances allocated to remaining participants during the years ended December 31, 2024 and 2023, totaled \$260,982 and \$99,347, respectively.

***Plan Termination***

The Company reserves the right to terminate the Plan at any time, subject to plan provisions. Upon such termination of the Plan, participants will become 100% vested in their accounts and the interest of each participant in the trust fund will be distributed to such participant or the participant's beneficiary at the time prescribed by the Plan terms and the Code. Upon termination of the Plan, the Employee Benefits Administration Committee shall direct the Trustee to pay all liabilities and expenses of the trust fund and to sell shares of financed stock held as collateral to the extent it determines such sale to be necessary in order to repay the loan.

***Diversification***

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25 percent of the number of post-1986 shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify receive a distribution of shares that may be put to the Company for cash proceeds.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

A material estimate that is particularly susceptible to significant change relates to the estimated fair value of Company common stock.

***Investment Valuation and Income Recognition***

The common shares of the Company are valued at estimated fair value. Fair value is determined by an annual independent appraisal.

Dividend income is accrued on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Allocations***

The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to: (a) the accounts of employees with rights in allocated stock ("allocated") and (b) stock not yet allocated to employees ("unallocated"), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

**Administrative Expenses**

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion. The Company has historically paid the operating expenses of the Plan.

**Note 3. Administration of Plan Assets**

The Trustee of the Plan holds the Plan's assets, which consist principally of Company common shares.

Company contributions are held and managed by the Trustee, which invests cash received, interest and dividend income and makes distributions to participants. The Trustee also administers the payment of interest and principal on the loan, which is reimbursed to the Trustee through contributions as determined by the Company.

**Note 4. Investments**

The Plan's investments, at December 31, 2024 and 2023, are presented in the following table:

The only investment of the Plan that represented 5% or more of the Plan's net assets at December 31, 2024 and 2023, was Company common stock. The Company common stock is nonparticipant directed. All appreciation or depreciation in the fair value of the Plan's investments was attributable to this common stock.

**Note 5. Dividends**

During the Plan years ended December 31, 2024 and 2023, the Company issued a \$43 dividend. In the event dividends are issued by the Company, to the extent dividends are not used by the Plan for debt service, participants are given the right to take a distribution of such dividends in cash or leave the funds in the Plan to be invested in Company stock or applicable other investments, as provided by the Plan.

**Note 6. Disclosures About Fair Value of Plan Assets and Liabilities**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities

**Level 3** Unobservable inputs that are supported by little or no market activity and are significant to the fair value of the assets or liabilities

***Recurring Measurements***

The Plan’s only investment measured at fair value consists of Sponsor Company stock. Sponsor Company stock falls within Level 3 – significant unobservable inputs of the fair value hierarchy.

If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy using valuation techniques discussed below.

The valuation process involves Trustee's selection of an independent appraiser under contract for a term of one year with the right to cancel such contract at any time. Plan management accumulates the data for the appraiser from the audited financial statements of the Company. The appraiser prepares a preliminary report which plan management, along with the ESOP trustee, reviews in detail, discusses and approves.

The preceding methods described produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 7. Loan Payable**

In 2012, the Plan entered into a \$25,646,002 term loan agreement with the Company. The proceeds of the loan were used to purchase Company's common stock. Unallocated shares are collateral for the loan. Shares are released from collateral and allocated to participants as payments of principal and interest are made. As of December 31, 2024 and 2023, the outstanding principal balance totaled \$6,325,614 and \$7,607,914, respectively. The number of shares released in any year is the number of shares held as collateral times the ratio of the current year payments divided by the total of this year's payments, plus all future years' principal and interest payments. This resulted in 1,983 shares being released and allocated for the Plan year ended December 31, 2024 and 2,033 shares for the Plan year ended December 31, 2023.

The agreement provides for the loan to be repaid over 18 years and matures December 31, 2029. The loan bears interest at 3%.

### **Note 8. Related Party and Party-In-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan invests in Company common stock and has indebtedness guaranteed by the Company. The Company pays the administrative and auditing fees related to the Plan.

The Company provides certain administrative services at no cost to the Plan.

### **Note 9. Tax Status**

The Plan has received a determination letter from the Internal Revenue Service dated April 2, 2015, stating that the Plan and related trust is designed in accordance with applicable requirements of the Internal Revenue Code (IRC) and therefore is not subject to tax. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan and related trust is designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 10. Risks and Uncertainties**

The Plan primarily invests in Company common stock, which is exposed to various risks, such as market and credit risk as well as valuation assumptions based on earnings, cash flows, and/or other such techniques. Due to the level of risk associated with such investment securities and the level of uncertainty related to changes in the value of such investments, it is at least reasonably possible that changes in risk in the near term could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.
