NOTE A -- Description of plan and significant accounting policies

The following description of River Bend RV Resort 401(k) Plan (“the Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. Rubidell Condominium Association (“the employer”, also referred to as “the company”) has adopted the CCH Incorporated, DBA fwilliam.com Pre-Approved Profit Sharing Plan, effective January 1, 2024.

General

The Plan is a defined contribution plan that covers all full-time employees of Rubidell Condominium Association who are age fourteen or older, with immediate eligibility upon hire. Union employees, leased employees, non-resident aliens, and interns are excluded from participation. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors of the company oversees governance of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

The Plan's federal identification number is 39-1658824, and the Plan's number is 001.

Contributions

Each year, participants may contribute up to 90% of their annual compensation, including up to 50% as Roth elective deferrals, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 10% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

The Plan is a safe harbor plan and is intended to meet the 401(k) discrimination limits. The employer will make a safe harbor matching contribution equal to 100% of participant elective deferrals not exceeding 5% of compensation. The company also has the right to make discretionary non-elective contributions. To be eligible for discretionary non-elective contributions a participant must be employed on the last day of the Plan year. No non-elective contributions were made in 2024. Annual contributions from all sources are subject to certain limitations defined by the Internal Revenue Service (IRS).

Participant accounts and “rollovers”

Each participant's account is credited with the participant's contribution and allocations of (a) the employer's safe harbor contribution, (b) Plan earnings and (c) charged with an allocation of administrative expenses. Allocations of Plan earnings are based on participant account balances, as defined, and allocation of employer safe harbor contributions are based on participant compensation, as provided in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan permits the transfer of funds from other qualified plans to a separate participant's rollover account.

NOTE A -- Description of plan and significant accounting policies (Continued)

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the employer's safe harbor contribution portion of their accounts is based on years of continuous service. A participant is 100% vested ratably after two years of credited service. Vesting in the employer's non-elective contribution portion of their accounts is based on years of continuous service. A participant is 100% vested ratably over six years of credited service starting in year two of service. Participants who leave the Plan because of death or disability, as defined in the Plan, are considered 100% vested in all amounts.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at a fixed rate that is determined as 1% over the Prime Rate (7.50% at December 31, 2024) set by the Wall Street Journal on the first business day of the month the loan is originated. Principal and interest is paid ratably through payroll deductions every pay period.

Benefits

On termination of service due to disability, retirement (age 65), or termination of employment a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installment payments over a specified period of time. For termination of service due to death, the beneficiary is required to distribute the participant's account balance by December 31 of the calendar year containing the fifth anniversary of the participant's death, or installment payments over a specified period not to exceed the life or life expectancy of the beneficiary. The Plan permits hardship distributions if certain criteria are met. The Plan permits in-service distributions at normal retirement age. A participant with an account valued at less than \$5,000 shall receive a lump sum distribution or elect to rollover the distribution to another qualified plan. For accounts exceeding \$5,000, the participant may elect a lump sum distribution or may elect to defer such distribution to any valuation date subsequent to his/her termination but no later than the valuation date of his/her normal retirement date; or the participant may elect to roll over the distribution to another qualified plan.

Forfeited accounts

At December 31, 2024 forfeited nonvested accounts totaled \$641. These accounts will be used to restore forfeitures, reduce future employer contributions, or pay reasonable Plan expenses. For the year ended December 31, 2024, \$2,563 of forfeited nonvested accounts were used to reduce employer contributions.

A summary of significant accounting policies follows:

Basis of accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) under the accrual method of accounting.

NOTE A -- Description of plan and significant accounting policies (Continued)

Cash

The Plan maintains its cash in bank deposit accounts, which, at times, may exceed federally insured limits. The Plan has not experienced any losses in such accounts. Management believes it is not exposed to any significant credit risk on cash.

Use of estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

The Plan's investments are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Board of Directors of the company determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

The plan sponsor and employer, Rubidell Condominium Association, pays most of the administrative expenses of the Plan which are excluded from these financial statements. The major administrative expenses are recordkeeping fees.

Notes receivable from participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024, no allowance for credit losses has been recorded.

Subsequent events

These financial statements have not been updated for subsequent events occurring after January 9, 2026, which is the date these financial statements were available to be issued. The Plan has no responsibility to update these financial statements for events and circumstances.

NOTE B -- Information certified by the asset custodian

Certain information related to cash and investments disclosed in the accompanying financial statements and supplemental schedule, including cash and investments held at December 31, 2024, and dividends and net appreciation, for the year then ended, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Matrix Trust Company, the asset custodian of the Plan.

U.S. GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value.

- Registered investment companies. Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Gains and losses (realized and unrealized) included in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, are reported in net appreciation in fair value of investments.

NOTE D -- Party-in-interest transactions

Matrix Trust Company is the asset custodian of the Plan and Human Interest is the Plan recordkeeper as of and for the year ended December 31, 2024, and are therefore designated as parties-in-interest. The Plan regularly invests in mutual funds for which Matrix Trust Company is the issuing party. These party-in-interest transactions occur in the course of ordinary business and are exempt transactions.

NOTE E -- Plan termination

Although it has not expressed any intent to do so, the company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

NOTE F -- Tax status

The CCH Incorporated, DBA ftwilliam.com Pre-Approved Profit Sharing Plan that the Plan has adopted effective January 1, 2024, obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the prototype plan, as then designed, was acceptable under Section 401 of the Internal Revenue Code for use by employers for the benefit of their employees. The Plan was established since the date of the opinion letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

NOTE G -- Concentration of market risk

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.
