Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of the Heritage Community of Kalamazoo Savings Plan and the Heritage Community of Kalamazoo 403(b) Plan (collectively, the "Plans"), employee benefit plans subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about whether Heritage Community of Kalamazoo Savings Plan and the Heritage Community of Kalamazoo 403(b) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedules Required by ERISA

The supplemental schedules, Schedule H, Line 4i - Assets Held for Investment Purposes at End of Year, are presented for purposes of additional analysis and are not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedule, other than information agreed to or derived from the certified investment information, including its form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion –

- The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTE A – Plan Description

The following description of Heritage Community of Kalamazoo Savings Plan (the “Savings Plan”) and Heritage Community 403(b) Plan (the “403(b) Plan”) (collectively, the “Plans”) provides only general information. Participants should refer to the Plan agreements or Summary Plan Description for a more complete description of the Plans’ provisions.

General

The Plans are defined contribution plans covering all employees of the Heritage Community of Kalamazoo Obligated group and its consolidated affiliates (the “Company”). The Plans are subject to the provision of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The 403(b) Plan provides for employee deferral contributions and is subject to maximum tax-deferred limitations established by the Internal Revenue Code. The 403(b) Plan allows participants to contribute on a pre-tax basis. Participants may also make contributions to the 403(b) Plan in the form of a rollover of funds of another qualified plan. The Savings Plan does not allow for employee deferrals or rollover contributions.

The 403(b) Plan provides for employer matching contributions of 50 percent of the participant’s contribution, not to exceed 1.5 percent of the employee’s deferred compensation. The Savings Plan provides for employer discretionary contributions based on a percentage of each employee’s compensation. Employees must meet the following eligibility requirements to receive employer matching or discretionary contributions, including completing one year of service and being 18 years of age or older. One year of service consists of at least 1,000 hours of service during the prior 12 consecutive months of employment with the Company. Contributions are invested in funds directed by the employee. There were no discretionary contributions to the Savings Plan during 2025 or 2024.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of the Company’s contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants’ compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participants may direct the investments of their account balances into various investment options offered by the Plans.

Participant Notes Receivable

Loans are allowed by the Plans, and participants may borrow from their accounts up to a maximum of \$50,000 or 50 percent of their vested account balances. Notes receivable are collateralized by the participant’s account balance and bear interest at a market rate.

NOTE A – Plan Description (Continued)

Vesting

Participants are immediately vested in their elective deferral contributions, rollover contributions and any income or loss thereon for the 403(b) Plan. Vesting in the Company's contribution portion of participant amounts, plus the earnings thereon is based on the years of service for both of the Plans. Participants vest in contributions made by the Company at 20 percent after one year of service, with an additional 20 percent after each additional year of service thereafter, until they become fully vested after five years of service. In addition, a participant is also fully vested upon attaining the retirement age of 65, death, or permanent disability.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plans.

Payment of Benefits

Distributions from the Plans are payable to the participant upon retirement, death, disability, or termination of employment in the form of a lump-sum amount equal to the vested balance of a participant's account or in various installment annuities. Account balances less than \$1,000 are paid in a single lump sum upon termination.

NOTE B – Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

The fair value of the Plans' interests in the Heritage Community Kalamazoo Savings and 403(b) Master Trust (the "Master Trust") is based on the beginning of year value of the Plans' interest in the Master Trust plus actual contributions and allocated investment income less actual distributions and allocated administrative expenses. Mutual funds and money market funds are valued based on quoted market value. See Note D for additional information.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plans believe their valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Administrative Expenses

Certain administrative expenses of the Plan are paid directly by the Company or from Plan forfeitures.

NOTE B – Summary of Significant Accounting Policies (Continued)

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the use of management's estimates. These estimates affect the amounts reported in the financial statements and the disclosures provided. Actual results may differ from management's estimates.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed to be uncollectible.

Payment of Benefits

Benefits are recorded when paid.

Memorandum-Only Totals

The total columns on the financial statements are memorandum only and represent solely a total of the individual plans. They are provided for information only.

Subsequent Events

Management has evaluated subsequent events through January 23, 2026, the date on which the financial statements were available to be issued.

NOTE C – Information Certified by the Plan's Trustee

Greenleaf Trust (the "Trustee") holds the Plans' investments and participant notes receivable and executes all investment transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements, including master trust information included in Note D, are based solely on information certified by the Trustee. The Plan administrator has elected the method of annual reporting compliance permitted by Section 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the trustee has certified that the following data included in the accompanying financial statements and supplemental schedule of assets held at year-end are complete and accurate.

The Plans’ independent accountants did not perform auditing procedures with respect to this information except for comparing such information with the related information included in the financial statements and supplemental schedule.

NOTE D – Investments and Fair Value Measurements

The Plans’ investments are in the Master Trust, which was established for the investment of assets of the Plans. Each participating plan’s interest in the Master Trust is based on account balances of the participants and their elected investment options. The assets of the Master Trust are held by the Trustee. Investment income and administrative expenses relating to the Master Trust are allocated to the individual plans based upon average monthly balances invested by each plan.

FASB codified accounting standards for *Fair Value Measurements* and established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Master Trust has the ability to access.
- Level 2 Inputs to the valuation methodology include:
 - quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE D – Fair Value Measurements (Continued)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The Master Trust's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset. There have been no changes in the methodologies used at June 30, 2025 and 2024. There were no investment transfers between levels and no investments classified as Level 2 or Level 3 during the years ended June 30, 2025 and 2024.

NOTE E – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plans to discontinue its contributions at any time and to terminate the Plans, subject to the provision of ERISA. In the event of Plans termination, participants' accounts will become fully vested and non-forfeitable.

NOTE F – Income Tax Status

403(b) Plan

The Internal Revenue Service (IRS) is not currently accepting applications for individual 403(b) plan determination letters. The plan administrator believes that the 403(b) Plan is designed and is currently being operated in compliance with applicable requirements of Internal Code Section 403(b). Therefore, no provision for income taxes has been included in the 403(b) Plan's financial statements.

Savings Plan

The IRS has determined and informed the Company by letter that the Savings Plan is designed in accordance with applicable sections of the Internal Revenue Code. The Savings Plan has been amended since receiving the determination letter. The plan administrator believes the Savings Plan is designed and is currently being operated in compliance with applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Savings Plan's financial statements.

NOTE G – Party-in-Interest and Reportable Transactions

Certain plan investments are managed by Greenleaf Trust who is the Plan custodian and, therefore, a party in interest. The 403(b) Plan paid the custodian \$38,493 and \$39,752 in the years ended June 30, 2025 and 2024, respectively. The Savings Plan paid the custodian \$1,669 and \$1,964 for the years ended June 30, 2025 and 2024, respectively.

The United States Department of Labor requires all transactions in excess of 5% of the current value of the Plans' net assets for non-participant-directed investments to be disclosed separately in the financial statements as a reportable transaction. As the Plans' investments are participant-directed, there were no reportable transactions for the years ended June 30, 2025 and 2024.

NOTE H – Risks and Uncertainties

The Master Trust invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
