INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Trustee of
ARC Excess & Surplus, LLC 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of ARC Excess & Surplus, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of July 31, 2025 and December 31, 2024 and the related statement of changes in net assets available for benefits for the period January 1, 2025 through July 31, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of July 31, 2025 and December 31, 2024 and for the period January 1, 2025 through July 31, 2025, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section—

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audits of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audits.

NOTE 1 DESCRIPTION OF PLAN

General

ARC Excess & Surplus, LLC 401(k) Plan (the “Plan”) was established on January 1, 1996 and covers all entities disclosed in the Eligibility section below. The following description of the Plan provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan was amended and restated to comply with the new tax laws with an effective date of January 1, 2023.

Effective July 31, 2025, ARC Excess & Surplus, LLC (the “Company” or the “Plan Sponsor”) terminated the Plan. Upon termination, participants received either a lump-sum distribution, a rollover to another qualified plan, or for participants who did not respond, an individual IRA established on their behalf by Inspira Financial Trust in connection with the Plan’s termination. See Note 7 for further details.

Eligibility

The Plan covers all eligible employees of ARC Excess & Surplus, LLC, ARC Mid-Atlantic Excess & Surplus, Inc., Professional Risk Facilities, Inc., Professional Risk Intermediaries, Inc., ARC South, LLC, ARC Specialty Brokerage, LLC, ARC Excess & Surplus of Midsouth, LLC, ARC Excess & Surplus West Coast Brokerage, LLC, ARC Excess & Surplus of Massachusetts, LLC, ARC Personal Lines, LLC, ARC Excess & Surplus of New England, LLC, ARC Excess & Surplus of Texas, LLC and Construction Risk Facilities, Inc who are eligible to participate in the Plan. To be eligible, an employee must have attained the age of twenty-one and have completed three months of service. For discretionary safe harbor matching contributions, if any, an employee must have attained age 21 and have completed 250 hours of service within the first three months of employment.

Participant Contributions

Each year, eligible employees may contribute up to 100% of pre-tax annual compensation, as defined in the plan document and not to exceed the amount allowable by the Internal Revenue Code (“IRC”) of \$23,500 for 2025. Participants who have obtained age 50 before the end of the plan year are eligible to make catch-up contributions of up to \$7,500 for 2025. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (i.e. rollovers).

The Plan Sponsor has the option to make a safe harbor matching contribution on behalf of all participants that make an elective deferral contribution to the Plan. The Plan Sponsor’s safe harbor matching contribution, if any, will be equal to (i) 100% of employee contributions but not in excess of 3% of compensation, plus (ii) 50% of the amount of the employee contributions that exceed 3% of compensation but not in excess of 5% of compensation.

The Plan Sponsor may make a discretionary safe harbor enhanced matching contribution equal to 100% of the employee contributions but not in excess of 4% of compensation.

The Plan Sponsor may also make additional qualified non-elective contributions for the benefit of participants as determined at the discretion of the Plan Sponsor up to 3% of employee compensation.

During the period January 1, 2025 through July 31, 2025, there were no employer discretionary safe harbor matching contributions, safe harbor enhanced matching contributions and additional qualified non-elective contributions made to the Plan.

Participant Accounts

Each participant's account is credited with (i) participant's contributions, (ii) employer safe harbor matching contributions, if any, (iii) employer discretionary safe harbor enhanced matching contributions, if any, and (iv) employer qualified non-elective contributions, if any, as well as allocations of plan earnings. Participant accounts may be charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of one-half of the vested account balance or \$50,000 reduced by the highest outstanding loan balance in the account during the prior twelve-month period. Participants are only permitted to have one outstanding loan from the Plan at any time. Loan terms range from one to five years; however, terms may exceed five years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with prevailing market rates, as determined by the plan administrator. Principal and interest is paid ratably through payroll deductions.

Vesting

Participants are vested immediately in their salary deferrals, rollover contributions, safe harbor matching contributions (if any), safe harbor enhanced matching contributions (if any) and qualified non-elective contributions (if any) plus actual earnings thereon.

Investment Options

The Plan's investments are held by John Hancock Life Insurance Company of New York. Participants direct the investment of their contributions into various investment options approved by the Plan.

Forfeited Accounts

For the period January 1, 2025 through July 31, 2025, there were no balances of forfeited non-vested accounts. Such accounts, when available, are used to reduce future employer contributions, if any, or plan expenses.

Benefit Payments

On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump sum amount or in annual installments over a period not exceeding the life expectancy of participant's beneficiary. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. Participants may receive an in-service withdrawal of their vested account balance upon reaching 59½ years of age. Hardship withdrawals are permitted under the Plan. For a participant with an account balance of \$5,000 or less, the balance will be distributed in a lump sum even if the participant does not consent to a distribution.

Plan Expenses

Expenses of operating and maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Fees related to the administration of notes receivable from participants are charged directly to the participant's account.

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP") in compliance with the Accounting Standards Codification ("ASC") of the Financial Accounting Standards Board ("FASB")

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions in net assets available for benefits during the reporting period. Actual results may differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

Investment Valuation and Income Recognition

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrator determines the Plan's valuation policies utilizing information provided by the investment advisers, custodian and insurance company. See Note 3 for discussion of fair value measurements.

Investments in guaranteed interest accounts held by the Plan are not considered to be fully benefit-responsive, and accordingly, are reported at fair value.

Investments in pooled separate accounts are valued at the net asset value (NAV) per unit as determined by the custodian at year end. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investment held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reportable NAV.

Management fees and other expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected in the statement of changes in net assets available for benefits. Consequently, such expenses are reflected in net appreciation or depreciation in the fair value of such investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the participant's account when incurred. No allowance for credit losses has been recorded as of July 31, 2025 and December 31, 2024.

Notes Receivable from Participants (continued)

If a participant fails to make a loan payment when due under the terms of the loan, the participant will be in default. In the event of default, the loan shall become due and payable immediately and interest will continue to accrue until the entire loan balance is repaid. The Plan will take all reasonable actions to collect the balance owed on the loan. Under certain circumstances, the loan in default could be considered a distribution from the Plan and could be considered income to the participant. In any event, failure to repay a loan will reduce the benefit a participant would otherwise be entitled to from the Plan.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses related to the administration of the Plan such as recordkeeping and advisory services are paid by the Plan and charged to administrative expenses as incurred.

Subsequent Events

The Plan's management has evaluated subsequent events through January 16, 2026 the date the financial statements were available to be issued. The Plan's management concluded that no subsequent events have occurred that would require recognition or disclosure in the financial statements.

NOTE 3 FAIR VALUE MEASUREMENTS

ASC Topic 820, *Fair Value Measurement* ("ASC Topic 820"), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). Categorization within the valuation hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Under this standard, fair value is defined as the exit price, or the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date.

The three levels of the fair value hierarchy under ASC Topic 820 are described below:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Assets and liabilities measured at fair value are based on one or more of three valuation techniques identified in the table below. The valuation techniques are as follows:

- (a) *Market approach.* Prices and other relevant information generated by market transactions involving identical or comparable assets or liabilities;
- (b) *Cost approach.* Amount that would be required to replace the service capacity of an asset (replacement cost); and
- (c) *Income approach.* Techniques to convert future amounts to a single present amount based on market expectations (including present value techniques, option-pricing and excess earnings models).

The following describes the valuation methodologies used for assets measured at fair value as of December 31, 2024. As of July 31, 2025, all Plan assets had been distributed upon termination, and no assets remained measured at fair value.

Pooled Separate Accounts (PSAs) Pooled separate accounts are valued at the NAV. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. NAV is not a publicly quoted price in an active market and is computed in accordance with accounting and reporting for investment companies.

Guaranteed interest accounts (GIA) are not actively traded and significant other observable inputs are not available. Thus, the fair value of the guaranteed interest account is determined by discounting the related cash flows based on current yields of similar instruments with comparable durations.

NOTE 4 RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

Certain plan investments are investments managed by John Hancock Life Insurance Company of New York (John Hancock). John Hancock is the custodian as defined by the Plan, and therefore, these transactions qualify as exempt party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation or depreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Plan Sponsor pays certain other fees related to the Plan's operations.

NOTE 5 INFORMATION CERTIFIED BY THE PLAN

The July 31, 2025 and December 31, 2024 statements of net assets available for benefits, the investment activities included on the statement of changes in net assets available for benefits for the period January 1, 2025 through July 31, 2025 and for the year ended December 31, 2024, was prepared in part or entirely from information certified by John Hancock Life Insurance Company of New York, the custodian of the Plan, in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

NOTE 6 TAX STATUS

The Plan has adopted a prototype non-standardized plan sponsored by FIS Business Systems LLC. FIS Business Systems LLC received an opinion letter from the IRS dated June 30, 2020, which states that the prototype document satisfied the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. Although the Plan has been amended, the Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and therefore, believes that the Plan is qualified, and the related trust is tax-exempt as of July 31, 2025. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of July 31, 2025, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 PLAN TERMINATION AND ASSET DISTRIBUTION

The Plan was terminated effective July 31, 2025. During the period January 1, 2025 through July 31, 2025, the Plan distributed \$35,248,528 to participants in the form of lump-sum payments and rollovers to other qualified plans. For participants who did not respond as of July 31, 2025, \$337,248 was rolled over into individual IRAs established by Inspira Financial Trust in connection with the Plan's discontinuance. As of July 31, 2025, all Plan assets had been fully distributed, and the Plan held no assets. Accordingly, the accompanying financial statements reflect no balances for investments or net assets available for benefits.
