INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Participants of the
Thompson Chiropractic 401(K) PSP and Trust:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Thompson Chiropractic 401(K) PSP and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to financial statements.

1. DESCRIPTION OF THE PLAN

The following brief description of the Thompson Chiropractic 401(K) PSP and Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for complete description of the Plan’s provisions.

General – The Plan is a participant-directed defined contribution and profit-sharing plan covering all eligible employees of Thompson Chiropractic (the “Company”). The Plan was originally established effective January 1, 2010 and was subsequently restated effective March 10, 2023. Ascensus Trust Company (the “Trustee”) is the trustee of the Plan’s assets. Ascensus, LLC (“Ascensus”) is the recordkeeper of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Eligibility – The Plan covers eligible employees who have attained the age of 21 and are not covered by a collective bargaining agreement or otherwise considered an excluded employee of the Plan. An eligible employee becomes a participant effective the first day of the third month after satisfying the eligibility requirements.

Contributions – Each year, participants may contribute a minimum of 1% and maximum of 92% of their annual compensation as defined in the Plan, subject to annual limitations imposed by the Internal Revenue Code (“IRC”). Also, in accordance with Internal Revenue Service (“IRS”) guidelines, participants could not make contributions exceeding \$23,000 during 2024. Eligible employees may make an additional employee contribution known as a “catch-up” contribution in accordance with the Economic Growth and Tax Relief Reconciliation Act of 2001 (“EGTRRA”). Catch-up contributions were limited to \$7,500 for 2024.

The Company contributes a Safe Harbor matching contribution to the Plan, on behalf of each participant, an amount equal to 100% of the first 3% and 50% of the next 2% of his or her base compensation that the participant contributes to the Plan.

The Plan allows for the Company to make profit sharing and qualified nonelective contributions at its discretion. Contributions are subject to certain limitations. No nonelective contributions were made for the year ended December 31, 2024.

Participant Accounts – A separate account is maintained for each participant. Each participant’s account is credited with his or her contributions, the Company’s contributions, and the Plan earnings or losses and charged with an allocation of any administrative expenses paid by the Plan. Allocations of earnings or losses are based upon the investment performance of the individual funds in which each participant’s account balance is invested. Allocations of expenses are based on participant’s account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment Options – Upon enrollment in the Plan, a participant may direct employee contributions in increments among several investment options. Participants may change their investment options through the Plan’s recordkeeper on any normal business day.

Rollovers – Rollover contributions are permitted into the Plan in accordance with IRS regulations and Plan provisions.

1. DESCRIPTION OF THE PLAN (continued)

Notes Receivable from Participants – A participant may request a loan subject to the limitations set forth in the Plan. The minimum loan amount is \$1,000 and the maximum amount is the lesser of one-half a participant's non-forfeitable account balance or \$50,000. All loans are repaid ratably through payroll deductions over a period not to exceed five years, unless the loan qualifies as a home loan, and are secured by the balance in the participant's account. All loans shall bear a reasonable rate of interest established by the Plan administrator. Upon termination of employment a loan will become due and fully payable. A participant may only have one (1) loan outstanding at a time. One note receivable is outstanding at December 31, 2024, bearing an interest rate of 5% and a maturity date of April 2025.

Vesting – Participants are fully vested in their elective deferrals, rollover contributions, employer matching contributions and profit-sharing contributions.

Payment of Benefits – Under the Plan, normal retirement age is 65. Upon termination of service due to death, disability or retirement, a participant shall be considered 100% vested. Participants may receive a lump-sum or substantially equal installment amounts equal to the value of the participant's vested account balance or may elect to rollover the distribution to a qualified account. If the balance of the vested benefit does not exceed \$5,000, under certain circumstances the vested balance may be transferred to an automatic rollover account without the participant's consent. Lump sum distributions will be made as soon as practicable following the event.

Hardship Withdrawals – Participants may withdraw their elective deferral contributions, if applicable, to satisfy immediate and heavy financial needs. In accordance with IRS regulations, participants must first exhaust all other assets available before obtaining a hardship withdrawal. All hardship withdrawals must be approved by the Plan administrator.

Forfeitures – Forfeitures of employer profit sharing contributions may be used to reduce employer contributions or pay plan expenses. At December 31, 2024 the unallocated forfeitures total \$160,308. For the year ended December 31, 2024 no forfeitures were utilized.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The financial statements of the Plan have been prepared on the accrual basis of accounting, in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates – The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for descriptions of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date and interest is recorded when earned. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant’s account and are included as administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based upon the terms of the Plan document.

Administrative Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Expenses attributable to the administration or operation of the Plan are allocated pro rata on the basis of account balances of all participants. Investment related expenses are included in the net appreciation of fair value of investments.

Payment of Benefits – Benefit payments to participants are recorded when paid.

3. INFORMATION CERTIFIED BY TRUSTEE (UNAUDITED)

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520:103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan’s management instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the following information certified by Ascensus Trust Company, except for comparing such information certified by the Trustee with information included in the Plan’s financial statements and supplemental schedule of Form 5500, Schedule H, Part IV, Line 4i-Schedule of Assets (Held at End of Year):

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 — Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 — Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 — Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds and Money Market Funds: Valued at the daily closing price as reported by the fund. Mutual funds and money market funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission ("SEC"). These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

5. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

A party-in-interest is defined under Department of Labor (“DOL”) regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer and certain others. As described in Note 2, certain fees are paid from the Plan’s assets and therefore qualify as party-in-interest transactions. For the year ended December 31, 2024, the Plan incurred administrative fees totaling \$6,139 for recordkeeping services provided by Ascensus. Loans to participants are secured by the balances in the respective participant accounts. These transactions qualify as party-in-interest transaction and are exempt from the prohibited transaction rules.

6. PLAN TERMINATION

Although the Company has not expressed any intention to do so, the Company reserves the right under the Plan to modify, suspend, amend or terminate the Plan in whole or in part at any time subject to the provisions of ERISA. If the Plan is terminated, the amounts credited to the employer contribution accounts of all participants become fully vested.

7. RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The Plan’s exposure to a concentration of credit risk is limited by the opportunity to diversify investments across multiple funds including active and passively managed funds covering multiple asset classes. Additionally, the investments within each fund are further diversified into varied financial instruments.

8. TAX STATUS OF THE PLAN

The Plan has adopted a comprehensive 401(k) profit sharing plan non-standardized adoption agreement, which received a favorable opinion letter from the IRS on June 30, 2020, which states that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the federal or state taxing authorities. The Plan administrator has analyzed the tax positions by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

9. PROHIBITED TRANSACTIONS AND OPERATIONAL FAILURES

Delinquent Transmittal – The Company was delinquent in remitting to the Plan certain employee contributions totaling \$48,616 and \$78,809 for the years ended December 31, 2019 and 2018, respectively, within the time period prescribed by the Department of Labor's ("DOL") regulations. Delays in remitting contributions to the Plan were due to administrative errors. The Company intends on computing lost earnings and will make a contribution for the lost earnings to the Plan. The Company estimates the amount of the corrective lost earnings payments due to the Plan at less than \$1,000.

Matching Contributions – During the period from May through October 2018, the Company made contributions to the Plan and did not maintain supporting documentation for the contributions to the Plan. The Company was unable to reconcile the actual contributions to the Plan to the payroll reports for the related periods. This caused the Company to overfund certain participants' deferrals in the total amount of approximately \$46,000 and underfund certain matching contributions in the total amount of approximately \$20,000. The Company plans to correct the error under the IRS Voluntary Correction Program ("VCP").

Matching Contributions on Bonuses – During the years 2021 through 2024, certain participants bonuses were not receiving matching contributions. According to the Plan's document, there are no exclusions for any compensation. All compensation is subject to employee and matching contributions. The failure to submit matching contributions is due to administrative errors. The Company plans to correct the error under the VCP.

10. SECURE ACT 2.0

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included the Setting Every Community Up for Retirement Enhancement ("SECURE") Act 2.0. The SECURE Act 2.0 contains over ninety new retirement provisions, with varying effective dates through 2027. Since the SECURE Act 2.0 provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. Applicable provisions outlined in the SECURE Act 2.0 will be adopted if elected and/or required. The Plan administrator did not adopt any of the optional provisions for 2024 and accordingly, there was no material impact to the Plan's 2024 financial statements.

11. SUBSEQUENT EVENTS

Effective March 20, 2025, the Plan moved from Ascensus Trust Company as its Trustee and Ascensus LLC as recordkeeper. Services are now provided by Advisor Trust, Inc. as Trustee and PCS Retirement, LLC as recordkeeper and third-party administrator. Management evaluated this event and determined that it does not have a material effect on the Plan's financial statements for the year ended December 31, 2024.

The Company has evaluated subsequent events through December 12, 2025, the date which the financial statements were available to be issued.

12. RECONCILIATION TO FORM 5500

No material differences exist between the financial statements and Form 5500.
