Basis for Opinion

NOTE 1 - DESCRIPTION OF PLAN

The following description of Direction's 403(b) Plan (Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General - Directions for Youth and Families, Inc. (Company) established the Direction's 403(b) Plan effective July 1, 2004. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions - The Plan is a defined contribution plan. All full-time employees are eligible to make contributions upon date of hire. Long-term part-time employees are also eligible to contribute to the Plan. A long-term part-time employee is one who has not entered the Plan as a regular participant, but who is credited with at least 500 hours of service in at least three consecutive years beginning after December 31, 2020. Participants may contribute a percentage of their pretax annual compensation or a dollar amount, provided that such contribution does not exceed the Internal Revenue Service (IRS) prescribed limitations. Effective January 19, 2025, participants may also designate all or a portion of their deferral contributions as after-tax contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company may make a discretionary nonelective contribution. Such contributions are allocated to all eligible participants based on a uniform percentage of the participant's compensation. Participants are eligible for the discretionary nonelective contribution if they have attained 21 years of age, completed at least six months and 1,000 hours of service, and are employed as of the last day of the plan year. The Company's discretionary nonelective contribution to all eligible employees was 4% for the year ended June 30, 2025.

Participant Accounts - Each eligible participant's account is credited with the participant's and the Company's contributions and allocations of plan earnings. Plan earnings are allocated based on the ratio of each participant's account balance to the total of all participants' account balances in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options - Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and two guaranteed investment contracts as investment options for participants.

Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after two years of credited service.

Payment of Benefits - On termination of service due to death, disability or retirement, a participant or beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or periodic payments as requested. Participants may also withdraw their vested amounts in the Plan under certain hardship conditions, as defined in the Plan document.

Forfeited Accounts - Forfeited nonvested amounts are used to reduce employer contributions. No forfeitures were used to reduce employer contributions during the year ended June 30, 2025. At June 30, 2025 and 2024, the balance in the forfeitures account was immaterial.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of significant accounting policies consistently applied by the Plan administrator in the preparation of the accompanying statements of net assets available for benefits and related statement of changes in net assets available for benefits and the related notes to the financial statements follows:

Basis of Accounting - The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - The Plan's investments, with the exception of the fully benefit-responsive guaranteed investment contract held by Principal Trust Company (Principal), are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The guaranteed investment contract is stated at contract value, which is the most relevant measurement attribute. (See Note 5.) Contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Plan management determines the Plan's valuation policies utilizing information provided by the custodians. See Note 4 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Dividends are recorded on the ex-dividend date.

Payment of Benefits - Benefits to participants are recorded when paid.

Administrative Costs - The Plan's administrative expenses and management fees for the trust account are primarily paid by the Company which are excluded from these financial statements. Certain fees may be paid by the Plan as they are allocated directly to the participant responsible for the expense and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Risks and Uncertainties - The Plan invests in securities that are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in value will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events - The Plan has evaluated subsequent events through January 8, 2026, the date the financial statements were available to be issued.

NOTE 3 - CERTIFICATIONS

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year), including investments held at June 30, 2025 and 2024, and net appreciation in fair value of investments and interest and dividends for the year ended June 30, 2025, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal) and Voya Retirement Insurance and Annuity Company (Voya).

NOTE 4 - FAIR VALUE MEASUREMENT

Financial accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the standard are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2025 and 2024.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 5 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

The Plan entered into traditional fully benefit-responsive investment contracts with Principal and Voya totaling \$50,389 and \$77,581 as of June 30, 2025 and 2024, respectively. Principal and Voya maintain the contributions in a general account. The accounts are credited with earnings on the underlying investments and are charged for participant withdrawals and administrative expenses. The investment contract issuers are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer and will never be less than the Guaranteed Minimum Interest Rate. The crediting rate is reviewed on a semiannual basis for resetting. The investment contracts do not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

These contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for the fully benefit-responsive investment contracts because that is the amount received by participants if they were to initiate permitted transactions under terms of the Plan. Contract value, as reported to the Plan by Principal and Voya, represents contributions made under the contracts, plus interest, less participant withdrawals, if any. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations, which might be affected by future economic and regulatory developments. Certain events might limit the ability of the Plan to transact at contract value with the issuer, including (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan sponsor or other Plan sponsor events (e.g., divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan; (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA; or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at the contract value with the participants.

In addition, certain events allow the issuers to terminate the contracts with the Plan and settle at an amount different from contract value, including (1) an uncured violation of the Plan's investment guidelines; (2) a breach of material obligation under the contract; (3) a material misrepresentation; and/or (4) a material amendment to the agreement without the consent of the issuer.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer and certain others. Voya Retirement Insurance and Annuity Company, a subsidiary of Voya Financial, provides recordkeeping services to the Plan; therefore, administrative expenses paid to Voya Retirement Insurance and Annuity Company by the Plan are considered party-in-interest transactions. At June 30, 2025 and 2024, the Plan holds all investment interests in various mutual funds and two guaranteed investment contracts, of which Principal and Voya are the custodians. Accordingly, the Plan's investments in these funds qualify as party-in-interest transactions. Certain administrative functions are performed by employees of the Company at no cost to the Plan. These transactions qualify as party-in-interest transactions.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 8 - TAX STATUS

The Plan is a prototype plan of FIS Business Systems, which received an opinion letter on March 31, 2017, in which the IRS stated that the form of the Plan document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been designed to qualify under Section 403(b) of the IRC. Although the Plan has been amended since receiving this opinion letter, the Plan administrator believes that the Plan is currently designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

NOTE 8 - TAX STATUS (Continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2025, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes that the Plan is no longer subject to tax examinations for years prior to 2021.
