We have performed an audit of the financial statements of Trinity Presbyterian School, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year then ended June 30, 2025, and the related notes to the financial statements.

Notes to Financial Statements

Note 1 – Description of the Plan

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Eligibility - The Plan is a defined contribution plan covering all full-time employees of the School who have completed one year of service and have attained age 21. Substitute teachers, leased employees, and community coaches are specifically excluded from participation. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). For the year ended June 30, 2023, entrance into the Plan was changed to the beginning of each month instead of January 1 and July 1. Eligibility to join the Plan is the attainment of age 21 and 90 days of service for voluntary deferrals. Participants are also automatically enrolled when eligibility is obtained with a 3% after-tax deferral percentage. Nonelective contributions and safe harbor contributions remain age 21 and one year of service with entrance dates of July 1 and January 1.

Participant Contributions - Participants may contribute a percentage of pretax or after-tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

Employer Contributions - The School contributes a nonelective safe-harbor contribution equal to 3.00% of each eligible participant's compensation for the Plan year. Additional nonelective amounts may be contributed at the option of the School's Board of Directors as determined annually. Discretionary nonelective amounts will be allocated to employees who have completed a year of service, worked 1,000 hours during the Plan year, and were employed on the last day of the Plan year, unless due to death, disability, or retirement. There were no discretionary nonelective contributions for the years ended June 30, 2025 and 2024. Contributions are subject to certain limitations under the Internal Revenue Code.

Participant Accounts - Each participant's account is credited with the participant's contributions, the School's nonelective safe-harbor contributions, allocations of plan earnings, and charged with an allocation of certain plan expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50.00% of their vested account balance, whichever is less. Loan terms range from one to five years. The loans are secured by the balance in the participant's account and bear interest at prime plus 2.00% as of the date the loan is issued. Interest rates on loans outstanding at June 30, 2025 and 2024 ranged from 5.25% to 10.50%. Principal and interest are paid ratably through payroll deductions. Participants may only have one loan outstanding at any one time.

Note 1 – Description of the Plan (Continued)

Vesting of Participant's Interest - Participants are immediately vested in their contributions and the nonelective safe-harbor contributions plus actual earnings thereon. Vesting in the School's discretionary nonelective portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100.00% vested after five years of credited service or if separation from service occurs due to death, total and permanent disability, or retirement.

Payment of Benefits - Upon termination of service, the participant is entitled to a distribution equal to the value of the participant's vested account balance. For vested benefits less than \$5,000, a lump-sum distribution will be automatically made. For vested benefits greater than \$5,000 and if married on the date benefits are to begin, the participant will automatically receive a joint and 50.00% survivor annuity, unless the participant elects an alternate form of payment. For vested benefits greater than \$5,000 and if a participant is not married on the date benefits are to begin, the participant will automatically receive a life annuity, unless they select an alternate form of payment.

Forfeited Accounts - Nonvested forfeited amounts may be used to reduce employer contributions or to pay administrative expenses of the Plan. Forfeited amounts available at June 30, 2025 and 2024 were \$13,609 and \$13,466, respectively. For the years ended June 30, 2025 and 2024, forfeited amounts of \$0 and \$0 were used to reduce plan expenses, respectively.

Note 2 – Summary of Accounting Policies

Basis of Presentation - The financial statements of the Trinity Presbyterian School, Inc. (the School) 401(k) Plan (the Plan) are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Valuation of Investments - Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by the Custodian and Trustee. See Note 4 for discussion of fair value measurements.

Income Recognition - Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Employer and Employee Contributions – The Plan recognizes contributions in the period the employee contribution is withheld.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 30, 2025 or 2024. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits - Benefits are recorded when paid.

Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid directly by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Use of Estimates in the Preparation of Financial Statements - In preparing financial statements, management is required to make estimates and assumptions that affect the reported amounts of assets and liabilities and the disclosure of contingent assets and liabilities at the date of the financial statements and revenues and expenses during the reporting period. Actual results could differ from those estimates.

Subsequent Events - The Plan has evaluated subsequent events through December 19, 2025, which is the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

Professional accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2025 and 2024.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts: Valued at the net asset value (NAV) of units held by the Plan. The NAV is based on the fair value of the underlying investments adjusted for separate account management fees.

The following tables sets forth by level, within the fair value hierarchy, the Plan’s assets at fair value as of June 30, 2025 and 2024. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

For the year ended June 30, 2025, the Custodian also certified to the completeness and accuracy of \$420,324 of net appreciation in fair value of investments; \$310,151 of dividends on mutual funds; and \$38,035 of interest related to the aforementioned investments.

Note 5 – Guaranteed Investment Contract

The Plan has a fully benefit-responsive guaranteed investment contract with Empower Annuity Insurance Company (EAIC) for the year ended June 30, 2025 and 2024. EAIC maintain the contributions in its general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented at contract value on the face of the statements of net assets available for benefits.

Contract value, as reported to the Plan by EAIC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The credit interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting.

Note 5 – Guaranteed Investment Contract (Continued)

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan); (2) changes to the plan's prohibition on competing investment options; (3) bankruptcy of the plan sponsor or other plan sponsor events that significantly affect the Plan's normal operations; (4) the failure of the Plan to qualify under 401(a) of the IRC or the failure of the trust to be tax exempt under Section 501(a) of the IRC; or (5) premature termination of the contract. The Plan administrator believes no events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer, and that would limit the ability of the Plan to transact at contract value with the participants. In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include an uncured violation of the Plan's investment guidelines, a breach of material obligation under contract, a material misrepresentation, or a material amount of amendments to the agreements without the consent of the issuer.

Note 6 – Related Party Transactions

Certain Plan investments are shares of mutual funds and units of pooled separate accounts managed by Empower Annuity Insurance Company of America. Empower Annuity Insurance Company of America is the Custodian of the Plan investments. Therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment services are included in net appreciation (depreciation) in fair value of investments. Fees paid by the Plan to the Trustee, Synovus Trust Company, for the year ended June 30, 2025 totaled \$22,864 and are included in administrative expenses.

Note 7 – Plan Termination

Although it has not expressed any intent to do so, the School has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 8 – Income Tax Status

The Plan adopted a nonstandardized form of a prototype plan sponsored by Empower Retirement, LLC. The prototype plan has received an opinion letter dated September 16, 2022 from the Internal Revenue Service as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Note 8 – Income Tax Status (continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2025, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
