The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

We have performed a compilation engagement in accordance with Statements on Standards for Accounting and Review Services promulgated by the Accounting and Review Services Committee of the AICPA. We did not audit or review the financial statement nor were we required to perform any procedures to verify the accuracy or completeness of the information provided by plan management. We do not express an opinion, a conclusion, nor provide any assurance on the 2023 financial statement.

1. Description of Plan

The following description of The Rise Companies 401(k) Plan (formerly SMT, Inc. 401(k) Plan) (the "Plan") provides only general information for the Plan sponsored by SMT, Inc. (the "Company"). Participants in the Plan should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan became effective on June 1, 1979 as a defined contribution plan. The Plan covers all employees of the Company who are at least 18 years of age and have completed three consecutive months of service. Effective January 1, 2024, the Plan was amended to include employees of Rise Capital, LLC, Pitt Electric ORI, LLC and Oak Ridge Metal Works, LLC. Effective April 1, 2024, the Plan was amended to include employees of Fortune Electric, LLC. The Company is treated as a controlled group whereby all employees of each company shall be treated as employed by a single employer. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Employees may elect to contribute a percentage of their pre-tax or after-tax ("Roth") compensation, not to exceed the maximum allowed by the Internal Revenue Service ("IRS"). Employees who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Effective January 1, 2024, the Plan was amended whereby employees are automatically enrolled in the Plan with a 2% pre-tax deferral election upon meeting the eligibility requirements unless they opt out within 90 days. Additionally, the Plan was amended to include an automatic escalation provision whereby deferral rates increase annually by 1% up to a maximum of 6%. The Plan also permits rollover contributions from other qualifying retirement plans.

The Company makes safe harbor matching contributions whereby the Company matches 100% of a participant's elective deferrals up to 3% of the participant compensation, plus 50% of the participant's elective deferrals up to 5%. Effective January 1, 2025, the Plan was amended whereby the Company makes safe harbor matching contributions of 100% of a participant's elective deferrals up to 5%. Additionally, the Company may make an additional employer matching contribution or profit-sharing contribution. There were no discretionary matching or profit-sharing contributions in 2024.

Participant Accounts

Employee contributions, employer contributions, and rollover contributions activity are maintained separately in each participant's account. Participants direct the investment of their account balances into various investment options offered by the Plan. Participants may change their investments daily. Each participant's account is credited with the participant's contribution, the Company's contribution, and an allocation of plan earnings and administrative expenses. Allocations are based on participants' compensation or account balances, as defined. A participant is entitled to the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in the salary reduction amount contributed to the Plan and the Company's safe harbor match. Vesting in the Company's discretionary match and profit-sharing contributions is based on the years of continuous service. Participants are fully vested after completing six years of credited service.

Forfeitures

At December 31, 2024, forfeited accounts totaled \$60,565. Forfeitures can be used to pay administrative expenses, applied in the restoration of participant's accounts, or applied to reduce employer contributions. Effective January 1, 2024, the Plan was amended to allow forfeitures to be applied in the restoration of participant's accounts or applied to reduce employer contributions.

Payment of Benefits

Generally, a participant becomes eligible to receive benefits on their normal retirement age (55), death, disability, termination of employment, or reasons of proven financial hardship. Participants will receive 100% of their account balance in a lump sum amount. Partial withdrawals are only permitted for participants or beneficiaries who must receive required minimum distributions. Participants are also eligible to take in-service withdrawals once they attain age 59½. If the vested balance is less than \$5,000, a lump sum distribution is made.

Hardship Withdrawals

Upon approval by the plan administrator, a participant may withdraw all or part of their elective deferral contributions for immediate and severe financial need. In accordance with IRS regulations, the participant must exhaust all other assets available prior to obtaining the hardship withdrawal. Effective January 1, 2024, the Plan was amended to allow hardship withdrawals from all accounts.

Notes Receivable from Participants

Participants may borrow from their fund a minimum of \$1,000 up to a maximum equal to 50% of their vested account balance or \$50,000 reduced by the highest outstanding loan balance during the one-year period ending on the day before the loan is made. A participant can only have one loan outstanding at a time. The loans are secured by the balance in the participant's accounts and bear interest at a fixed rate equal to the prime rate plus one percent (9.50% at December 31, 2024) as of the date of the new loan. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants at December 31, 2024 and 2023 were \$264,005 and \$132,694, respectively.

2. Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Cash and Cash Equivalents

The Plan considers all invested cash balances to be cash equivalents.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based on upon the terms of the plan document.

Investment Valuation and Income Recognition

Investments are comprised of mutual funds, interest bearing cash and cash equivalents, and a collective investment trust fund. The Plan’s investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Realized and unrealized appreciation and depreciation in value of investments are allocated to the participant accounts based on participant holdings in each fund.

Plan Expenses

Certain plan expenses are paid by the plan sponsor as provided by the plan document. Expenses related to specific participant transactions (notes receivable from participant and distributions) are charged directly to the participant’s account.

3. Federal Income Taxes

The Plan adopted a Non-Standardized Pre-Approved Profit Sharing Plan document. This document received an opinion letter dated June 30, 2020, in which the IRS stated that the document was in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). As allowed by the IRS, the Plan is relying on the opinion letter issued on the plan document for its own qualification. The plan document has been amended for changes required by the IRS since receiving the opinion letter. The plan administrator believes the Plan is designed and currently operating in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would be sustained upon examination by the applicable authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in process

4. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their accounts.

5. Investments

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. The following information included in the accompanying financial statements and supplemental schedule was obtained or derived from information certified as complete and accurate by Ascensus, LLC, the trustee of the Plan as of December 31, 2023 and for the period from January 1, 2024 to January 12, 2024 and Reliance Trust Company (“Reliance”), the trustee of the Plan as of December 31, 2024 and for the period from January 13, 2024 to December 31, 2024 , and was not subject to audit for the years ended December 31:

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

Level 1 Inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority.

Level 2 Inputs are based on significant other observable inputs such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs are unobservable and significant to the fair value measurement.

6. Fair Value Measurements (Continued)

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. The Plan uses Level 2 inputs when market prices are not attainable but other observable inputs are available to arrive at a fair value, and Level 3 inputs were only used when Level 1 or Level 2 inputs were not available. There were no Level 2 or 3 investments in the Plan.

Level 1 Fair Value Measurements

The fair value of mutual funds and interest bearing cash and cash equivalents is based on quoted net asset values of the shares held by the Plan at year end.

Collective Investment Trust Fund

This investment is valued using the net asset value (“NAV”) of units of the collective investment trust (“CIT”) funds. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investments for an amount different from the reported net asset value.

7. Collective Investment Trust Fund

The T. Rowe Price Stable Value Trust Fund Class N is a CIT managed by T. Rowe Price Trust Company. The CIT seeks to provide maximum current income while maintaining stability of principal. It invests primarily in guaranteed investment contracts, bank investment contracts, synthetic investment contracts, and separate account contracts, designed to provide principal stability and a competitive yield. There were no unfunded commitments.

8. Risks and Uncertainties

The Plan invests in various investment securities as directed by its participants. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

9. Party-in-Interest Transactions

Plan investments are managed by Ascensus Trust Company and Reliance, the trustees as defined by the Plan, and therefore these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Ascensus Trust Company, Reliance, and other parties-in-interest for contract administration, advisory and professional services amounted to \$56,213 for the year ended December 31, 2024. The Plan also holds notes receivable from participants. As a result, these notes receivable and all related transactions were with a party-in-interest. All of these transactions are exempt from being prohibited transactions by ERISA.

10. Prohibited Transactions

During 2024, the Company failed to deposit \$7,415 of participant deferrals within the required timeframe as stated by the United States Department of Labor (“DOL”). The DOL considers late deposits to be a prohibited transaction. The Company plans to calculate and remit the lost earnings subsequent to year end and will file the Form 5330 to pay applicable excise taxes. The excise tax payments will be made from the Company’s assets and not from the assets of the Plan.

11. Subsequent Events

The Company has evaluated events and transactions for potential recognition or disclosure in the financial statements through December 22, 2025, which is the date the financial statements were available to be issued.

In December 2022, Congress passed the Setting Every Community Up for Retirement Enhancement Act of 2022 (“SECURE Act 2.0”) that continued the retirement system reform previously passed in 2020. Certain provisions of the SECURE Act 2.0 are effective starting in January 1, 2024 and various dates through 2026, with the plan amendment for the adoption of SECURE Act 2.0 due by December 31, 2026.

Effective January 1, 2025, R&D Specialties LTD Pooled Employer 401(k) Plan merged into the Plan.
