### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of the Tax Deferred Annuity Plan for Employees of WellLife Network Inc. (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



### ***Basis for Opinion***

## Notes to Financial Statements

---

### 1. Description of the Plan

The following description of the Tax Deferred Annuity Plan for Employees of WellLife Network Inc. (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan covering all eligible employees of WellLife Network Inc. (WellLife or the Employer), as defined in the Plan document. The Plan was adopted effective August 1, 1987. For the purposes of making salary deferral contributions, employees may enter the Plan immediately upon hire, as described below. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan is administered by the Employer.

#### *Contributions*

Participants may elect to defer a portion of their pretax annual earnings, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Under the terms of the Plan, WellLife does not make any contributions on behalf of the Plan's participants. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

#### *Participant Accounts*

Each participant's account is credited with the participant's contributions, as well as allocations of Plan earnings and losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### *Vesting*

A participant shall, at all times, be fully (100%) vested in their contributions plus any investment earnings thereon.

#### *Investment Options*

Participants may direct the investment of their account balances into any of the Plan's available investment options with Mutual of America Life Insurance Company (Mutual of America), which include pooled separate accounts and a guaranteed interest contract.

#### *Loans to Participants*

Participants may borrow from Mutual of America and use their Plan account balance as collateral. Participants may borrow a minimum of \$1,000 up to a maximum of the lesser of half of their vested account balance or \$50,000. The loan bears interest at a rate commensurate with local prevailing rates at the time funds are borrowed, as determined by Mutual of America. Loan terms range from one to five years; however, terms may exceed five years but not ten years for the purchase of a

primary residence. The collateral must be equal to or exceed 120% of the loan, and payments on the loan are made outside of the Plan. The loans to participants are not made from the Plan's assets, nor are they considered assets of the Plan. Therefore, the loans are not shown on the statements of net assets available for benefits. As of December 31, 2024, the total outstanding Plan loans collateralized by individual participant accounts was \$60,083 and \$66,391, respectively. As such, \$72,100 and \$79,669 of account values serve as collateral for the related loans as of December 31, 2024 and 2023.

### ***Payment of Benefits***

Upon termination of service due to death, disability, retirement, severance from employment, or hardship, a participant is entitled to receive a distribution in the amount equal to the value of the participant's vested interest in their account. The method in which a participant's account is distributed depends on their marital status and elections made by the participant and their spouse. If a participant is married on the date their benefits begin, the participant will automatically receive a joint  $66\frac{2}{3}\%$  survivor annuity, unless the participant and their spouse elect another form of payment. A married participant may also elect a 75% survivor annuity. If a participant is not married on the date their benefits begin, the participant will automatically receive a life annuity.

### ***Administrative Expenses***

The Employer pays substantially all administrative expenses of the Plan, except account administration expenses, which are paid by the participants. Administrative expenses paid by the Employer are excluded from these financial statements. Management fees and operating expenses charged to the Plan for its investments are deducted from the investment returns of such investments. Transaction fees, such as investment buying or selling fees, are paid by the Plan and charged directly to the participants.

## **2. Summary of Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America (GAAP).

### ***Use of Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of certain assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

The investments of the Plan are reported at fair value, except for the guaranteed interest account, which is a fully benefit-responsive investment contract, and reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the period.

### ***Payment of Benefits***

Benefits are recorded when paid.

### **3. Risks and Uncertainties**

The Plan is invested in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **4. Fair Value Measurements**

Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under ASC 820 are described below:

*Level 1* - This level consists of inputs to the valuation methodology that are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - This level consists of inputs to the valuation methodology that include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - This level consists of inputs to the valuation methodology that are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

*Pooled Separate Accounts* - These accounts are valued at their accumulation unit value (AUV), which approximates fair value. The AUV is determined daily based on the net asset value (NAV) of shares of the underlying fund and the separate account charges (i.e., the daily asset charge). The pooled separate accounts invest in various registered investment companies (mutual funds). The underlying funds of the investments in pooled separate accounts are various registered investment companies whose investment strategies are to seek capital appreciation through investment in common and preferred stocks and debt securities. The NAV, as determined by Mutual of America, is used as a practical expedient to measure fair value. NAV would not be used if it was probable that the investment would not be traded at NAV. Accordingly, the investments in pooled separate accounts are not required to be and have not been classified in the fair value hierarchy at December 31, 2024. The Plan's investments in the pooled separate accounts may be redeemed daily. There are no redemption fees or notice periods and no unfunded commitments. These are direct filing entities.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

As of December 31, 2024 and 2023, the Plan holds pooled separate accounts classified at NAV totaling \$5,656,111 and \$4,780,315, respectively.

The Plan had no financial assets that were measured at fair value on a nonrecurring basis at December 31, 2024.

### **5. Information Certified by Mutual of America**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedules, related to investments held as of December 31, 2024, and net appreciation in fair value of investments and interest income from guaranteed insurance contract for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Mutual of America, a qualified institution.

### **6. Fully Benefit-Responsive Guaranteed Interest Contract**

The Plan entered into a fully benefit-responsive guaranteed interest contract with Mutual of America. Mutual of America maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed interest contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer. Because the guaranteed interest contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed interest contract. Contract value, as reported to the Plan by Mutual of America, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk for the contract issuer or otherwise.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Employer or other Employer events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

### 7. Tax Status

The Plan has adopted Mutual of America's Prototype Non-Standardized 403(b) Plan Document. Mutual of America received an opinion letter, dated March 31, 2017, from the IRS that stated the prototype plan was designed in accordance with the applicable sections of the IRC. The Plan administrator believes that the Plan is currently designed and is being operated in compliance with all applicable sections of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 8. Related Party and Party-in-Interest Transactions

Certain Plan investments are shares of pooled separate accounts and the interest accumulation account managed by Mutual of America and, therefore, transactions involving these investments qualify as party-in-interest transactions. Additionally, certain employees and officers of WellLife, who are also participants of the Plan, perform administrative services for the Plan at no cost. Such transactions are permitted under the Plan and are exempt from the prohibition of party-in-interest transactions.

### 9. Plan Termination

Although it has not expressed any intent to do so, WellLife has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, each participant will continue to be 100% vested and the net assets of the Plan will be distributed as prescribed by ERISA.

### 10. Delinquent Participant Contributions

During the Plan years ended December 31, 2023 and 2021, participant contributions totaling \$39,213 and \$8,611, respectively, were not remitted to the Plan within the period prescribed by Department of Labor regulations. These transactions constitute prohibited transactions, as defined by ERISA. The related lost earnings were remitted to the Plan in July 2025.

### 11. Subsequent Events

The Company elected to add a Roth contribution feature effective September 1, 2025.

The Plan has performed an evaluation of subsequent events through January 23, 2026, the date the financial statements were available to be issued. The Plan is not aware of any other subsequent events that would require recognition or disclosure in the financial statements.
