As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institutions").

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating the certified investments information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control related matters that we identified during the audits.

### Note 1—Description of the Plan

The following brief description of the JRC Mechanical, LLC 401(k) Plan (the “Plan”) is provided for general information purposes only. Reference should be made to the Plan Agreement for a more complete description of the Plan’s provisions.

*General* – The Plan was established by JRC Mechanical, LLC (the “Company”) as a defined contribution plan effective May 1, 1999 and was most recently amended and restated effective January 1, 2022. The Plan is subject to the provisions of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan covers certain employees who have completed one year of service and have attained the age of 18 years of age. Eligible participants can join on first day of the Plan year or the first day of the 7<sup>th</sup> month of Plan year.

*Administration* – The Company is the Plan sponsor and the Plan administrator. Assets of the Plan are held and managed at Capital Bank and Trust Company and Nationwide Life Insurance Company, the qualified institutions. The Plan administrator has the responsibility to administer the Plan for the exclusive benefit of the participants and their beneficiaries. These duties include, but are not limited to, establishing procedures, maintaining records, interpreting provisions of the Plan, and making determinations regarding questions which may affect eligibility for benefits.

*Employee Contributions* – Participants may contribute up to the maximum amount permitted by law subject to certain Internal Revenue Code (“IRC”) limitations. The maximum contribution limitation for 2024 is \$23,000. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The limits on catch-up contributions for 2024 is \$7,500. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

*Employer Contributions* – Each year, the Company may contribute to the Plan by making a matching contribution to all eligible participants who have elected to make salary reduction contributions. The amount of the matching contribution, if any, will be determined each Plan year by the Company equal to a discretionary percentage. For the year ended December 31, 2024, the Company elected to make a matching contribution in an amount equal to 25% of each participant’s basic earnings, up to the first 4% of the participant’s deferral election. The employees eligible for the employer contribution must be employed at the last day of the Plan year. The Company may also elect to make a discretionary non-elective profit-sharing contribution to the participants’ accounts. There was no additional discretionary profit-sharing contribution made during 2024.

*Vesting* – Participants have a fully vested and nonforfeitable interest in their voluntary contributions, rollover contributions, plus actual earnings thereon. Vesting in Company discretionary matching contributions and discretionary non-elective profit-sharing contributions is based on years of service. Each participant’s vesting schedule is as follows:

### Note 1—Description of the Plan (continued)

*Payment of Benefits* – Participants are allowed in service withdrawals of their participant’s vested interest in his or her account upon attainment of retirement age or in the event of a financial hardship. On termination of service due to death, disability or retirement, a participant (or participant’s beneficiary) shall be entitled to receive 100% of their accrued benefit either in a single or a partial lump-sum distribution. Upon termination of service for any other reason or in the event of a financial hardship, a participant shall receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account.

*Participant Accounts* – Each participant’s account is credited with the participant’s contributions, rollover contributions and distributions plus an allocation of: (a) the Company’s discretionary matching contributions, (b) the Company’s discretionary non-elective profit-sharing contributions, and (c) investment earnings or losses (including net appreciation and depreciation in fair value of investments) and charged with an allocation of administrative expenses not paid by the Company. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*Notes Receivable from Participants* – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by their highest outstanding note balance during the past 12 months or 50% of their vested interest, subject to certain Plan restrictions. The notes are secured by the balance in the participant’s account and bear interest at a rate the Plan administrator establishes in a nondiscriminatory manner by reviewing the interest rates charged for similar types of loans by other lenders. Notes must be repaid within five years. If the note is made for the purchase of a participant’s residence, the note may be repaid over a reasonable period of time longer than five years. Principal and interest are paid ratably through payroll deductions. At December 31, 2024, the interest rates on the notes receivable for participants were 5.50%.

*Forfeiture Account* – Forfeitures are used to reduce employer contributions and Plan expenses. Forfeited accounts totaled \$4,774 and \$3,165 at December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, no forfeitures were used to reduced employer contributions.

### Note 2—Summary of significant accounting policies

*Basis of Accounting* – The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

*Use of Estimates* – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Notes Receivable from Participants* – Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

*Investment Valuation and Income Recognition* – The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. (See Note 4 for further discussion of fair value measurements).

**Note 2—Summary of significant accounting policies (continued)**

Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date and interest income is recognized when earned. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Fair Value Measurements* – U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability in the principal or most advantageous market for the asset and liability, in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value. U.S. GAAP defines three levels of inputs that may be used to measure fair value as follows:

*Level 1* – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

*Level 2* – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

*Level 3* – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following are descriptions of the valuation methodologies used for Plan instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy, if applicable. There have been no changes in the methodologies used at December 31 2024 or 2023:

*Money Market Fund* – This investment is a public investment vehicle valued using NAV provided by the administrator of the fund. The underlying assets are generally comprised of short-term securities representing high quality, liquid debt, and monetary assets. This investment is classified as Level 1 of the valuation hierarchy.

*Mutual Funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and considered Level 1 of the valuation hierarchy.

*Pooled Separate Accounts* – These investments are investment vehicles valued using NAV provided by the administrator of the fund, as a practical expedient. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is excluded from the valuation hierarchy consistent with U.S. GAAP.

The methods described above produce a fair value determination that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

*Payment of Benefits* – Benefits are recorded when paid.

*Administrative Expenses* – Certain administrative expenses paid directly by the Plan sponsor include legal fees, third party administration, and accounting fees. Investment fees of the individual funds are paid by the Plan. The earnings and value of the various funds reflect the deduction of these investment fees.

*Excess Contributions Payable* – Amounts payable to participants for contributions in excess of amounts permitted by the Internal Revenue Service (“IRS”) are recorded as a liability with a corresponding decrease to contributions. As of December 31, 2024 and 2023, the Company has excess contribution payables of \$32,288 and \$78,014, respectively. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15 of the following year.

**Note 3—Information certified by the qualified institutions (unaudited)**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the qualified institutions of the Plan has certified to the completeness and accuracy of the following data included in the accompanying financial statements and supplemental schedule:

Investments, at fair value, and notes receivable from participants as shown on the statements of net assets available for benefits as of December 31, 2024 and 2023.

Net appreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

The Plan’s independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule, schedule of assets (held at end of year).

**Note 5—Tax status**

The Plan is a Non-Standardized Prototype Plan (“Prototype Plan”) adopted by the Company. The Company received an opinion letter from the IRS, dated June 30, 2020, which states the Prototype Plan satisfies the applicable provisions of the IRC. The Company and the Plan administrator believe the Plan is designed and operated in compliance with the applicable requirements of the IRC, the Plan and related trust continue to be tax-exempt, and the Plan has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

**Note 6—Party-in-interest transactions**

Plan investments and the related transactions as of December 31, 2024 and 2023 and for the year ended December 31, 2024 were in investment funds managed by the qualified institutions; therefore, these investments and transactions qualify as party-in-interest transactions. Fees paid during the year for accounting and other services rendered by parties-in-interest were based on customary and reasonable rates for such services. Fees paid to the qualified institutions totaled \$14,027 for the year ended December 31, 2024. Notes receivable from participants are also considered to be party-in-interest transactions because they are transacted with Plan participants.

**Note 7—Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

**Note 8—Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 10—Delinquent participant contributions**

During the year ended December 31, 2024, the Plan failed to remit in a timely manner certain participant contributions from its assets within the required time period as specified by DOL Reg. 2510.3012. Failure to segregate and remit contributions within the specified time period is a prohibited transaction according to the provisions of ERISA and the IRC. The Plan made the deposit after the required timeframe and remitted lost earnings and late remittances during 2024.

**Note 11—Subsequent events**

The Plan's management evaluated subsequent events through December 2, 2025, in connection with the preparation of these financial statements, which is the date the financial statements were available to be issued.
