To Whom It May Concern,

We are writing to sincerely apologize for the late filing of Form 5500 for the plan year ending in 2023 and to provide an explanation of the circumstances that led to this delay.

Our company previously maintained a 401(k) plan, which was closed during 2023. During the time the plan was active, Paychex served as our plan administrator and handler. It was our understanding that Paychex would prepare Form 5500 on our behalf and provide it to us for filing.

Regrettably, we did not receive the prepared Form 5500 or any related notification from Paychex for the 2023 plan year. As a result, we were unaware that Form 5500 had not been filed. This oversight was not intentional and occurred due to our reliance on our service provider, the non-receipt of the required filing information, and the lack of system access following the plan's cancellation.

During this same period, our company address changed. Because we no longer had access to our Paychex 401(K) account, we were unable to update our address in the system. As a result, we did not receive the initial IRS correspondence that was sent in November to our previous address. We became aware of the issue only after subsequently receiving the notice regarding the missing filing at our current address.

Immediately upon receiving the notice from the IRS we contacted Paychex to resolve the matter. We are now acting promptly to bring the plan into compliance. Enclosed with this submission are Form 5500-SF received from our provider today and Form 8822-B. We are also mailing all required documents together to ensure full and timely compliance.

This late filing was not intentional and resulted from administrative circumstances beyond our control, including lack of access to our account following plan termination. We sincerely regret this oversight and respectfully request your understanding and consideration as we work diligently to correct this matter.


