We are the Court Appointed Accountants in the Bankruptcy of iSun Inc. (“iSun” or the “Debtor”), the Sponsor of the iSun 401(k) Retirement Plan (the “Plan”). iSun filed for protection under Chapter 11 of the United States Bankruptcy Code on June 3, 2024, and sold all of its assets on August 23, 2024, at which time all operations and payroll ceased. Our firm and the Plan Administrator were appointed on November 1, 2024, and the case was converted to Chapter 7 proceeding on January 27, 2025. As a result of the bankruptcy proceeding and cessation of operations, and pursuant to 11 U.S.C. Sect. 704(a)(11), the Plan needs was terminated and the Plan Administrator has liquidated and distributed all Plan Assets.

The 2025 annual informational return was prepared by Principal Financial Group (“Principal”), the Plan Asset Custodian, from the best information available; that is, data provided by the Debtor’s former personnel and the Debtor’s payroll service. Due to the cessation of business and the filing of the bankruptcy, certain key financial records, subsidiary ledgers and documentation supporting various policies, transactions, and other matters that would normally be expected to be present in an operating enterprise, were missing or unavailable.

This Plan requires audited financial statements along with a Schedule of Assets, but as a result of the bankruptcy the Debtor does not have funds to pay for the audit, and bankruptcy regulations require that Plan expenses be paid from Plan Assets. In an effort to minimize costs and preserve participants’ funds, the annual audit will not be prepared. Given that the Plan has terminated and all funds were distributed to participants, the Plan Administrator and Bederson believe that not preparing audits was in the best interests of the Plan’s participants. In addition, the Debtor’s former personnel have only provided limited financial or other records needed to administer the bankruptcy and complete the audit, and the Plan’s prior auditors have not responded to our requests for information because they have a substantial unpaid balance owed by the Debtor. Accordingly, due to lack of information caused by the bankruptcy and the need to preserve Plan Assets for participants’ benefit, the annual audit was not be prepared this Form 5500. Our retention application to the Court disclosed that audits would not be prepared, and all parties including the DOL were notified and had an opportunity to respond.

During 2025, as part of the termination and liquidation process, all of the Plan’s remaining funds were distributed to Participants. We are not aware of any complaints from Participants regarding the distribution or disposition of their account balances.

The Plan Administrator, by his signature on the face of this informational return, has relied on Principal’s expertise in preparing the return from the available records, which were limited due to the entity’s cessation of business. We have no direct knowledge of the transactions recorded by the Debtor and Principal prior to our appointment. In addition, we have no knowledge of the processes used or policies put in place by the Debtor or Principal. However, it is our qualified opinion that this is a complete return based on the financial information available.
