Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Venus Fashion, Inc. Retirement Benefits Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP"); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of Plan:

The following description of the Venus Fashion, Inc Retirement Benefits Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan was initially established on January 1, 1992, and restated October 1, 2023. The Plan is a 401(k) defined contribution plan covering all employees of Venus Fashion, Inc. (the “Company”). The Plan is subject to the provisions of ERISA.

Eligibility

Employees who have completed two months of service and are age twenty-one or older are eligible to contribute to the Plan, except employees covered by a collective bargaining agreement, leased employees, and residents of Puerto Rico. Eligible employees may enroll immediately upon satisfying the Plan’s eligibility requirements.

Employees who have completed 12 months of service, with 1,000 hours of service, are eligible to participate in employer nonelective contributions.

Investments

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers mutual funds, common/collective trusts, and a guaranteed investment contract as investment options for participants.

Contributions

Each year participants may elect to contribute up to 90% of their annual compensation, as defined by the Plan up to the maximum allowable under the Internal Revenue Code (“IRS”). In addition, employees who have attained age 50 by the end of the Plan year may make catch-up contributions up to limits defined by the IRS. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Company has elected to make safe harbor matching contributions equal to an amount equal to 100% of salary deferrals that do not exceed 4% of compensation. Additional employer discretionary matching and nonelective contributions may be made at the option of the Company. Contributions are subject to certain limitations. The Company did not contribute additional discretionary contributions to the Plan during 2024.

1. Description of Plan (Continued):

Participant Accounts

Each participant's account is credited with the participant's contribution and allocation of (a) the Company's contribution and (b) Plan's investment earnings and losses. Plan earnings are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants invested in that fund. Any related administrative expenses based on participant earnings or account balances are deducted from the participant's account. The participants' accounts are adjusted daily to reflect contributions, income, and expenses.

Vesting

Participants are vested immediately in their contributions as well as employer safe harbor contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and nonelective contributions is based on the following table:

Less than 2 years	0%
2 but less than 3	20%
3 but less than 4	40%

Participant Loans Receivable

Participants may borrow a minimum of \$500, up to 50% of their vested contributions and related earnings, not to exceed \$50,000. Participants are permitted one outstanding loan at a time. Loans are secured by the balance in the participant's account and must be repaid in level payments through payroll deductions within a 5 year period, except for loans for the purchase of a principal residence which may be repaid over a reasonable period of time not to exceed a maximum of 30 years. Generally, notes receivable from participants include interest at 1% above the prime rate.

Payment of Benefits

The entire vested balance in an individual participant's account shall be payable to the participant upon the election of the participant, upon retirement at or after age 65, or upon determination of total and permanent disability, or to the participant's beneficiary in the event of death. A participant becomes fully vested upon death or total and permanent disability. Additionally, hardship withdrawals and certain other in-service withdrawals are also permitted by the Plan if certain criteria are met. Account balances that are under \$5,000 may be automatically paid out at the discretion of the Plan. The Plan requires a minimum distribution of \$500 for partial withdrawals.

Forfeited Accounts

Forfeitures from non-vested participant accounts are used to reduce future Company contributions and to pay Plan expenses. At December 31, 2024 and 2023 there were \$10 in forfeited non-vested accounts. During the year ended December 31, 2024, forfeitures totaling \$412 were used to reduce employer contributions.

1. Description of Plan (Continued):

Administrative Expenses

Administrative expenses of the Plan may be paid by the Company or Plan. Unless paid by the Company, administrative expenses are allocated to 1) participant accounts proportionally based on the value of the account balances, 2) as an equal dollar amount based on the number of participants of the Plan, or 3) charged to the related participant's account, based on the nature of the expense.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

2. Summary of Accounting Policies:

Basis of Accounting

The accompanying financial statements of the Plan are prepared using the accrual method of accounting in accordance with GAAP.

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are presented at fair value, except fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements. Contract value is the relative measurement attribute for that portion of the net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. Realized gains and losses on the sales of securities are reported on the average cost method.

Notes Receivable from Participants

Notes receivable from participants are reported at amortized principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent notes receivable from participants are reclassified as distributed based upon the terms of the Plan document. The loans are secured by the balance in the participants' accounts.

2. Summary of Accounting Policies (Continued):

Payment of Benefits

Benefits are recorded when paid.

Risks and Uncertainties

The Plan provides for various investment options in mutual funds. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

3. Fair Value Measurements:

Financial Accounting Standards Board, Statement of Accounting Standards Codification Topic 820 (ASC 820), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1 - Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

Level 2 - Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;

Level 3 - Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

In many cases, a valuation technique used to measure fair value includes inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy. The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Mutual funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Common/collective trusts: Stated at fair value as determined by the issuers of the funds on the fair market value of the underlying investments, which is valued at net asset value ("NAV") as a practical expedient to estimate fair value. The practical expedient would not be used if it is determined to be probable that the funds will sell the investment for an amount different from the reported NAV.

3. Fair Value Measurements (Continued):

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables set forth by level, within the fair value hierarchy, the Plan investment assets at fair value as of December 31, 2024 and 2023.

4. Investment Contract with Insurance Company:

The Plan invests in a guaranteed interest contract with Voya Retirement Insurance and Annuity Company (“Voya”), which is a fully benefit-responsive investment contract. Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed interest contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed interest contract is fully benefit-responsive, contract value is the relevant measurement attribute because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Contract value of the guaranteed interest contract was \$156,287 and \$232,896 at December 31, 2024 and 2023, respectively.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include but may not be limited to the following: 1) participant termination, 2) removal from the Plan of one or more groups or classifications of participants, 3) partial or complete Plan termination or 4) Plan disqualification. In general, the following events would permit Voya to terminate the contract and settle at other-than-contract value: 1) the Plan's loss of its qualified status, 2) Plan termination, 3) uncured breaches of material obligations under the contract, or 4) advance notification by either party.

5. Information Certified by the Plan's Custodian:

The following investments included in the statements of net assets available for benefits as of December 31, 2024 and 2023 and the dividends and net appreciation in fair value of investments included in the statement of changes in net assets available for benefits for the year ended December 31, 2024 have been derived from information certified as complete and accurate by Reliance Trust Company in accordance with 29 CFR 2520.103-5(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, as follows:

6. Party-in-Interest Transactions:

ADP, LLC ("ADP") provides recordkeeping services to the Plan and is considered a party in-interest to the Plan. The Plan paid \$50,733 to ADP during the 2024 Plan year which is included in administrative expenses.

Reliance Trust Company is the trustee and custodian of the Plan, therefore, transactions involving managed investments qualify as party-in-interest transactions.

Voya Retirement Insurance and Annuity Company is the custodian of the certain investments, therefore, transactions involving managed investments qualify as party-in-interest transactions.

Included in the Plan assets are notes receivable from participants. At December 31, 2024 and 2023, notes receivable from participants amounted to \$179,596 and \$261,773, respectively. For the year ended December 31, 2024, interest income related to notes receivable from participants amounted to \$12,611. These transactions qualify as party-in-interest transactions permitted under provisions of ERISA

7. Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

8. Tax Status:

The Plan was established under the Prototype Non-standardized Profit Sharing Plan with CODA (the “Prototype Plan”). The Internal Revenue Service issued a determination letter dated October 6, 2020, stating that the Prototype Plan was in accordance with the applicable Plan designed requirements as of that date. The Plan as adopted and amended has not requested a determination letter. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement dates.

Management has evaluated the Plan's tax positions and concluded that as of December 31, 2024, the Plan had taken no uncertain tax positions that require recognition of a liability (or asset) in the financial statements. With few exceptions, the Plan is no longer subject to income tax examination by the U.S. federal, state or local tax authorities for tax years before 2021.

9. Partial Plan Termination:

As a result of a reduction of the Plan Sponsor's workforce, the Plan experienced a partial plan termination as defined by ERISA in 2024. Under ERISA, a partial plan termination may occur if a significant percentage of the Plan participants are terminated because of an action taken by the Plan Sponsor. If a partial plan termination occurs, full vesting in the employer's contributions is required for the affected participants, but the remaining participants' vesting continues to be determined per the plan provisions.

All affected employees who were participants in the Plan were fully vested in their account balances at the date of their partial plan termination. Vesting provisions for remaining active participants continue to be governed by the Plan's terms.

10. Subsequent Events:

During October 2025, the Plan experienced partial plan termination as defined by ERISA due to a reduction of the Plan Sponsor's workforce.

Management has evaluated subsequent events through December 8, 2025, the date the financial statements were available to be filed and has determined that there were no material events, except as described above, requiring recognition or disclosure.
