Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of WGNSTAR 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements (2024 financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of WGNSTAR 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

1) PLAN DESCRIPTION

The following description of the WGNSTAR 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

a) General

The Plan is a defined contribution plan covering all eligible employees of Westerwood Global USA Corporation (the Company or Plan Sponsor), who have completed 30 days of service and have attained age eighteen by the effective date of participation, as defined by the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The trustees are responsible for oversight of the Plan.

b) Plan Name Change, Merger and Asset Transfer

Pursuant to an adopting resolution, the Westerwood Global USA Corporation 401(k) Plan merged into the NSTAR Global Services 401(k) Retirement Plan effective January 1, 2024. A transfer of assets into the NSTAR Global Services 401(k) Retirement Plan from the Westerwood Global USA Corporation 401(k) Plan in the amount of \$429,687 is reflected on the statement of changes in net assets available for benefits for the year ended December 31, 2024 and was received in January 2024. The plan document was restated effective January 1, 2024, to reflect the merger at which point the plan name was changed to WGNSTAR 401(k) Plan.

c) Plan Contribution Policy

Each year participants may contribute a percentage of annual eligible compensation, as defined by the Plan. Participants who have attained age fifty before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Participants may modify salary deferral elections periodically. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various pooled separate accounts and a guaranteed investment contract as investment options for participants. At its discretion, the Company may make a matching contribution. In 2024, the matching contribution was 50% of participant deferrals, limited to 1.5% of annual eligible compensation. Contributions are subject to certain Internal Revenue Service limitations.

d) Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

e) Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$8,264 and \$1,019. Forfeiture funds can be used to pay plan administrative expenses or reduce employer contributions. During the year ended December 31, 2024, plan administrative expenses of \$5,040 were paid from the forfeited non-vested accounts.

f) Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after three years of credited service. A year of service is defined as a 12-month period of time beginning on a participant's date of hire. The Plan contains additional specific rules for crediting hours of service for vesting purposes. Participants will become fully vested upon death, total and permanent disability, or reaching normal retirement age (defined by the Plan as 65).

g) Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the present value of their vested account balance. Participants may have no more than one loan outstanding at any time. The loans are secured by the balance in the participant's account and bear interest at the United States Prime rate plus 2%. Principal and interest are paid ratably through bi-weekly payroll deductions. Loans generally may not exceed a five-year term unless it is for the purchase of a principal residence.

h) Payment of Benefits

On termination of service, a participant is entitled to a single lump-sum payment or a direct rollover to a tax qualified plan equal to the value of the participant's vested interest in his or her account. Generally, certain minimum distributions are required for participants who have separated from service and have reached age 73. The Plan allows hardship withdrawals, subject to account balance limits and applicable laws.

2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

a) Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

b) Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

c) Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to contract administration are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

d) Payment of Benefits

Benefits are recorded when paid. There were no benefits requested before year-end that were not paid.

e) Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Plan management determines the Plan's valuation policies utilizing information provided by investment advisors and Empower. See Note 6 for a discussion of fair value measurements.

f) Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

g) Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants in October 2025.

h) Subsequent Events

The Plan has evaluated subsequent events through January 26, 2026, which is the date the financial statements were available to be issued. There are no material subsequent events which require recognition or disclosure.

3) RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

4) PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% invested in their employer contributions.

5) PLAN MERGER AND TRANSFER OF PLAN ASSETS

On September 28, 2023, the current Plan Sponsor, Westerwood Global USA Corporation (EIN# 80-0905560), adopted a resolution to merge the Westerwood Global USA Corporation 401(k) Plan (EIN# 80-0905560, Plan Number #001) into the NSTAR Global Services 401(k) Retirement Plan (EIN# 03-0480734, Plan Number #001) effective January 1, 2024 and rename it WGNSTAR 401(k) Plan (EIN# 80-0905560, Plan Number #001). The plan assets were transferred to the WGNSTAR 401(k) Plan (EIN# 80-0905560, Plan Number #001) on January 19, 2024, under the trust of Empower Life and Annuity Insurance Company of New York and Empower Trust Company, LLC (collectively "Empower"). The total amount of the plan transfer was \$429,687.

6) FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodology used for assets measured at fair value by the Plan. There has been no change in the methodology used at December 31, 2024 and 2023:

Pooled separate accounts: Valued at the net asset value (NAV) of units held by the Plan at year end. The NAV is determined by dividing the net assets, at fair value, of the fund by the number of units outstanding on the day of valuation. Pooled separate accounts are comprised, primarily, of shares of registered investment companies held through sub-accounts of a separate account of an insurance company. As a practical expedient, the NAV, as adjusted (for mutual fund dividends, mutual fund splits and administrative maintenance charges and other items) and reported by the insurance company, is used to estimate fair value. The investments are redeemable daily at the adjusted NAV under agreements with the insurance company. However, it is possible that the redemption rights may be restricted or eliminated in the future. Due to the nature of the investments, changes in market conditions, liquidity requirements and the economic environment may significantly affect the NAV of the registered investment companies and, consequently, the fair value of the Plan's investments.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

7) GUARANTEED INVESTMENT CONTRACT

The Plan has a traditional, fully benefit-responsive guaranteed investment contract with Empower Life & Annuity Insurance Company of New York (ELAINY) that is reported at contract value. Assets allocated to the guaranteed investment contract totaled \$266,367 and \$216,989 on December 31, 2024 and 2023. ELAINY maintains the contributions in the general account. The account is credited with contributions, earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1%. Such interest rates are reviewed on a quarterly basis for resetting. The average crediting rate for the period of January 1, 2024 – December 31, 2024 was 2.8%.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by ELAINY, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination, or merger with another plan), (2) changes to the Plan's prohibition on completing investment options or deletion of equity washing provision, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause significant withdrawals from the Plan, or (4) the failure of the trust to qualify for exemption from federal taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants. In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

9) ADDITIONAL DEPOSIT DUE FROM PLAN SPONSOR

The Plan Sponsor failed to provide plan participants an opportunity to defer on certain compensation during the plan year ended December 31, 2024. In order to remedy this issue, the Plan Sponsor will make an employer contribution of \$5,453, including lost earnings of \$405 in February 2026. The employer contribution represents 50% of the missed deferral the employee would have made and 100% of the eligible match for the applicable pay periods from January 1, 2024 – December 31, 2024.

10) PROHIBITED TRANSACTIONS

As required by ERISA section 2510.3-102, the Plan Sponsor is required to deposit employee contributions when the assets can be reasonably segregated from the general assets of the company. During the plan year ended December 31, 2024, there were deposits of participant contributions and loan repayments which have been determined to be late. The Plan Sponsor will make an interest payment in the amount of \$148 in February 2026 to compensate plan participants for investment earnings relating to the prohibited transactions for the plan year ended December 31, 2024.

12) TAX STATUS

On June 30, 2020, the Internal Revenue Service (IRS) stated that the prototype adopted by the Plan, as then designed, qualifies under the Internal Revenue Code (IRC) Section 401(a). The Plan has not received a determination letter specific to the Plan itself; however, the Plan administrator believes that the Plan was designed and was being operated in compliance with the applicable requirements of the IRS. Therefore, no provision for income taxes has been included in the Plan's financial statements. Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more than likely would not be sustained upon examination by the IRS.

TAX STATUS (Cont.)

The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The Plan is in violation of ERISA for failure to file a 2024 Form 5500 Annual Report satisfactory to the DOL. No liability has been included in these financial statements as any potential penalty will not be paid out of the Plan.
