We have performed audits of the financial statements of University of Maryland Physicians, P.A. Money Purchase Pension Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended June 30, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of June 30, 2025 and 2024, and for the year ended June 30, 2025, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Notes to the Financial Statements

1. Description of Plan

The following brief description of University of Maryland Physicians, P.A. Money Purchase Pension Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, established by University of Maryland Physicians, P.A. (the Association or Employer), and became effective April 1, 1986, and was amended and restated April 3, 2017. The Plan is a money purchase pension plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan covers all eligible employees of the Association upon completion of one (1) hour of service, except for leased or temporary employees, employees covered by a collective bargaining agreement, and residents and fellows of the University of Maryland School of Medicine.

Custodian and Administration of the Plan

The custodian and recordkeeper of the Plan is Teachers Insurance and Annuity Association (TIAA) and College Retirement Equities Fund (CREF). The administrator of the Plan is the Association. TIAA and CREF hold all assets of the Plan in accordance with the service provider contract with the Organization. The Retirement Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

Each year, as required by the Plan document, the Association contributes to the Plan an amount equal to 7.25% of participant's compensation, as defined by the Plan (Employer contribution). Participants direct their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, an insurance contract, and a pooled separate account as investment options for participants. Contributions are subject to certain Internal Revenue Services (IRS) limitations. Participants may also rollover amounts representing distributions from other qualified defined benefit or contribution plans. No employee elective deferrals are allowed under the Plan.

Participant Accounts

Each participant's account is participant directed and is credited with the Association's contribution according to the investment options selected by the participant. Any earnings or losses are allocated to the participant's account based upon the balance in each account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in the Association's contributions plus actual earnings thereon.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or to purchase a retirement income insurance or annuity contract. In the case of a participant who is married on the date that benefit payments are to commence, all benefit distributions shall be in the form of a qualified joint or survivor annuity unless the participant elects otherwise and obtains spousal consent. In the case of a participant who is single on the date benefit payments are to commence, all benefit distributions shall be in the form of a life annuity unless the participant elects otherwise. If a participant's vested interest is less than \$1,000, payment to the participant or beneficiary will be made in a lump sum. Accordingly, if a participant terminates employment with an account balance of more than \$1,000, that participant must affirmatively elect the form and timing of the distribution from the Plan.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements are prepared using the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodian and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions Receivable

Employer contributions are recorded as receivables when the related compensation is earned, in accordance with the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Association elected to pay substantially all administrative expenses on behalf of the Plan. Expenses paid by the Association are excluded from these financial statements. Investment-related expenses are included in net appreciation.

Funding Policy

The Association's funding policy is to make monthly contributions to the Plan in amounts that are expected to remain a constant percentage of employees' compensation each year such that, all employees' benefits will be fully provided for by the time they retire.

Subsequent Events

Events that occurred subsequent to June 30, 2025 have been evaluated by the Plan's management for potential recognition or disclosure in the financial statements through the date of the independent auditor's report, which is the date the financial statements were available to be issued.

3. Fair Value Measurements

Accounting Standards Codification (ASC) 820, Fair Value Measurement, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at June 30, 2025 and 2024. Such information

is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements.

The following is a description of the valuation methodologies used for assets measured at fair value:

Registered Investment Companies - Registered investment companies are valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

Pooled Separate Accounts (PSAs) - PSAs are valued at the NAV of units held and are published daily on NASDAQ. The NAV is based on the fair value of the underlying investments held by the PSA less its liabilities. The fair value of the underlying investments is determined using market quotations or prices obtained from independent pricing sources that may employ various pricing methods to value the investments, including matrix pricing.

Non-Fully Benefit-Responsive (NFBR) Insurance Company General Contract (ICGCs) - The ICGCs are fixed return products with annual interest rate guarantees and are credited on a net daily (or monthly) basis at annual effective rates. Fair value is determined based on a discounted cash flow model by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer or the theoretical exit price. TIAA values the ICGCs based on the amount paid when funds are withdrawn prior to their maturity for an event other than death, disability, termination, or retirement. The fair value represents contract value adjusted to reflect current market interest rates only to the extent such market rates exceed crediting rates. Liquidity restrictions limit the types and timing of distributions allowed and subject certain distributions to a 2.5% surrender charge if certain conditions are met.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Certified Investment Information

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at June 30, 2025 and 2024, and net appreciation in fair value of investments and interest and dividends for the year ended June 30, 2025, was obtained by management and agreed to or derived from information certified as complete and accurate by TIAA and CREF, qualified institutions.

5. Related Party and Party-In-Interest Transactions

The Plan invests in shares of registered investment companies, pooled separate accounts, and an insurance company general contract managed by TIAA. TIAA is the custodian and recordkeeper as defined by the Plan and; therefore, these transactions qualify as party-in-interest transactions, which are exempt from prohibited transaction rules.

6. Tax Status

The IRS has determined and informed the Plan by a letter dated May 8, 2014 that the Plan was designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The Association is responsible for reviewing the annual Required Amendments List issued by the IRS for individually designed plans to retain qualified tax status. The Plan Administrator and its legal counsel believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC and continues to be tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

7. Plan Termination

Although it has not expressed any intent to do so, the Association has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

8. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits.
