INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of
Savings Plan for Employees of Intermountain Power Service Corporation:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Savings Plan for Employees of Intermountain Power Service Corporation (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of assets available for benefits as of June 30, 2025 and 2024, and the related statement of changes in assets available for benefits for the year ended June 30, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2025 and 2024, and for the year ended June 30, 2025, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTES TO FINANCIAL STATEMENTS AS OF JUNE 30, 2025 AND 2024, AND FOR THE YEAR ENDED JUNE 30, 2025

1. DESCRIPTION OF THE PLAN

The following description of the Savings Plan for Employees of Intermountain Power Service Corporation (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s information.

General—The Plan is a defined contribution plan covering substantially all employees of Intermountain Power Service Corporation (IPSC) (the “Company”). The board of directors of the Company has appointed the Savings and Retirement Committee to control and manage the operation and administration of the Plan. Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (“Principal Trust Company”) serves as the trustee of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions—Contributions to the Plan include (i) salary reduction contributions authorized by participants, (ii) matching contributions made by the Company, (iii) discretionary contributions made by the Company, and (iv) participant rollovers from another qualified plan. Participants have the option to make Roth elective salary reduction contributions to the Plan.

Participants may elect to make contributions to the Plan up to a maximum of 75% of the participant’s pre-tax or post-tax eligible compensation, subject to the limitations, as defined in the Plan document. Such contributions are excluded from the participant’s taxable income for federal income tax purposes until received as a withdrawal or distribution from the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a target date retirement fund based on the participant’s current age relative to the Plan’s normal retirement date, until changed by the participant. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

The Company match is 100% of each participant’s contributions up to 6% of their eligible compensation for all participants. The maximum contribution amount eligible to be matched is 6% of eligible compensation as defined by the Plan.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (“rollovers”). Contributions are subject to certain Internal Revenue Code (IRC) limitations.

Participant Accounts—Individual accounts are maintained for each participant of the Plan. Each participant’s account is credited with the participant’s contributions and related matching and Company contributions and plan earnings. Participant accounts are also charged with withdrawals and an allocation of plan losses and administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investments—Participants may direct the investment of their contributions and/or account balances into various investment options offered by the Plan and may change investments and transfer amounts between funds daily. The Plan offers investment options of mutual funds, collective investment trusts, and a pooled separate account.

Vesting—Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after five years of credited service.

Notes Receivable from Participants—Participants may borrow from their accounts up to a maximum of the lesser of one-half of the vested account balance or \$50,000 or 50%. Participants may not have more than three loans outstanding from the Plan at the same time. The loans are secured by the balance in the participant’s account and bear interest at prime rate, plus 2% at the time funds are borrowed. Principal and interest are paid ratably through payroll deductions over periods up to 60 months or as a lump sum for the outstanding loan balance. Loan terms range from one year to five years; however, terms may exceed five years for the purchase of a primary residence. As of June 30, 2025, participant loans have maturities through 2030 at interest rates ranging from 5.25% to 10.50%.

Payment of Benefits—Upon termination of employment, payments of benefits are made in accordance with the Plan’s vesting schedule. Upon termination, participants with vested benefits of \$5,000 or less receive a single sum cash payment of benefits from the trustee within a reasonable period following the date the participant terminates employment. Those participants with vested amounts exceeding \$5,000 have the option of receiving a single lump-sum distribution, partial lump-sum distributions of at least \$5,000, or installment distributions for required minimum distributions. Upon death, disability, or attaining normal retirement age, the benefit will equal 100% of the participant’s account balance and the same payment options are available to such participants.

Participants are also eligible to make hardship withdrawals from their deferred contributions in the event of certain financial hardships.

Forfeitures—When certain terminations of participation in the Plan occur, the nonvested portion of the participant’s account, as defined by the Plan, represents a forfeiture. Any such forfeitures are utilized to reduce current or future Company contributions and/or pay Plan administrative expenses. At June 30, 2025, all forfeitures were utilized and there was no remaining balance. At June 30, 2024, forfeited nonvested accounts totaled \$3,116. For the year ended June 30, 2025, Company matching contributions were reduced by \$18,119 from forfeited nonvested accounts.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting—The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates—The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets available for benefits and changes therein. Actual results could differ from those estimates.

Risks and Uncertainties—The Plan provides various investment options to its participants. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Material risks include global events, which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the value of participants’ account balances and the amounts reported in the financial statements.

Investment Valuation and Income Recognition—The Plan’s investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants—Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the Plan document.

Contributions—Employee contributions and Company matching contributions are recorded when withheld and earned, respectively.

Administrative Expenses—Administrative expenses of the Plan are paid by the Plan or the Plan sponsor, as provided in the Plan document. Participants pay administrative costs for loans, distributions, and qualified domestic relation orders.

All investment management and transaction fees directly related to the Plan investments are paid by the Plan. Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, investment management fees and operating expenses are reflected as a reduction of investment return for such investments.

The Plan has a revenue-sharing agreement whereby certain investment managers return a portion of the investment fees to the recordkeeper to offset the Plan's administrative expenses.

Payment of Benefits—Benefit payments to participants are recorded upon distribution. There were no participants who elected to withdraw from the Plan but had not yet been paid at June 30, 2025 and 2024.

Excess Contributions Payable—The Plan is required to return contributions received during the Plan year in excess of IRC limits. There were no excess contributions payable as of June 30, 2025 and 2024.

3. CERTIFIED INVESTMENT INFORMATION

The following is a summary of the information regarding the Plan as of June 30, 2025 and 2024, and for the year ended June 30, 2025, included in the Plan's financial statements and supplemental schedule that was prepared by or derived from investment information prepared by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, the trustee of the Plan, and furnished to the Plan administrator. The Plan administrator has obtained certifications from the trustee that such investment information is complete and accurate.

4. FAIR VALUE MEASUREMENT

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides a framework for measuring fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, as follows: Level 1, which refers to securities valued using unadjusted quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market, but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

Asset Valuation Techniques—Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds—Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Investment Trusts—The stable value fund is held in a collective trust fund, invests in conventional and synthetic guaranteed investment contracts (GICs) issued by life insurance companies, banks, and other financial institutions with excess cash invested in cash equivalents. The stable value fund and the other collective investment trusts are valued using NAV as a practical expedient to estimate fair value where NAV is based on the value of the underlying investment assets owned by the fund, minus its liabilities. This practical expedient is not used when it is determined to be probable that the account will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective investment trusts, the issuers reserve the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. There are currently no redemption restrictions or unfunded commitments to the collective investment trusts.

Pooled Separate Account—Valued by using the NAV of the fund at year-end as a practical expedient. The NAV is not a publicly quoted price in an active market and is determined based upon the fair value of the underlying investments. The pooled separate account consists of equity funds that invest in companies that compose small-, mid-, and large-cap index funds. The account can be redeemed daily and has no redemption restrictions. The Plan has no unfunded commitments to the pooled separate account.

5. RELATED-PARTY TRANSACTIONS AND EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Principal Life Insurance Company and Principal Global Investors Trust Company, both of which are associated with Principal Trust Company. Principal Trust Company is the trustee and Principal Life Insurance Company is the recordkeeper, as defined by the Plan. Therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid for investment management services were included as a reduction of the return earned on each fund. The Plan issues loans to participants, which are secured by the vested balances in the participants’ accounts.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, partial termination, or discontinuance of contributions to the Plan, participants would become 100% vested in their accounts.

7. FEDERAL INCOME TAX STATUS

The Internal Revenue Service determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust were designed in accordance with the applicable regulations of the IRC. The Company and Plan management believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC, and the Plan and related trust continue to be tax exempt. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

8. SUBSEQUENT EVENTS

Subsequent events were evaluated through January 21, 2026, the date the financial statements were available to be issued. No events occurred that require additional disclosure or adjustment to the Plan’s financial statements.
