Scope And Nature Of The ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of S.M. Wilson & Co. 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of March 14, 2025 and December 31, 2024, and the related statement of changes in net assets available for benefits for the period beginning January 1, 2025 and ended March 14, 2025 and for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of March 14, 2025 and December 31, 2024 and for the period beginning January 1, 2025 and ended March 14, 2025 and for the year ended December 31, 2024 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities For The Audit Of The Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Basis For Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities For The Audit Of The Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities Of Management For The Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

**For The Period Beginning January 1, 2025 And Ended March 14, 2025
And For The Year Ended December 31, 2024**

1. Description Of The Plan

The following brief description of the S.M. Wilson & Co. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan was adopted by the Board of Directors of S.M. Wilson & Co. (the Company) to provide participants an opportunity to defer portions of their earnings so as to provide supplementary retirement income and a measure of economic security. The Plan covers all employees of the Company and its wholly owned subsidiaries who had completed one month of service and are age 21 or older, except those included in collective bargaining units, leased employees, non-resident aliens, or commissioned sales personnel employed by Cambridge Wilson & Co., LLC. Employees became participants in the Plan the first day of the month following the completion of one month of service. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

On March 14, 2025, all Plan assets were merged to the FlexPEP(k) Pooled Employer 401(k) Plan. All plan assets were transferred out at this time.

Contributions

Contributions included participant salary deferrals and discretionary Company matching and profit sharing contributions. Employees were allowed to make contributions up to 100% of eligible compensation, not to exceed the maximum percentage allowable not to exceed the limits of the Internal Revenue Code (the IRC). Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants might also contribute amounts representing distributions from other qualified plans (rollover). For the period ended March 14, 2025 and year ended December 31, 2024, the Company elected to match 100% of participant contributions up to a maximum of 4% of employee eligible compensation for all participants who had attained six months of service and were actively employed at the end of the Plan year. Discretionary profit sharing contributions were allocated based on an amount as determined by the Company. The Company did not make a discretionary profit sharing contribution for the period ended March 14, 2025 or for the year ended December 31, 2024.

Vesting

Participants were immediately vested in the Plan for their salary deferral contributions, Company contributions, and any earnings thereon.

Participant Accounts

Each participant's account was credited with the participant's contributions, the Company's matching and profit sharing contributions, an allocation of Plan earnings, and administrative expenses. The allocation of earnings was determined by the earnings of the participant's investment selection based on each participant's account balance, as defined in the Plan Agreement. The benefit to which a participant was entitled was the benefit that can be provided from the participant's account.

Payment Of Benefits

Participants were eligible for normal retirement upon reaching age 65. Participants were eligible for early retirement upon attaining age 55. Participants who had reached a benefit event (e.g. death, disability, retirement, or termination) might elect to receive an amount equal to the vested value of their account in the form of a lump sum or substantially equal installments. Distributions are subject to the applicable provisions of the Plan Agreement.

In-Service Distributions

In service distributions may be made to a participant who has not separated from service provided the participant has attained the normal retirement age.

A participant might withdraw from the Plan a portion of their account in the event of undue financial hardship subject to Internal Revenue Service (IRS) regulations, which included payments for education expenses, medical or burial expenses, the purchase of a home or delinquent mortgage payments, and for the repair of damage to the participant's principal residence as defined by the Plan Document.

Notes Receivable From Participants

A participant may borrow from the Plan. In no event could the participant borrow more than the lesser of \$50,000 or 50% of the participants vested balance in the Plan, whichever was less. Notes were for a period not exceeding five years, unless used to acquire a personal residence for which the period was not to exceed thirty years.

Participant notes were secured by participants' account balances, and interest was charged at current lending rates. The notes were repaid through payroll withholdings, including principal and interest.

Administrative Expenses

Investment management fees were deducted on a quarterly basis from Plan investments. Generally, all administrative expenses were paid by the Plan or the Company.

Investment Options

Upon enrollment in the Plan, a participant might direct the investment of their account in various pooled separate accounts or in a guaranteed investment contract offered through American United Life Insurance Company (AUL or Custodian). The guaranteed investment contract, referred to as the AUL Fixed Account, was an interest-earning investment option backed by AUL's general account assets. AUL guaranteed that interest was credited at the higher of the rate guaranteed in the group annuity contract or the current rate periodically declared by AUL.

2. Summary Of Significant Accounting Policies

Basis Of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

Estimates And Assumptions

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Sponsor to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation And Income Recognition

Investment other than fully benefit-responsive investment contracts are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of fair value measurements.

Interest income and dividends are recorded as earned on the accrual basis. Purchases and sales of securities are recorded on a trade date basis.

Notes To Financial Statements *(Continued)*

Net change in fair value represents the difference between their aggregate fair value at year end and their values at the beginning of the year, and includes any realized gains and losses in shares that were bought and sold during the year.

Investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value is considered an appropriate determination of fair value for the AUL Fixed Account (the Fund), which is a fully benefit-responsive fund.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Contributions Receivable And Credit Loss Policy

Amounts due for contributions are stated at the amount that management expects to collect from outstanding balances less an allowance for expected credit losses. The expected credit losses amount reflects management's best estimate of amounts that will not be collected. This assessment considers historical experience, current conditions, and, when appropriate, reasonable and supportable forecasts.

The Company has concluded that no allowance for current expected credit losses was necessary for the period ended March 14, 2025 or year ended December 31, 2024.

Payment Of Benefits

Benefit payments are recorded when paid.

3. Certified Financial Information

The following is a summary of the Plan's asset information as of March 14, 2025 and December 31, 2024, and for the period beginning January 1, 2025 through March 14, 2025 and for the year ended December 31, 2024, included throughout the Plan's financial statements, that was prepared by or derived from information certified by American United Life Insurance Company (AUL or the Trustee), and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the Trustee that the information provided to the Plan Administrator related to the following information is complete and accurate.

Accordingly, as permitted by CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and supplemental schedule related to the following assets as of March 14, 2025 and December 31, 2024:

4. Investment Contract With Insurance Company

The Plan is invested in a guaranteed investment contract that is a fully benefit-responsive fund held with AUL. The contract is included in the financial statements at contract value as reported by AUL. Contract value is the relevant measure for the fully benefit-responsive investment contract because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on an agreed-upon schedule with the issuer and is reset on a semi-annual basis. The crediting interest rate was 2.41%, for the period ended March 14, 2025 and for the year ended December 31, 2024.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment from the Fund at contract value under all circumstances including the termination of the Plan. After transferring or withdrawing funds a participant must wait 90 days until they may transfer money into the Fund again.

5. Fair Value Measurements

The Plan utilizes an established framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the standards are described below:

- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value:

Pooled Separate Accounts

Valued at net asset value (NAV) of units held by the Plan at year end. The NAV, as provided by the insurance company, is used as a practical expedient to estimate fair value. The NAV is determined by dividing the net assets, at fair value, of the fund by the number of units outstanding on the day of valuation. Pooled separate accounts are comprised, primarily, of shares of registered investment companies held through sub-accounts of a separate account of an insurance company. The Plan has concluded that the NAV as adjusted (for mutual fund dividends, mutual fund splits and administrative maintenance charges and other items) and reported by the insurance company approximates fair value of the investments. The investments are redeemable at the adjusted NAV under agreements with the insurance company. However, it is possible that the redemptions rights may be restricted or eliminated in the future. Due to the nature of the investments, changes in the market conditions, liquidity requirements, and the economic environment may significantly affect the NAV of the registered investment companies and, consequently, the fair value of the Plan's investments. Pooled separate accounts are measured at fair value using the net asset value per share (or its equivalent) practical expedient and have not been categorized in the fair value hierarchy. All of the pooled separate accounts file an annual Form 5500 as a direct filing entity. There are no unfunded purchase commitments.

The method described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the valuation methodology used at March 14, 2025 or December 31, 2024.

6. Income Tax Status

The Plan has adopted a pre-approved plan with a cash or deferral arrangement. The sponsor of the pre-approved plan obtained its latest opinion letter dated January 15, 2021, in which the IRS stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan itself has not received a determination letter. The Plan has been amended since the latest opinion letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified and the related trust is tax-exempt. Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions. However, there are currently no audits for any tax periods in progress.

7. Transactions With Parties In Interest

The Plan's investments are managed by American United Life Insurance Company, the Custodian of the Plan. Therefore, these transactions qualify as party in interest transactions.

Certain participants had outstanding loans with the Plan as of December 31, 2024. These loans are considered party in interest transactions.
