NOTES TO FINANCIAL STATEMENTS

Note 1. Description of the Plan

The following description of Folium, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution profit sharing plan adopted by Folium, Inc. (hereinafter referred to as the Organization) covering all full-time employees of the Organization. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is administered by a committee comprised of management and the Board of Directors of Folium, Inc. (hereinafter referred to as Plan Administrator). The Plan Administrator has appointed the Chief Executive Officer and Treasurer as individual Trustees of the Plan.

Eligibility: Employees may begin to defer into the plan upon the attainment of 21 years of age. To be eligible for the employer matching and employer profit sharing contributions, participants must be age 21 and complete one year of service annually, defined as 1,000 hours. Additionally, participants must be employed on the last day of the year to receive the profit sharing contribution except in the event of death, disability or retirement.

Contributions: Each year, participants may contribute a portion of their annual compensation into either a regular 401(k) or a Roth 401(k) elective deferral account, as defined by the Plan. However, the total of all such participant contributions is subject to annual limits set by law. Participants who have attained age 50 before the end of the Plan year are eligible to make additional ("catch-up") contributions up to a prescribed annual limitation. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

In addition, the Organization may make a discretionary profit-sharing contribution to the Plan on an annual basis. Contributions are determined by the Organization's Board of Directors and are subject to certain limitations. The employer profit sharing contribution for the year ended June 30, 2025, was \$388,441.

The Organization also provides for a safe harbor match provision. All employees contributing to the Plan are generally required to receive a safe harbor match contribution up to a maximum match of 4% of compensation. The employer safe harbor match for the plan year ended June 30, 2025, was \$419,484.

The Plan also provides for a discretionary employer matching contribution in addition to the existing discretionary profit-sharing contribution. The Plan Sponsor may make matching contributions equal to a percentage of each participant's elective deferrals, at a rate determined by the Organization annually. All employees contributing to the plan are eligible for the discretionary employer matching contribution. For 2025, the employer made no discretionary employer matching contributions.

NOTES TO FINANCIAL STATEMENTS

Note 1. Description of the Plan (Continued)

Participant Accounts: Each participant's account is credited with the participant's contributions and allocations of (a) the Organization's contribution and (b) Plan earnings, less any administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant Investment Options: Participants may direct the investment of contributions into various investment options offered by the Plan. Participants may change their allocations at any time via the internet. Market valuations of the Plan's assets are generally made daily.

Vesting: Participants are immediately vested in their contributions and employer safe harbor contributions plus actual earnings thereon. Vesting in the Organization's discretionary profit sharing and matching contribution portion of their accounts, plus earnings thereon, is gradual based on years of credited service with 100% vesting after six years of credited service. A participant is fully vested in the event of death, disability, and normal retirement.

Payment of Benefits: Upon termination of service due to death, disability, retirement, or other reasons, a participant, or beneficiary, will receive a lump-sum amount equal to the value of the participant's vested account. In-service distributions of vested benefits are available to participants who have reached the age of 59½. In addition, the Plan allows for hardship distributions if certain criteria are met.

Participant Loans: Participants may borrow amounts from their fund accounts at a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years, unless the loan qualifies as a home loan and the home is used as the Participant's principal residence. Loans are secured by the vested balance in a participant's account. Interest rates on loans are based on the prime rate of interest, plus one percent. Loan repayments are based on substantially level amortization over the term of the loan and must generally be made by payroll deductions. Participants are limited to having two loans outstanding at one time.

Forfeited Accounts: Forfeitures represent unallocated employer contributions resulting from the termination of participants with less than fully vested benefits under the Plan. Forfeitures are used to reduce future employer contributions or defray administrative expenses of the Plan. At June 30, 2025 and 2024, forfeitures of participants' non-vested accounts totaled \$10,568 and \$26,053, respectively. During the plan year ended June 30, 2025, forfeited amounts of \$17,614 were used to offset administrative expenses, and \$20,918 was used to reduce the 2024 profit sharing contribution paid in 2025.

Note 2. Summary of Significant Accounting Policies

Accounting Method: The financial statements have been prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid for transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest. Delinquent participant loans are treated as distributions based upon the terms of the plan document pertaining to defaulted loans.

Payment of Benefits: Benefits are recorded when paid.

Administrative Expenses: Expenses incurred for administration of the Plan may be paid by the Plan if not paid by the Plan Sponsor.

Subsequent Events: In preparing these financial statements, the Plan Sponsor has evaluated events and transactions for potential recognition or disclosure through January 9, 2026, the date the financial statements were available to be issued.

Note 3. Information Certified by the Custodian

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at June 30, 2025 and 2024, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended June 30, 2025, was obtained by management and agreed to information certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company of America (together, the trustee of the Plan).

Note 4. Investments and Fair Value Measurements

The Plan measures on a recurring basis its investments at fair value in accordance with Financial Accounting Standards Board (FASB) codification topic *Fair Value Measurement*, which provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy are as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that are accessible to the Plan. These generally provide the most reliable evidence and are used to measure fair value whenever available.

- Level 2 Inputs to the valuation methodology include significant inputs, other than Level 1 inputs, which are observable either directly or indirectly for substantially the full term of the asset through corroboration with observable market data. Level 2 inputs include quoted prices for similar assets in active markets, quoted market prices in markets that are not active for identical or similar assets, and other observable inputs.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The inputs or methodology used for valuing investments are not an indication of the risk associated with investing in those securities.

The following are descriptions of valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at June 30, 2025 and 2024.

Registered Investment Companies: Shares of registered investment companies are valued at the daily closing price as reported by the funds. The funds held by the Plan are open-end mutual funds registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

Collective Investment Trust: The collective investment trust is valued based upon the net asset value (NAV) of units of the collective trust as reported to the Plan by the trust. Net asset value is used as a practical expedient to estimate fair value because it is unlikely that the trust would sell the investment for an amount different than the reported net asset value. The units of each share class of the collective trust are valued daily based on closing market prices of the underlying investments. The NAV per unit is computed by dividing the total assets of the trust, less its liabilities, by the total number of units outstanding as of the valuation date. Investment income earned is reinvested in the trust and included in the determination of unit values.

The preceding method may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain investments or financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Investment Contract with Insurance Company

The Plan holds a traditional investment contract with Empower Annuity Insurance Company of America (EIACA). More specifically, the Key Guaranteed Portfolio Fund is offered through a group annuity contract which provides a guaranteed rate of return that obligates EIACA to repay the principal and a specified rate of return to the Plan. The entire general account assets of Empower Annuity Insurance Company of America guarantee participant-initiated benefit payments.

This contract meets the fully benefit-responsive investment contract criteria; therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they are to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses.

The crediting interest rate is based on a formula agreed upon with the issuer but cannot be less than 0%. Such interest rates are reviewed on a quarterly basis for resetting. There are no reserves against contract value for credit risk of the contract issuer, surrender charges or otherwise. There are no reserves against the contract value for credit risk of the contract issue or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify from exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Additionally, upon termination of the group annuity contract, the Plan Sponsor may choose to receive a payout in a lump sum with a market value adjustment or receive the payout in a lump sum at book value, which the contract issuer may defer payment to a date no longer than twelve months.

Note 6. Related Party Transactions

Certain Plan investments in collective investment trusts are managed by Empower Trust Company, LLC. Empower Trust Company, LLC is the current Trustee of the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Fees incurred by the Plan for investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts.

Note 8. Tax Status

The Plan has adopted a Non-Standardized Pre-Approved Profit Sharing Plan with CODA sponsored by Smith Elliot Kearns and Company LLC. The Non-Standardized Pre-Approved Profit-Sharing Plan has received an opinion letter from the Internal Revenue Service dated June 30, 2020, that the Non-Standardized Pre-Approved Profit-Sharing Plan as then designed, was in compliance with the applicable provisions of the Internal Revenue Code (IRC). Although the Plan has been amended subsequently, the Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2025, there are no uncertain positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

Note 9. Risks and Uncertainties

The Plan provides for various investment options in various combinations of investment funds. Investment funds are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.
