We have performed an audit of the financial statements of Kwik Lok Corporation 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of March 31, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements (the financial statements).

Notes to Financial Statements

March 31, 2025 and 2024

(1) Description of the Plan

The following description of Kwik Lok Corporation 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

General

The Plan is a defined contribution plan, established August 1, 1990. The Plan has been amended and restated throughout the years to comply with tax legislation and was most recently amended April 1, 2023. The Plan covers substantially all employees of Kwik Lok Corporation, KLC Holdings, LTD, and Kwik Lok Corporation-Indiana (collectively referred to as the Company or Plan Sponsor), except for union employees, non-resident alien employees, interns, temporary employees, and certain part time employees as defined in the Plan provisions.

The Plan is administered by the Trustees and Advisory Committee who receive assistance from a retirement plan administration organization, which processes and maintains records of participant account activity.

All contributions made to the Plan are held in a trust fund. The Trustees are responsible for the safekeeping of the trust fund. The trust fund established by the Trustees is the funding medium used for the accumulation of assets from which benefits are distributed.

Eligibility

To be eligible to participate in the salary deferral portion of the Plan, an employee must attain age 21 and complete three consecutive months of employment. Additionally, if an employee does not complete three consecutive months of employment, they are still eligible for Plan participation after one year of service. Employees enter the Plan on the first day of the month coinciding with or next following the completion of the eligibility requirements.

Employees who meet the eligibility requirements above are also eligible for the employer safe harbor matching contributions. In order to receive employer discretionary matching contributions or employer discretionary profit-sharing contributions, the participant must attain age 21, complete one year of service, and be actively employed on the last day of the Plan year.

Contributions

Participants may contribute up to the maximum annual federal dollar limit to pre-tax, or Roth, salary deferrals as provided by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Plan includes a safe harbor matching contribution of 100% of the first 3% of salary deferrals, and then 50% of the next 2% of salary deferrals, for a maximum of 4% in matching contributions. The Company contributed \$396,754 and \$388,256 in safe harbor matching contributions for the years ended March 31, 2025 and 2024, respectively.

Notes to Financial Statements

March 31, 2025 and 2024

The Company may also elect to make discretionary matching contributions and discretionary profit-sharing contributions, of which there were none for the years ended March 31, 2025 and 2024.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions, employer contributions, and allocations of Plan earnings, as well as charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their salary deferrals, rollover contributions, and the Plan Sponsor's safe harbor contributions, plus actual earnings thereon. Vesting in other Plan Sponsor contributions is based on years of continuous service. A participant vests 20% after two years of service and earns an additional 20% for each year of service thereafter, becoming 100% vested in other Plan Sponsor contributions after six years of credited service.

Payment of Benefits

Participants are eligible to receive 100% of their vested account balance upon attaining normal retirement age of sixty-five years, death, disability, or break in service. Benefits are paid under various options, as defined by the Plan. Participants may also request in-service hardship distributions, distributions from rollover contribution accounts, and distributions of all other contributions upon reaching age 59 ½. If a participant terminated employment and the participant's account balance does not exceed \$5,000, the Plan Administrator will distribute the funds in a single lump-sum.

Investment Options

Participants direct the investment of their contributions and Plan Sponsor contributions into various investment options offered by the Plan.

Forfeited Accounts

Forfeitures, which are non-vested portions of participants' accounts at the point of termination from the Plan, will be placed in a suspense account and will be restored to the participant if rehired before five consecutive one-year breaks in vesting service have occurred. If the participant takes a distribution of their entire vested portion, the non-vested portion will be forfeited at that time. The non-vested amounts are used to reduce future employer contributions to the Plan or reduce administrative expenses. There were no forfeitures for the years ended March 31, 2025 and 2024.

Notes to Financial Statements

March 31, 2025 and 2024

Administrative Expenses

The Plan Sponsor pays substantially all administrative costs of the Plan. Investment fees and commissions are paid by the Plan. The Plan expenses are allocated based on participant account balances and those participants who elect to withdraw amounts from the Plan.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Concentration of Credit Risk

Financial instruments that potentially subject the Plan to concentrations of credit risk consist of the stable value collective trust fund, mutual funds, and money market accounts. Concentrations of credit risk are limited as the Plan maintains an investment portfolio that is diversified between various publicly-traded investments. Investments in money market accounts may, at times, exceed federally insured limits. The Plan Administrator believes there is no significant risk with respect to these accounts.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. The fair value of the investments is based on quoted market prices, if available. Otherwise, the fair values are determined by the issuers based on other investments with similar terms.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Assets and liabilities are classified based on the lowest level of input that is significant to the fair value measurement. The three levels of the fair value hierarchy are described as follows:

- Level 1 Inputs based upon quoted prices in active markets for identical assets.
- Level 2 Inputs other than quoted prices included within Level 1 that are observable for the asset, either directly or indirectly.
- Level 3 Inputs that are unobserved for the asset.

The following is a description of the valuation methodologies used by the Plan for assets measured at fair value. There have been no changes in the valuation methodologies used at March 31, 2025 and 2024.

Mutual Funds and Money Market Funds: The fair value is based on the daily closing prices reported on the exchange or listed market. The funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds are deemed to be actively traded and are considered Level 1 investments.

Stable Value Collective Trust Fund: Morley Stable Value Fund composed primarily of fully benefit-responsive investment contracts that are valued at the net asset value of units of the collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require twelve months' notification in order to ensure that securities liquidations will be carried out in an orderly manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Payment of Benefits

Benefits paid to participants are recorded when paid. As of March 31, 2025 and 2024, there were no distributions that had been requested but not yet paid.

(3) Investments

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's *Rules and Regulations for Reporting and Disclosure* under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's auditors not to perform any auditing procedures with respect to the investments that were certified by Charles Schwab Trust Bank (custodian) for the years ended March 31, 2025 and 2024, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirement of U.S. GAAP.

(4) Party-in-Interest Transactions

Charles Schwab Trust Bank is the custodian of the Plan, USI Consulting Group is the record keeper of the Plan, and Kibble & Prentice Holding Company is the third-party administrator (TPA) and investment advisor. Transactions with these service providers qualify as party-in-interest transactions. Total fees paid by the Plan for administration and investment advisory services amounted to \$32,413 and \$31,769 for the years ended March 31, 2025 and 2024, respectively. The Plan Sponsor also paid certain administrative expenses of the Plan. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

(5) Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions and terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions and all assets would be held, administered, and distributed pursuant to the Plan's terms and conditions.

(6) Tax Status

The Plan document is based on the adoption of a prototype plan, which the IRS has determined was designed in accordance with applicable sections of the Internal Revenue Code (IRC) by letter dated June 30, 2020. The Plan itself has not requested a determination letter. However, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC.

Notes to Financial Statements

March 31, 2025 and 2024

The Plan's income tax returns are subject to review and examination by federal and state authorities. The Plan is not aware of any activities that would jeopardize its tax-exempt status, nor is it aware of any activities that are subject to tax on unrelated business income or excise or other taxes. Plan amendments have had no impact on the Plan's tax status.

(7) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(8) Subsequent Events

The Plan has evaluated subsequent events through December 12, 2025, which is the date the financial statements were available to be issued.
