Scope and Nature of the ERISA Section 103(a)(3)(c) Audit of the 2025 Financial Statements

We have performed an audit of the accompanying financial statements of The Bement School Defined Contribution 403(b) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of June 30, 2025, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Notes to the Financial Statements

June 30, 2025 and 2024

NOTE 1 – DESCRIPTION OF PLAN

The following description of The Bement School Defined Contribution 403(b) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document and any amendments for a more complete description of the Plan's provisions.

General

The Plan is a participant-directed defined contribution 403(b) plan covering all eligible employees of The Bement School (the “School”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Contributions

Upon hire, eligible employees may contribute a percentage of their eligible compensation on a pre-tax basis and may also make Roth contributions. Participants that are age 50 or older, may elect to defer additional amounts (age-50 catch-up contribution) to the Plan. However, a participant’s total deferral in any taxable year may not exceed a dollar limit which is set by the Internal Revenue Service (“IRS”). Participants may also contribute amounts representing distributions from other eligible plans. Employees who generally work less than 20 hours per week are excluded from the Plan. The Plan includes an automatic enrollment provision set at 5%, with no automatic annual increase.

All eligible employees are eligible for a matching contribution to the Plan. The School will make a matching contribution of 100% of participant contributions.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, the School’s matching contributions and Plan earnings. Allocations are based on participant compensation or account balances, as defined.

Investment Options

A participant may direct the School to invest their contributions in a variety of investment options allowed by the Plan. All investments are participant directed.

Vesting

Participants are immediately vested in their contributions, matching contributions and actual earnings thereon.

Payment of Benefits

A participant is entitled to the full value of their account upon termination of employment, becoming disabled or death. There are various options available for distributions. Distributions may be made in a lump sum, partial payments, or installment payments. Involuntary cash outs will be made for participant accounts less than \$5,000. A participant may also take in-service distributions.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

The Plan's assets are invested with Teachers Insurance and Annuity Association of America/College Retirement Equities Fund ("TIAA-CREF"). The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Expenses

A portion of the expenses of maintaining the Plan are paid directly by the School and are excluded from these financial statements. Investment related expenses are included in net appreciation/depreciation of fair value in investments.

Subsequent Events

The Plan monitored and evaluated subsequent events for footnote disclosures or adjustments required in its financial statements for the year ended June 30, 2025 through January 9, 2026, the date on which financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the input to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs are used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 inputs for the periods presented and there were no changes in the methods used to measure fair value at June 30, 2025 and 2024.

NOTE 3 – FAIR VALUE MEASUREMENTS—(CONTINUED)

Level 1 Fair Value Measurements

The fair value of registered investment companies are based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. The funds must to publish their daily net asset value (NAV) and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Level 3 Fair Value Measurements

The non-benefit responsive fixed annuity contracts are reported at contract value which approximates fair value. The contract value of the TIAA Traditional Annuities equals the accumulated cash contributions and interest credited to the Plan’s contracts, and transfers, less any withdrawals and transfers. The TIAA Traditional Annuities are not available for sale or transfer on any securities exchange, accordingly, transactions in similar investment instruments are not observable.

The School has various processes and controls in place to ensure that fair value is reasonably estimated. The School sets the valuation policies for assets and is responsible for the determination of fair value. The School (1) compares price changes between periods to current market conditions, (2) compares trade prices of securities to fair value estimates, (3) compares prices from multiple pricing sources, and (4) performs ongoing due diligence to confirm that independent pricing services use market based parameters for valuation. Valuation approaches are reviewed on an ongoing basis and revised as necessary based on changing market conditions to ensure values represent a reasonable exit price.

The School assesses the fair value measurements applied by TIAA, including those for level 3 measurements, on a continuing basis. Periodically, the School, together with TIAA, determines if the current valuation techniques used in the fair value measurements are still appropriate.

The fixed annuity contracts are the TIAA Traditional Annuity contracts (TIAA Traditional Annuities) that are unallocated fixed annuity contracts that are fully and unconditionally guaranteed by TIAA. TIAA Traditional Annuities within liquid contracts are benefit responsive. TIAA Traditional Annuities within illiquid contracts are non-benefit responsive. TIAA Traditional Annuities provide a guarantee of principal, a guaranteed minimum rate of interest (generally 3%, but in some contracts between 1% and 3%) and the potential for additional interest if declared by TIAA. Additional interest, when declared, remains in effect for the “declaration year,” which begins each March 1. Additional interest is not guaranteed for future years. Contributions to a participant’s account purchases a guaranteed amount of lifetime annuity income. When a participant’s account in the TIAA Traditional Annuities are annuitized based on available options, the present value of the stream of payments is equal to the account balance. Certain contract types contain liquidity restrictions on the redemption of TIAA Traditional Annuities accumulations, which could impact the value realized upon exiting the contracts.

NOTE 4 – CERTIFIED INVESTMENTS

Information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including all investments held at June 30, 2025, and net appreciation in fair value of investments for the year ended June 30, 2025, was obtained by management and agreed to or derived from information certified as complete and accurate by TIAA-CREF, the custodian of the Plan.

NOTE 5 – RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

A portion of the costs and expenses incurred in connection with the operations of the Plan are paid by the School. TIAA-CREF is the custodian of the Plan's assets and manages the Plan's investments. Therefore, these transactions qualify as party in interest transactions and are denoted as such on the supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year).

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intention to do so, the School has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 7 – TAX STATUS

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code. The terms of the Plan have been prepared to conform with the sample language provided by the Internal Revenue Service in Revenue Procedure 2007 – 71. The Plan is required to operate in conformity with the Internal Revenue Code to maintain the tax-exempt status for plan participants under Section 403(b).

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investments. These investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
