Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Foxcroft School Tax-Deferred Annuity and Defined Contribution Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of April 1, 2025 and June 30, 2024, and the related statement of changes in net assets available for benefits for the period July 1, 2024 to April 1, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of April 1, 2025 and June 30, 2024, and for the period July 1, 2024 to April 1, 2025, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion on the Financial Statements

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the Financial Statements

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

Note 1. Plan Description

The following description of Foxcroft School Tax-Deferred Annuity and Defined Contribution Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Foxcroft School (the "School"). The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA). The Plan's management is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

In October 2024, the School entered into an agreement with the Virginia Association of Independent Schools Multiple Employer Plan ("VAIS MEP") to participate in the VAIS MEP effective April 1, 2025, at which time the Plan's assets were transferred to the VAIS MEP.

Contributions

Eligible full-time employees of the School, who are not students, are eligible to make contributions upon their date of hire. There are no minimum or maximum age requirements for general participation. The Plan also includes a School contribution based on years of service. For eligible employees who provide up to five years of service, the School contributes 6.5% of base salary to the participant's account. For eligible employees who provide six to ten years of service, the School contributes 8% of base salary to the participant's account. For employees who provide more than ten years of service, the School contributes 10% of base salary to the participant's account. Participants may also contribute amounts representing distributions from other qualified defined benefit and defined contribution plans (rollover contributions). The Plan offers various investment options for participants. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the School's contribution, allocated forfeitures, and Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow, from their fund accounts, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest commensurate with local prevailing rates. Loan terms range to a maximum of 5 years or up to 10 years for the purchase of a primary residence. Principal and interest are paid ratably through payroll deductions or an ACH agreement.

Notes to Financial Statements

Vesting

Participants are fully and immediately vested in their contributions plus actual earnings thereon. Vesting in the School's contribution portion of their accounts plus actual earnings thereon is based on years of credited service. A participant is credited with 20% each year after completing two years of service and is 100% vested after six years.

Payment of Benefits

On termination of service due to death, disability, retirement or resignation, a participant may elect to receive a lump sum payment, installment payments of substantially equal payments over a period they elect, a life annuity, or a joint and survivor annuity. Hardship withdrawals are permitted under the Plan.

Forfeited Accounts

Forfeitures are typically used to reduce employer contributions. During the period July 1, 2024 to March 31, 2025, forfeitures totaling \$57,714 were used to reduce employer contributions. As of April 1, 2025 and June 30, 2024, unapplied forfeited non-vested accounts totaled \$10,708 and \$8, respectively. The forfeited non-vested account balance was included in the Plan transfer to the VAIS MEP as of April 1, 2025.

Note 2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors, custodian, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded as earned on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Annuity Contracts

Annuity contracts held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the

Notes to Financial Statements

relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred. No allowance for credit losses has been recorded as of April 1, 2025 and June 30, 2024. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the School and are excluded from the financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net appreciation of fair value of investments.

Note 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in similar markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Notes to Financial Statements

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at April 1, 2025 and June 30, 2024.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts: Valued at the fair value of the fund's share of the underlying mutual funds. The NAV is based on the fair value of the underlying investments, which are traded at publicly quoted amounts.

Non benefit-responsive investment contract: Valued at the accumulated cash contributions and interest credited to the Plan's contract, less any withdrawals. Contract value approximated fair value because the crediting rates for the contract historically are representative of a risk adjusted market rate for this type of product.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain instruments could result in a different fair value measurement at the reporting date.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

Plan management evaluates the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the period July 1, 2024 to March 31, 2025, there were no significant transfers into or out of different levels.

Notes to Financial Statements

Purchases and issuances for the Plan’s level 3 asset for the period July 1, 2024 to March 31, 2025, prior to the Plan transfer to the VAIS MEP on April 1, 2025, were approximately \$147,000 and \$180,000, respectively.

The following table presents the Plan’s level 3 financial instruments, the valuation techniques used to measure the fair value of those financial instruments as of June 30, 2024, and the unobservable inputs and the ranges of values for those inputs:

Note 4. Annuity Contracts with TIAA

The Plan holds investments in two annuity contracts with Teachers Insurance and Annuity Association of America (TIAA). TIAA maintains the contributions in general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contracts are included in the financial statements at contract value as reported to the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The Plan holds one annuity contract that is fully benefit responsive and is reported at contract value. The other annuity contract is non-fully benefit responsive, but TIAA and plan management estimated that fair value approximates contract value. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than zero. Such interest rates are reviewed on a monthly basis for resetting.

The Plan’s ability to receive amounts due in accordance with investment contracts is dependent on the third-party issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligation may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (a) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events which would limit the Plan’s ability to transact at contract value with participants are probable of occurring. The annuity contracts do not permit the insurance companies to terminate the agreement prior to the scheduled maturity date.

Notes to Financial Statements

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract.

Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer

Note 5. Plan Termination

Although it has not expressed any intent to do so, the School has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their employer accounts. Effective April 1, 2025, all of the Plan's assets were transferred to the VAIS MEP.

Note 6. Information Certified and Provided by TIAA and CREF

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants at June 30, 2024, and net appreciation in fair value of the investments, interest earned on investment contracts, interest income on notes receivable from participants, and dividends for the period July 1, 2024 to March 31, 2025, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by TIAA and College Retirement Equities Fund (CREF), the custodian of the Plan.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Generally accepted accounting principles require the financial statements to present the fair value of investments. As described in Note 4, the Plan's investments in certain annuity contracts have been presented at contract value, which approximates fair value. This determination is based on the annuity contract issuer's credit ratings and yields being comparable to similar alternative investments. In subsequent periods, if market conditions change, such as the credit ratings or interest rate environment, the difference between contract value and fair value could become significant causing the financial statement to become materially misstated.

Notes to Financial Statements

Note 8. Related Party and Party-in-Interest Transactions

The Plan held investments in mutual funds that were managed by TIAA, the Plan custodian, and therefore qualify as party-in-interest transactions.

TIAA provides certain administrative services to the Plan pursuant to an agreement between the School and TIAA. TIAA receives revenue from investment service providers for services TIAA provides to the investment service providers. This revenue is used to offset certain amounts owed to TIAA for its administrative services to the Plan.

If the revenue received by TIAA from such investment service providers exceeds the amount owed under the agreement, TIAA remits the excess to the Plan's trust. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During the period July 1, 2024 to March 31, 2025, there was \$8,613 of excess deposited into the Plan. The Plan or Plan Sponsor may make a payment to TIAA for administrative expenses not covered by revenue sharing.

OneDigital Investment Advisors, investment advisor, and Yount, Hyde & Barbour, P.C., auditor, are service providers to the Plan and, therefore, transactions with these parties also qualify as party-in-interest transactions.

Note 9. Tax Status

The Plan has adopted a pre-approved plan sponsored by TIAA for its original plan documents and amendments. The pre-approved plan has received an opinion letter from the Internal Revenue Service (IRS) dated August 7, 2017, stating that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 10. Subsequent Events

In preparing these financial statements, the School has evaluated events and transactions for potential recognition or disclosure through January 12, 2026, the date the financial statements were available to be issued.
