### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of United Felts 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of United Felts 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### Opinion

**Note 1 – Plan Description**

---

The following description of United Felts 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

*General*

The Plan is a defined contribution plan covering substantially all employees of Applied Felts, Inc. who are age 18 or older. Ferratex Solutions, LLC and MaxLiner, LLC are also members of a controlled group who can participate in the Plan. Formed in January 2024, United Felts, Inc. was formed to consolidate Applied Felts, Inc.; Ferratex Solutions, LLC; and MaxLiner, LLC. Effective December 20, 2024, United Felts, Inc. assumed the role of Plan Sponsor (the “Company”) and the Plan changed its name from Applied Felts, Inc. 401(k) Profit-Sharing Plan and Trust to the United Felts 401(k) Plan. Upon the completion of six months of service, employees will enter the Plan on January 1 or July 1 coincident with or next following the date the eligibility requirements are met. Employees who are covered by a collective bargaining agreement for which retirement benefits have been the subject of good faith negotiations are not eligible to participate in the Plan. Leased employees are also ineligible for Plan participation. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

At the close of business on December 31, 2024, the assets of the Plan were transferred to Vortex Companies, LLC 401(k) Plan, effective January 1, 2025.

*Plan Administration*

The Company is the Plan Sponsor and Plan Administrator. The assets of the Plan are held by American United Life Insurance Company, the Custodian, as of December 31, 2024. Certain administrative functions are performed by employees of the Company, who receive no compensation from the Plan. The Plan may reimburse the Company for any administrative expenses incurred.

*Contributions*

Participants may contribute up to 100% of compensation as pre-tax and/or Roth deferrals, as defined in the Plan document, provided that in no event shall a participant elect to contribute more than the maximum allowed under Section 402(g) of the *Internal Revenue Code (IRC)*. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions in the amount of \$7,500 for the year ended December 31, 2024, into the Plan as a contribution subject to certain *IRC* limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contributions plans (rollover).

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions are invested in a designated balanced fund until changed by the participant. In addition, participants’ deferral rates are automatically increased annually by 1% up to 6% of eligible compensation unless they affirmatively elect not to increase their deferral rate.

The Plan includes a safe harbor matching contribution for all employees eligible to make elective deferrals to the Plan. The safe harbor matching contribution is equal to 100% of the participant’s contributions up to 1% of eligible compensation plus 50% of the participant’s contributions that exceed 1% but do not exceed 6% of eligible compensation.

The Company may make a discretionary profit-sharing contribution. Participants who are age 21 or older, have completed one year of service, and are employed on the last day of the Plan year are eligible to receive profit-sharing contributions, if any. There were no profit-sharing contributions for the year ended December 31, 2024.

*Participant Accounts*

Each participant's account is credited with the participant's contributions, the Company's matching or non-elective contributions, if any, an allocation of Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting*

Participants are immediately vested in their contributions plus actual earnings thereon. Participants also become fully vested upon death, disability, or normal retirement age. Participants become fully vested in safe harbor matching contributions after two years of service. Vesting in the Company's matching contribution and profit-sharing contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. The following vesting schedule applies to matching contributions:

*Participant-Directed Investments in Funds*

Each participant may direct how his/her account balance and future contributions are invested by choosing between the investment funds offered by the Plan. Any such investment direction remains effective until changed by a new election. The right to direct the investment continues at termination or retirement of the participant until the distribution of the entire account balance.

*Payment of Benefits*

On termination of service due to death, disability, retirement, or other reasons, a participant will be paid in the form of a lump-sum payment, installments, or partial withdrawals. In circumstances when a terminated participant has a vested account balance of less than \$1,000, the participant's vested account balance shall be distributed in cash. In the event of a distribution greater than \$1,000 but less than \$5,000, if the participant does not elect to have such distribution paid directly to an eligible retirement plan specified by the participant in a direct rollover or to receive the distribution directly, then the Plan Administrator will pay the distribution in a direct rollover to an individual retirement account designated by the Plan Administrator. Hardship and in-service distributions are also permitted from participant accounts, based on the terms of the Plan document. At December 31, 2024 and 2023, there were no benefit payments that had been requested but not yet paid.

*Forfeited Accounts*

Forfeitures are used to pay Plan expenses or to reduce amounts otherwise required to be contributed to the Plan. Total unallocated forfeiture account balances were \$5,362 and \$1,571 as of December 31, 2024 prior to transfer and 2023, respectively. For the year ended December 31, 2024, no forfeitures were used to reduce administrative fees.

**Note 2 – Significant Accounting Policies**

---

*Basis of Accounting*

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

*Use of Estimates*

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of income and expenses during the reporting period. Actual results could vary from the estimates that were used.

*Investment Valuation and Income Recognition*

Investments, other than the fully benefit-responsive investment contract, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion of fair value measurements. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts, because contract value is the amount Plan participants generally receive when executing transactions under terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan provides for various investment fund options. Investments are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

*Benefit Payments*

Benefits paid to participants are recorded when paid.

*Subsequent Events*

Subsequent events have been evaluated through January 21, 2026, the date the financial statements were available to be issued.

**Note 3 – Income Tax Status**

---

The Plan adopted a non-standardized, pre-approved plan sponsored by Ascensus LLC and has not requested a determination letter but rather has relied upon the Internal Revenue Service (IRS) opinion letter dated June 30, 2020 issued on the volume submitter plan stating the Plan and related trust are designed in accordance with applicable sections of the *IRC*. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 4 – Plan Termination**

---

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

The Plan was merged into Vortex Companies, LLC 401(k) Plan on December 31, 2024.

**Note 5 – Related Party and Party-in-Interest Transactions**

---

The Plan invests in investments managed by an affiliate of the John Hancock Life Insurance Company USA and American United Life Insurance Company, the Custodians of the Plan, and these transactions, therefore, qualify as party-in-interest transactions. **Note 7 – Fair Value Measurements**

The Plan’s investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

Guaranteed income accounts are investments that are made by the Plan in the guaranteed interest accounts of the issuer which are invested in the general assets of John Hancock who guarantee a fixed rate of interest. The guaranteed income accounts are not benefit-responsive; therefore, fair value is the relevant measurement attribute. Fair value is the amount the Plan participant would receive if they transfer or surrender their funds out of the guaranteed income account prior to maturity. The fair value is computed using a combination of the current interest rates based on remaining investment terms at the reporting date as well as the interest rate on the account. The guaranteed income accounts are classified within Level 3 of the valuation hierarchy.
