## INDEPENDENT AUDITORS' REPORT

### Opinion

We have audited the accompanying financial statements of IBEW Local No 13 Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of May 31, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

## **NOTE 1 – DESCRIPTION OF THE PLAN**

The following description of the IBEW Local No 13 Retirement Plan (Plan) provides only general information. Participants should refer to the Plan Agreement for a complete description of the Plan's provisions.

### **General**

The Plan is a participant-directed defined contribution retirement savings plan covering eligible employees (Participants) as provided by collective bargaining agreements (Agreements) between International Brotherhood of Electrical Workers Local 13 in Burlington, Iowa, (Union) and the Southeast Iowa division and Ottumwa division of the Iowa Chapter, National Electrical Contractors Association (Association). A trust, with Trustees designated by the Union and the Association, has been established to manage and operate the Plan. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was created on June 1, 1979.

### **Contributions**

Contributions are made for all Participants working under the provisions of the Agreement. The current employer contribution rate for inside wireman is \$8.90 per hour as of year-end. The actual rate paid is determined by the classification of the participant and the area they perform the work. Reciprocity contributions are received through reciprocity agreements with other jurisdictional areas.

### **Reciprocity**

Reciprocity contributions are collected by and remitted to the Plan on behalf of Participants who worked with contractors outside the previously defined Union area.

### **Participant Accounts**

Each Participant's account is adjusted for employer, employee, and reciprocity contributions, investment earnings (losses), expenses paid, and withdrawals in allocated accounts. Investment earnings (losses) and expenses are allocated to participants' accounts based on the participant's account balance in proportion to the total of all account balances. The benefit to which a Participant is entitled is the amount accumulated in the allocated account. Participants direct their funds into the Plan investments of their choice.

### **Vesting**

Participants are 100% vested in employer contributions, their own contributions, and earnings or losses on their accounts.

### **Payment of Benefits**

Provisions relating to payments of vested benefits are as follows: (1) Participants or their beneficiaries may, at date of retirement, disability or death, elect to receive one of several options, including a lump sum benefit or receive an annuity; or (2) an inactive participant may elect to receive their benefits at any time following the date of a termination from service.

### **NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### **Basis of Accounting**

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for details. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Employer Contributions Receivable**

Employer contributions are accrued as receivables and recorded as income in the month the work is performed. Contributions were deposited into a checking account designated solely for the Plan and are currently transferred to the fund's investment custodian, Empower Retirement, LLC.

#### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

#### **Payment of Benefits**

Benefits are recorded when paid. As of May 31, 2025, there were no amounts payable to participants who had requested withdrawals from the Plan.

#### **Expenses**

The Plan's expenses are paid by the Plan, as provided by the Plan document. Expenses incurred in connection with the general administration of the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits.

#### **Administrative Services**

Effective January 1, 2025, the Plan engaged Noridian Benefit Plan Administrators to perform third-party administrative services which include expenses incurred for office space, clerical staff, bookkeeping, and other administrative expenses necessary to administer the Plan. Previously, Wilson-McShane was engaged to perform these services.

#### **Date of Management's Review**

Subsequent events were evaluated through January 20, 2026, which is the date the financial statements were available to be issued.

### NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair values provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2            Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at May 31, 2025 and 2024.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

*Stable Value Fund:* Units of the fund are valued each day the New York Stock Exchange (NYSE) is open for trading and the NAV (Net Asset Value) per unit is calculated as of the close of each trading day. The NAV per unit is computed by dividing the total assets of the Fund, less its liabilities, by the total number of units outstanding at the time of such computation. Investment income earned is reinvested in the Fund and included in the determination of unit values.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### NOTE 4 – ROLLOVER CONTRIBUTIONS

There was \$101,904 rolled into the Plan during the year ended May 31, 2025, and is included in rollover contributions on the statement of changes in net assets available for benefits.

### NOTE 5 – PLAN TERMINATION

Although it has not expressed any intention to do so, the Plan Sponsors have the right under the Plan provisions to discontinue contributions at any time and to terminate the Plan. In the event of termination of the Plan, the net assets will be distributed according to the Plan document and as required by ERISA. After satisfaction of all liabilities under the Plan, the participants' vested account balances would be distributed to them.

### NOTE 6 – TAX STATUS

The Internal Revenue Service has informed the Plan Sponsors by a letter dated July 13, 2015, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan sponsor believes that the Plan is currently designed and operated in compliance with applicable requirements of the Internal Revenue Code and the Plan and related trust continue to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan has adopted guidance on accounting for uncertainty in income taxes issued by the Financial Accounting Standards Board. Management of the Plan believes that the plan has taken no uncertain tax positions that require adjustment to the financial statements in order to comply with the provisions of this guidance. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### NOTE 7 – RESTRICTED NET ASSETS AVAILABLE FOR BENEFITS

Each participant in the plan has their own account balance where contributions made by employers on their behalf are added to their account. The investments of the plan are held by Empower Retirement, LLC so that each participant can self-direct his or her own investments. Benefit payments are subtracted from the participant's account balances. A summary of the Net Assets available for benefits as of May 31, 2025 and 2024 is as follows:

### **NOTE 7 – RESTRICTED NET ASSETS AVAILABLE FOR BENEFITS, Continued**

Assets identified as participants account balances are assets that are specifically allocated to participants.

The Plan's unallocated net assets – crediting account can be used to pay USERRA benefits or as "make whole" contributions for participants whose employers are unable to pay.

The Plan's unallocated net assets – administrative can be used to pay plan expenses.

### **NOTE 8 – RISKS AND UNCERTANTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

At May 31, 2025, the book and bank balance of deposits in a local bank was \$182,216, of which all was insured by the Federal Depository Insurance Company ("FDIC").
