Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Pink Jeep Tours 401(k) Plan's internal control. Accordingly, no such opinion is expressed.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Pink Jeep Tours 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(c) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Note 1. Description of the Plan

The following description of Pink Jeep Tours 401(k) Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan for the benefit of its employees who have worked at least three months. Prior to January 1, 2022, the Plan was sponsored by Pink Jeep Tours, Inc. Effective January 1, 2022, the plan sponsor's name changed to Pink Jeep Tours, LLC (Sponsor). The Plan has no minimum age requirements. Related employers who also participate in the Plan include Pink Adventure Tours, LLC, and as of January 1, 2019, Pink Jeep Tours Nevada, Inc., (Pink Jeep Tours Nevada, LLC, effective January 1, 2022) and as of March 1, 2019, Pink Adventure Tours Tennessee, LLC (removed as of January 1, 2022), and as of January 1, 2020, Herschend Adventure Holdings, LLC and Adventure Software, LLC, and as of November 1, 2021, Pink Adventures Tours, LLC. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

State Street Bank and Trust Company is the trustee and Transamerica Retirement Solutions, LLC (Transamerica) serves as the plan recordkeeper. Effective January 1, 2022, the Plan was restated and adopted a nonstandardized 401(k) profit sharing plan sponsored by Transamerica to incorporate the employer contribution amendments adopted during 2021.

Plan Transfers

Effective April 1, 2025, the Plan merged into the Herschend Family Entertainment Profit Sharing and 401(k) Plan. The provisions of the Herschend Family Entertainment Profit Sharing and 401(k) Plan survived in regard to vesting and employer matching.

Contributions

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have a percentage, up to 60% effective January 1, 2025, and up to 86% prior to January 1, 2025, of eligible compensation contributed as pretax 401(k) or Roth contributions. All eligible employees are automatically enrolled in the Plan at a deferral rate equal to 3.5% effective January 1, 2025, and equal to 4% prior to January 1, 2025, of their eligible compensation on the first day of the month after eligibility requirements are met, unless the participant elects not to participate. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Employee rollover contributions are also permitted.

Employer contributions for the Plan are made in accordance with the plan agreement and are at the discretion of the employer. During 2024, the Sponsor matched 50% of each participant's salary deferral contribution up to the first 4% of the participant's eligible compensation (Match #1).

Effective January 1, 2021, the Plan was amended to add a second discretionary employer matching contribution for participants who are employed on the last day of the plan year. During 2024, there were no second discretionary employer matching contributions (Match #2).

Effective January 1, 2025, the Plan was amended to remove the discretionary employer Match #1 and Match #2 contributions previously mentioned.

The Sponsor may elect to make discretionary contributions to all employees as deemed by the Sponsor's management. For participants who are employed on the last day of the Plan year and credited with 1,000 hours of service, the Sponsor made no contributions for the Plan period ended April 1, 2025 and the year ended December 31, 2024.

Contributions are subject to certain limitations.

Participant Investment Account Options

Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily. Or they may individually direct their investments as they choose.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Sponsor's contributions, and plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions and rollover contributions, plus earnings thereon. Effective January 1, 2025, vesting in the Plan Sponsor's contribution portion of their accounts plus earnings is based on years of continuous service. A participant becomes fully vested after three years of continuous service.

Prior plan provision of any Sponsor contributions, Match #1 and Match #2, made prior to January 1, 2025, for participants with less than three years of service, vest based upon the following vesting schedule:

Prior plan provision of any Sponsor contributions, Match #1 and Match #2, made prior to January 1, 2025, for terminated employees, vest based upon the following vesting schedule:

Notwithstanding the above, a participant is fully vested upon reaching normal retirement age of 65, death, or permanent disability.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at 2% above the prime rate, as defined. Principal and interest is paid ratably through biweekly payroll deductions.

Effective January 1, 2025, Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Effective April 1, 2025, \$194,841 of notes receivable from participants was transferred to the Herschend Family Entertainment Profit Sharing and 401(k) Plan as part of the plan merger.

Payment of Benefits

Participants can request distributions upon the attainment of normal retirement age (65) or termination of employment equal to the value of the vested interest in their account. Benefits are paid in a lump-sum, installments, or partial withdrawals. The Plan allows for hardship and in-service distributions, subject to plan provisions.

Forfeited Accounts

Forfeited accounts are used to pay plan expenses or reduce future employer contributions. Forfeited accounts as of April 1, 2025 and December 31, 2024, totaled \$0 and \$1,514, respectively. For the period ended April 1, 2025 and the year ended December 31, 2024, employer contributions were reduced by \$0 and \$5,421, respectively, from forfeited accounts. For the period ended April 1, 2025 and the year ended December 31, 2024, plan expenses were reduced by \$0 and \$9,516, respectively, from forfeited accounts. On April 1, 2025, \$7,304 of forfeitures was transferred to the Herschend Family Entertainment Profit Sharing and 401(k) Plan as part of the plan merger.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustees determine the Plan's valuation policies utilizing information provided by the investment advisers. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Sponsor or the Plan, at the Sponsor's discretion.

The Plan has a nonallocated expense budget account held in an interest-bearing account. The purpose of this account is to pay necessary and reasonable plan related expenses in accordance with the Department of Labor's guidance. The Sponsor is responsible for determining what expenses the third-party administrator will reimburse from the account. All funds utilized from this account are treated as administrative expenses on the statements of changes in net assets available for benefits. Additions to the expense budget account were \$1,053 and \$3,949 for the period ended April 1, 2025 and the year ended December 31, 2024, respectively. Expense budget account funds utilized amounted to \$8,860 and \$2,866 for the period ended April 1, 2025 and the year ended December 31, 2024 respectively. The expense budget account's balance at April 1, 2025 and December 31, 2024, was \$0 and \$7,752, respectively. On April 1, 2025, \$8,081 of the expense budget account was transferred to the Herschend Family Entertainment Profit Sharing and 401(k) Plan as part of the plan merger.

Note 3. Certification of Plan Trustee

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, State Street Bank and Trust Company, a qualified institution, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of April 1, 2025 and December 31, 2024.
- Investment income (loss) and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the period January 1, 2025 through April 1, 2025 and the year ended December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities.
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3** Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques through April 1, 2025, the date the Plan merged. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. Level 1 securities include common stocks within the self-directed brokerage accounts, which are valued at the closing price reported on the active market on which the individual securities are traded, mutual funds, which are valued at the net asset value (NAV) of shares held by the Plan at year-end, and cash reserve accounts, which are valued at fair value as provided by the custodian. If quoted market prices are not available, then fair values are estimated by using pricing models, quoted prices of securities with similar characteristics, or discounted cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. The Plan held no Level 2 or 3 investments at December 31, 2024.

Note 5. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The plan incurs expenses related to general administration and recordkeeping. The Plan paid direct fees of \$3,855 and \$14,283 to Transamerica during 2025 and 2024, respectively.

The Sponsor pays certain other administrative fees related to the Plan's operations and provides certain administrative services at no cost to the Plan.

Note 6. Plan Termination

Although it has not expressed an intention to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in all accounts.

As described in *Note 1*, effective April 1, 2025 the Plan merged into the Herschend Family Entertainment Profit Sharing and 401(k) Plan. The plan merger does not constitute a plan termination and participants will continue to receive benefits in the merged plan.

Note 7. Tax Status

Effective January 1, 2022, the Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust document sponsored by Transamerica Retirement Solutions, LLC. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9. Subsequent Events

Subsequent events have been evaluated through January 23, 2026, which is the date the financial statements were available to be issued.
