### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Lincoln Community Health Center, Inc. Internal Revenue Code Section 403(b) Tax Deferred Annuity Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of June 30, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Lincoln Community Health Center, Inc. Internal Revenue Code Section 403(b) Tax Deferred Annuity Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of June 30, 2025 and 2024, and for the year ended June 30, 2025, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### Opinion

### **Basis for Opinion**

**NOTE A – Description of Plan**

The following description of the Lincoln Community Health Center, Inc. Internal Revenue Code Section 403(b) Tax Deferred Annuity Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General.** The Plan is a defined contribution plan established by Lincoln Community Health Center (the “Organization”) on August 1, 1971 and was amended and restated effective as of September 1, 2008, December 20, 2010, May 1, 2012, and January 1, 2013 to provide employees with a systematic means of savings and investing for retirement. All permissible employees of the Organization, as defined in accordance with the universal availability standards are eligible to enroll on their date of hire. Deferrals begin on the first day of enrollment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Administration.** The Plan is administered by the Organization, which serves without compensation. The Plan Administrator has the overall responsibility and authority as the named fiduciary to manage and control the operations and administration of the Plan and may designate one or more individuals to perform those responsibilities.

**Contributions.** Each year, participants may contribute up to the lesser of 100 percent of their compensation, or the defined contribution dollar limitation by means of payroll deduction, subject to certain discrimination tests prescribed by the Internal Revenue Code and other limitations specified in the Plan. The Organization matches 50 percent of the employee contributions, up to six percent of compensation.

**Expenses.** The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party administrators, the trustee, and actuary. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses. Expenses that are paid by the Company are excluded from these financial statements.

**Participant Accounts.** Each participant’s account is credited with the participant’s contribution, allocations of the Organization’s matching contributions, Plan earnings, and any discretionary contributions. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Investment Options.** Upon enrollment in the Plan, participants may direct the investment of their contributions and the Organization’s contributions into various investment contracts and annuity options offered by the Plan.

**Vesting.** Participants are immediately vested in their voluntary contributions and actual earnings thereon. Organization contributions plus actual earnings thereon vest at 25 percent after two years of vesting service, 50 percent after three years, 75 percent after four years, and are fully vested after a participant completes five years of vesting service. If a participant is an employee on or after the earliest date of retirement age or the date he or she becomes totally and permanently disabled, the nonvested portion of his or her account becomes fully vested at that time.

**Notes Receivable from Participants.** Participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum equal to the lesser of half of their vested account balance or \$50,000. The number of outstanding loans is limited to one. Loan terms do not exceed five years. The loans are secured by the balance in the participant’s account and bear interest from 4.25 percent to 9.50 percent within the year. Principal and interest are paid ratably through payroll deductions. All loans must generally be paid within five years.

**Participant Investment Rollovers.** Participants are allowed to transfer or rollover funds into the Plan from other qualified or 403(b) plans.

**Payment of Benefits.** Upon retirement, disability or death, a participant or beneficiary receives the entire amount credited to the participant's account in either a lump sum or, at the participant's election, in annual installments. Upon termination, other than by retirement, disability, or death, a participant may elect to receive a distribution of any part of his vested account after he has a severance from employment.

**Forfeited Accounts.** Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the plan. Such forfeitures can be applied to reduce employer contributions or Plan administrative expenses otherwise payable by the Organization. For the year ended June 30, 2025, forfeited nonvested accounts totaled \$0. For the year ended June 30, 2025, contributions were reduced by \$0 of forfeited nonvested accounts.

**NOTE B – Summary of Accounting Policies**

The following are the significant accounting policies followed by the Plan:

**Basis of Accounting.** The financial statements of the Plan are prepared on the modified cash basis of accounting, which is a comprehensive basis of accounting other than generally accepted accounting principles. Modified cash basis of accounting is defined as cash basis accounting modified with respect to contributions. Employer and employee contributions and the related contribution receivables are accounted for based on the payroll check dates within the Plan year. Contribution receivables are recorded if Plan contributions from check dates occurring within the Plan year were credited to the Plan after the year end date.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

**Use of Estimates.** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Notes Receivable from Participants.** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expenses when they are incurred. No allowance for credit losses has been recorded as of June 30, 2025 or 2024.

**Investment Valuation and Income Recognition.** Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits.** Benefit payments to participants are recorded when paid.

**Expenses.** Administrative costs related to the administration of the Plan are paid by either the Plan or Organization. Certain administrative functions are performed by employees of the Organization. No such employee receives compensation from the Plan.

**Subsequent Events.** The Plan has evaluated subsequent events through September 5, 2025, the date the financial statements were available to be issued.

**NOTE C – Investments**

Information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including all investments and notes receivable from participants held at June 30, 2025 and 2024, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended June 30, 2025, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Character Guarantee and Trust Company d/b/a Principal Trust Company (Principal Trust Company), the trustee of the Plan.

**NOTE D – Fair Value Measurements**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include –

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2025 and 2024.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE E – Guaranteed Investment Contract with Principal Life Insurance Company**

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company (Principal) totaling \$2,826,241 and \$2,668,592 at June 30, 2025 and 2024, respectively. Principal maintains the contributions in a general account. The account is credited with actual earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest that is guaranteed to the Plan. The credit rating is based on a formula established by the contract issuer but may not be less than 1.80 percent. The credit rating is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measurement for fully benefit-responsive investment contracts because this amount received participants if they were to initiate permitted transactions under the Plan. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amount dues is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the Plan's ability to transact at contract value with Principal. Such events include the following: (1) amendments to the Plan documents (including the complete or partial Plan termination or merger with another Plan), (2) changes to Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

**NOTE F – Related-Party Transactions and Party-in-Interest Transactions**

Certain Plan investments are investment contracts and shares of mutual funds managed by Principal Investment Company. Principal Investment Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the trustee for the year ended June 30, 2025 equaled to \$53,727.

**NOTE G – Plan Termination**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

**NOTE H – Tax Status**

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (Code). The terms of the Plan have been prepared to conform to the sample language provided by the Internal Revenue Service (IRS) in Revenue Procedure 2007-71. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for Plan participants under Section 403(b).

**NOTE I – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
