Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Springfield, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of September 30, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended September 30, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Springfield, Inc. 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of September 30, 2025 and 2024, and for the year ended September 30, 2025, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

1. Description of the Plan

The following brief description of the Springfield, Inc. 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more comprehensive description of the Plan's provisions.

General

The Plan is a defined contribution plan that covers all employees of Springfield, Inc. (the "Company") who have six months of service and are age twenty-one or older. Entry into the Plan occurs semi-annually on the first day of the Plan year and the first day of the seventh month of the Plan year following the date an employee meets the eligibility requirement. The Plan is subject to the provisions of the Employee Retirement Security Act of 1974 (ERISA).

SECURE Act Provisions

The U.S. Congress enacted the SECURE Act which includes provisions that impact benefit plans. Provisions of the SECURE Act are operationally available at this time but Plan documents will not require formal amendment until 2026. SECURE increased the RMD age from 70 ½ to 73. SECURE also has the option for long-term part-time employees to participate and the option for in service withdrawals for childbirth and adoption expense. To comply with the provisions of SECURE, effective January 1, 2025, a Roth contribution option to was made available to participants. The Plan is not currently operating according to any of the other optional provisions included in SECURE. The Plan will be formally amended before the required 2026 deadline.

Participation and Eligibility

Employees are eligible to participate in the Plan once they have completed six consecutive months of service, with at least one hour worked in each month, and are at least 21 years old.

Contributions

Each year participants may contribute up to 100 percent of pretax annual compensation, subject to limits established by the Internal Revenue Service. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). There were rollover contributions of \$26,371 for the Plan year ended September 30, 2025. The Plan sponsor adopted a safe harbor nonelective contribution of 3 percent of a participant's compensation. The Plan sponsor may make discretionary matching contributions of up to 6 percent of a participant's compensation. There were no matching contributions made for the year ended September 30, 2025.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (1) the Company's contribution, and (2) Plan earnings. Allocations are based on participant earnings or account balances, as defined. Participants are charged with an allocation of administrative expenses as defined in the Plan. The benefit to which a participant is entitled

is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their elective deferrals, their rollover contributions and the Company's safe harbor contributions (3%) plus actual earnings thereon.

Beyond the safe harbor contribution, the Company may make additional discretionary contributions each year. Vesting in these discretionary contribution portions of the participant's accounts plus actual earnings thereon occurs at the rate of 20% for each year of service after one year of service. A participant is 100 percent vested after six years of credited service.

Vesting of 100 percent of a participant's employer contributions and earnings thereon also occurs upon death, disability of the participant or attainment of age 65 (normal retirement).

Payment of Benefits

Upon termination of service due to retirement, death, disability, or separation from service, participants may receive benefits in a lump sum or installments, in accordance with the Plan. Also, upon retirement, disability, or separation from service, participants may elect to continue their account as permitted by the Internal Revenue Code. Participants are also allowed to make hardship withdrawals in certain circumstances.

Forfeitures

Forfeitures may be used to pay plan expenses or reduce employer matching contributions. At September 30, 2025 and 2024, there was a balance of forfeited non-vested accounts of approximately \$761 and \$1,422, respectively. In the year ended September 30, 2025, forfeitures were used to pay plan expenses of approximately \$700.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

Management uses estimates and assumptions in preparing the financial statements. Those estimates and assumptions affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities and the reported additions and deductions. Actual results could differ from those estimates.

Investment Valuation And Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustee determines the Plan's valuation policies. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through the date of the auditor's report, which is the date the financial statements were available to be issued.

3. Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at September 30, 2025 and 2024 and dividends and net appreciation in fair value of investments for the year ended September 30, 2025, was obtained or derived from information supplied by the plan administrator and certified as complete and accurate by both Empower Annuity Insurance Company of America and Empower Trust Company LLC.

4. Fair Value Measurements

ASC Topic 820 establishes a framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2025 and 2024.

Registered Investment Companies: Valued at the daily closing price as reported by the fund. Registered Investment Companies held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The Registered Investment Companies held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Group Annuity Contract with Empower Annuity Insurance Company of America

The Plan is invested in the Empower Annuity Insurance Company of America Fixed Account fund, which is a traditional fully benefit responsive guaranteed investment contract that is fully guaranteed by the general account assets of Empower Annuity Insurance Company of America totaling \$1,228,093 and \$865,511 as of September 30, 2025 and 2024, respectively. The fund maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The fund is contractually obligated to repay the principal and a specified interest rate that is declared at the beginning of each calendar quarter. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the fund, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The average yield for 2025 was 2.20%.

The Plan's ability to receive amounts due is dependent on the fund's ability to meet its financial obligations. The fund's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan, (2) changes to the Plan's prohibition on competing investment options, (3) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, (5) premature termination of the contract.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that would also limit the ability of the plan to transact at contract value with the participants.

6. Related-Party and Party-in-Interest Transactions

Empower Trust Company LLC is the custodian, trustee and record keeper as defined by the Plan. The Plan is invested in a group annuity contract managed by Empower Annuity Insurance Company of America, who is an affiliate of Empower Trust Company LLC. Transactions with Empower Trust Company LLC and Empower Annuity Insurance Company of America qualify as party-in-interest transactions. Empower Trust Company LLC receives revenue from mutual fund service providers that is credited back to the Plan. This revenue is used to offset plan expenses.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

8. Tax Status

The Plan has adopted a volume submitter profit-sharing plan sponsored by Great-West Life & Annuity Insurance Company. The volume submitter plan received a favorable opinion letter effective June 2020 from the Internal Revenue Service ("IRS") regarding the volume submitter plan's qualified status. Therefore, no provision for income tax has been included in the Plan's financial statements.

Management has determined that the Plan does not have any uncertain tax positions and associated unrecognized benefits that materially impact the financial statements and related disclosures.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risk such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
