There have been no initial selection of accounting policies and no changes in significant accounting policies or their application during 2024. No matters have come to our attention that would require us, under professional standards, to inform you about (1) the methods used to account for significant unusual transactions and (2) the effect of significant accounting policies in controversial or emerging areas for which there is a lack of authoritative guidance or consensus.

Significant Accounting Estimates and Related Disclosures

Most of the fair value estimates were based upon quoted prices in the open market. The estimate for the general account for the plan was based upon reliance on the custodian's certification statement as to the completeness and accuracy of accounting information, including the fair value of investments for the plan.

Financial Statement Disclosures

The financial statement disclosures are neutral, consistent, and clear.

Form 5500 Procedures

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

NOTES TO FINANCIAL STATEMENTS

1. Plan Description and Summary of Significant Accounting Policies

The following provides general information about the BekaertDeslee USA Inc. 401(k) Retirement Plan (the Plan). Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

General Information

The Plan was established on September 1, 2015 and is a defined contribution 401(k) plan. The plan covers the eligible employees of the adopting employers, BekaertDeslee USA Inc. and Progressive Products, Inc. (now BD Solutions, Inc.) (collectively "the Companies" or "the Employers"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Most recently, the Plan's operations for the 2020 plan year were amended to adopt the provisions of the Coronavirus Aid, Relief, and Economic Security (CARES) Act.

The Companies develop, manufacture and sell innovative, high-quality products throughout the world that vary from process and conveyor belts to sailcloth and mattress ticking. The Companies' business units hold prominent positions worldwide. The stock of most of the companies in the Plan was distributed to the foreign business units in 2012. Therefore, only Bekaert Textiles USA, Inc. remains under the ownership of Gamma Holding USA, Inc., a wholly owned subsidiary of Gamma Holding N.V., (The Netherlands).

Basis of Accounting

The Financial statements of the Plan are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Administration

The Trustee of the Plan's assets is Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal Trust Company, the Trustee). The Plan is administrated by the Treasurer of Bekaert Textiles USA, Inc. together with an advisory committee (the Committee) made up of members of key business units of the Employers. These members generally include a cross-section of those representing each business unit from the employers who have adopted the plan. The Committee has the authority to control the operation, management, and administration of the Plan. Allowable administrative expenses (as defined by federal regulations) of the Plan are paid out of Plan assets.

The Company pays certain administrative expenses on behalf of the Plan. Administrative expenses paid by the Plan during the years ended December 31, 2024 and 2023 were for asset fees and administrative fees. Administrative expenses paid by the Plan for the years ended December 31, 2024 and 2023 were \$78,888 and \$72,174, respectively. These expenses are included on the statement of changes in net assets available for benefits.

1. Plan Description and Summary of Significant Accounting Policies (Continued)

Participation

All employees other than nonresident aliens, collectively bargained employees, leased employees and certain other classes of employees (as defined in the Plan document) over age 21 are eligible to make salary deferral contributions to the Plan immediately upon employment. All eligible employees (as defined above) over age 21, as defined by the Plan, are entitled to participate in all other aspects of the Plan. Once employees are admitted into the Plan, they remain in the Plan until termination of employment and/or withdrawal of their individual account balance from the Plan. An employee's initial eligibility carries over to when the employee is rehired, if applicable.

Contributions

In accordance with the Plan, participants may elect to contribute from 1% to 100% of their annual eligible compensation on a pretax basis. Absent an election otherwise, eligible employees are set up to make automatic contributions of 3% of their eligible compensation in the form of salary deferrals. Employees may also make after-tax (Roth) contributions to the Plan. For each plan year, the Employers are required to contribute a matching contribution of 100% of contributions that are not over 1% of compensation plus 50% of contributions which are over 1% but are not over 6% of compensation as specified by the Plan.

In addition, contributions by or on behalf of a participant for a plan year may not exceed certain limits which are imposed by the Internal Revenue Code (IRC) and which are set forth in the Plan.

Vesting

A participant shall at all times have a fully vested, nonforfeitable interest in his or her contributions. A participant becomes vested in employer contributions in accordance with the vesting schedules specified in the Plan document for each employer. Employees who were participants in their employer's plan prior to merging with the BekaertDeslee USA Inc. 401(k) Retirement Plan or its predecessor plan are 100% vested at all times in all accounts. All other plan participants are subject to a two year cliff vesting schedule (0% vested until two years of service is attained, at which time the participant becomes 100% vested) on the employer match contribution portion of their accounts. All other plan participants are subject to a three year cliff vesting schedule (0% vested until three years of service is attained, at which time the participant becomes 100% vested) on the employer discretionary contribution portion of their accounts.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

1. Plan Description and Summary of Significant Accounting Policies (Continued)

Vesting (continued)

A participant is 100% vested upon attaining normal retirement age (age 62 for the Plan) or early retirement age (age 55 and four years of service). A participant is also 100% vested in the event of disability (as defined by the Plan document) or death.

Forfeited Accounts

The nonvested portion of a terminated participant's account is forfeited upon distribution of the vested portion or after a five-year break in service. Such forfeitures are used to reduce future employer contributions or to pay plan expenses. For the years ended December 31, 2024 and 2023, forfeited non-vested accounts totaled \$19,620 and \$26,870, respectively. During the years ended December 31, 2024 and 2023, forfeitures in the amount of \$28,336 and \$19,798, respectively, were used to reduce employer contributions and pay plan expenses. As of December 31, 2024 the Plan did not a forfeited non-vested account balance. As of December 31, 2023, forfeited non-vested amounts totaling \$8,688 were available to reduce future employer match contributions or expenses of the Plan.

Notes Receivable from Participants

Within the limits of the IRC, a loan may be requested electronically by a participant. The minimum loan amount is \$1,000. The maximum loan amount may not exceed the lesser of (1) the amount which could be loaned tax-free under the applicable provisions of the IRC or (2) 50% of the loan participant's nonforfeitable account balance, reduced by the outstanding principal balance of any existing loan.

The loan repayment period is generally set at a maximum of 60 months. For loans used to purchase the participant's principal place of residence, the loan repayment period is set at a maximum of 180 months. The rate at which loans are issued plan-wide is the Wall Street Journal prime rate at the time of the loan plus 1.00%. No exceptions to this rate (by employer) are allowed. Refinancing to secure a more favorable rate during the scheduled amortization of the loan is not allowed.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. Interest rates on loans outstanding as of December 31, 2024 ranged from 4.25% to 9.50%. Principal and interest is paid ratably through payroll deductions.

1. Plan Description and Summary of Significant Accounting Policies (Continued)

Plan Termination

Although management has not expressed any intent to do so, it has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants or their beneficiaries become 100% vested in all accounts and are entitled to a distribution of 100% of their account balances in all funds.

Benefits

On termination of service, disability, death, or retirement, participants receive a distribution in an amount equal to their vested account balance. If the participants' vested account balance exceeds \$5,000, the participant may elect distribution under any one of the various methods provided for by the Plan, including, but not limited to, a lump-sum payment or installment payments not to exceed the participants' life expectancy. If the participants' vested account balance is less than \$1,000, the Plan will distribute their vested account balance in a lump-sum payment. If the participant's vested account balance is between \$1,000 and \$5,000, the Plan will rollover the participant's vested account balances to an Individual Retirement Account on behalf of the participant or distribute the balance in accordance with the participant's election.

Benefit payments are recorded upon distribution to participants.

Participant Accounts

Each participant's account is credited with the participant elective deferrals, allocation of Plan Sponsor contributions and an allocation of Plan earnings and expenses. Plan Sponsor discretionary contributions, if any, are allocated based on a participant's compensation as a percentage of all eligible participants' compensation. Allocations of Plan earnings are based on the valuation of the investments held in each participant's account. Participants' accounts are valued on a daily basis. The benefit the participant is entitled to is the benefit that can be provided from the participant's account.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion on fair value measurements.

All purchases and sales of securities have been recorded on a trade-date basis. Income is recorded as earned. Dividends are recorded on the ex-dividend date. The increase or decrease in the fair value of investments represents the net difference between the current value of securities held at the beginning of the year or cost of securities purchased during the year and the current value of securities held at the end of the year.

1. Plan Description and Summary of Significant Accounting Policies (Continued)

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Reclassifications

Certain amounts presented in the prior year have been reclassified in order to be consistent with the current year's presentation. There were no changes to net assets available for benefits as a result of these reclassifications.

Subsequent Events

In preparing these financial statements, management of the Plan has evaluated events and transactions for potential recognition or disclosure through October 13, 2025, the date the financial statements were available to be issued.

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2024 and beyond. Plan management is evaluating the impact of the adoption and implementation of this legislation on the Plan.

2. Financial Information Certified by the Trustee

Principal Trust Company (the Trustee) has provided the plan administrator with certifications as to the completeness and accuracy of total investments of the Plan (including notes receivable from participants) held by the Trustee aggregating \$11,189,862 and \$10,153,683 as of December 31, 2024 and 2023, respectively; the related investment income of \$1,373,097 and \$1,520,836 for the years then ended, respectively; and interest from notes receivable from participants of \$24,290 and \$15,023 for the years then ended, respectively. Such amounts and all related financial data are included in the accompanying financial statements and supplemental schedule of the Plan based on such certifications from the Trustee. Under the terms of the trust agreements, the Trustee manages investment funds on behalf of the Plan. The Trustee has been granted non-discretionary authority concerning the purchases and sales of the investments of the investment funds.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

3. Fair Value Measurements

Accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Observable market-based inputs or unobservable inputs that are corroborated by market data. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used during the years ended December 31, 2024 and 2023.

Investments in common/collective trusts: The collective trust funds are valued at contract value which is determined by the net asset value (NAV) of units of a bank collective trust. The NAV, as provided by the trustee, is published as the fund's fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The common collective trust fund held by the plan is determined to be actively traded.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

3. Fair Value Measurements (Continued)

Pooled separate accounts: Pooled separate accounts are valued based upon the unit values of such pooled accounts held by the Plan at year end. Unit values are based on the fair value of the underlying assets of the fund derived from inputs principally from or corroborated by observable market data by correlation or other means, although are not based upon quoted market prices in an active market. The underlying investments of the pooled separate accounts consist of mutual funds, each of which follows a separate investment strategy. Due to the nature of these pooled accounts, there are no unfunded commitments or redemption restrictions.

The methods described above and on the previous page may produce fair values that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Party-in-Interest Transactions

Transactions resulting in Plan assets being transferred to or used by a party-in-interest are considered prohibited transactions under ERISA unless a specific exemption exists. Certain Plan investments are shares in registered investment companies – mutual funds, pooled separate accounts and common/collective trusts managed by the Trustees; and therefore, these transactions qualify as party-in-interest transactions and are indicated as such on the supplemental Schedule of Assets Held at End of Year. However, the transactions are not considered prohibited transactions as ERISA regulations provide for a specific exemption for such transactions.

The Plan issues loans to participants, which are secured by the participant account balances. These qualify as party-in-interest transactions but are permitted under ERISA regulations.

Additionally, certain employees of the Company provide certain accounting and administrative services to the Plan for which no fee is charged. These transactions are also permitted under ERISA regulations.

5. Tax Status

The Plan has adopted a nonstandardized 401(k) Profit Sharing Plan and Trust which received a favorable opinion letter from the Internal Revenue Service which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The nonstandardized 401(k) Profit Sharing Plan and Trust has been amended since receiving its determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

The Plan evaluates all significant tax positions as required by generally accepted accounting principles in the United States. As of December 31, 2024, the Plan does not believe that it has taken any tax positions that would require the recording of any additional tax liability nor does it believe that there are any unrealized tax benefits that would either increase or decrease within the next twelve months. The Plan's income tax returns are subject to examination by the appropriate regulatory authorities as of December 31, 2024, and the Plan's federal tax returns generally remain open for the last three years.

6. Risk and Uncertainties

The Plan offers a number of investment options to participants that are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect amounts reported in the statements of net assets available for benefits and participant accounts.

7. Reconciliation of Financial Statements to Form 5500

The financial statements are prepared on the full accrual basis of accounting whereas on the Form 5500 certain accruals are not recorded. The following is a reconciliation of the net assets available for benefits per the financial statements to the Form 5500 as of December 31, 2024 and 2023:
