I submitted the form last year, but unbeknownst to me, Paychex made a clerical error and did not properly submit it. This was through no fault of my own, and I had called Paychex customer service, and they indicated to me that they had made a clerical error resulting in my inability to properly submit the form. I am requesting that any late fees be waived because my plan administrator created the clerical error. And received a notification on January 28th that my Form 5500 was not submitted for the 2024 year. It was my understanding that I filed the form under the Paychex filing system, but this was not the case, due to the technical errors Paychex had incurred. I have successfully submitted the form 5500-SF for 2024 as of today's date on the EFAST website. I am requesting that any late fees are not incurred due to the error of my plan administrator. I have contacted the Technical Support team regarding the paychecks, and they have resolved the issue. The problem will no longer occur in 2025 and moving forward.
