Independent Auditor's Report

To the Board of Trustees of

Opinion

We have audited the financial statements of the National Electrical Benefit Fund Defined Contribution Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years ended June 30, 2025 and 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the National Electrical Benefit Fund Defined Contribution Plan as of June 30, 2025 and 2024, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

Notes to Financial Statements

June 30, 2025 and 2024

1. Plan Description and Funding

The following description of National Electrical Benefit Fund Defined Contribution Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a single-employer noncontributory defined contribution plan covering all eligible employees of the National Electrical Benefit Fund ("NEBF"), National Real Estate Advisors, LLC ("NREA"), a subsidiary of NEBF, and National Real Estate Advisors Development Services ("NREADS"), a subsidiary of NREA. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Administration

The Retirement Plan Company, LLC serves as the Plan's third-party administrator. The assets of the Plan are held in trust by Fidelity Management Trust Company ("Fidelity"), as Trustee. Effective March 1, 2023, Segal Marco serves as the Plan's investment manager.

Eligibility to Participate

An employee of NEBF, NREA or NREADS is deemed eligible to participate in the Plan upon completion of six months of credited service and attainment of the minimum age of 20.5.

Participant Accounts

A retirement benefits account is maintained for each participant. Each participant's account is credited with employer contributions and net investment earnings thereon and reduced by fees and distributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are 100% vested in their individual accounts after achieving three or more years of credited service. One year of credited service is defined by the Plan as any Plan year in which an active employee is employed for not less than one thousand hours. Prior to achieving three years of credited service, participants are non-vested in their individual accounts, except that participant accounts become 100% vested upon the death or total and permanent disability of the participant without regard to the participant's years of credited service.

Forfeitures

Accounts of participants who fail to achieve the three years of credited service required to become vested are forfeited upon a break in service or termination of employment. These forfeited balances may be made available to reinstate previously forfeited account balances of participants or used to satisfy any employer contribution that may be required.

At June 30, 2025 and 2024, there were \$53,752 and \$20,208, respectively, of forfeited nonvested accounts available to reduce future employer contributions. For the years ended June 30, 2025 and 2024, employer contributions were reduced by forfeitures by \$0 and \$35,652, respectively.

Plan Services

The Trustee provides recordkeeping and custodial services for the Plan.

Retirement

Normal retirement age is attained on the date of the participant's 65th birthday. Participants are eligible to receive normal retirement benefits on the first day of the month coinciding with or next following the participant's 65th birthday. Early retirement is available to participants who have attained age 54.5 and completed at least ten years of vested service. Benefits are normally paid as an annuity, but with consent of the Plan Administrator and subject to spousal consent, the participant may elect a lump sum payment in lieu of all other benefits.

Contributions

For each of the years ended June 30, 2025 and 2024, employer contributions to the Plan were made quarterly at a rate of 8% of compensation, subject to certain limitations, earned by eligible participants.

BrokerageLink

BrokerageLink is a self-directed brokerage account intended for sophisticated investors who are willing to take on additional risk and are prepared to assume the responsibility of more closely monitoring their portfolios. As of June 30, 2025 and 2024, BrokerageLink accounts maintained by Plan participants were invested in various corporate stocks and exchange traded funds.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Employer Contributions Receivable

Employer contributions receivable are accrued based upon amounts due but not yet paid as of June 30, 2025 and 2024. As of June 30, 2025 and 2024, there was no allowance for credit losses established.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan's management evaluated events that occurred after June 30, 2025 through January 20, 2026, the date the financial statements were available to be issued. In December 2025, the Trustees approved changing the Plan's fiscal year end to December 31, effective December 31, 2025. There were no other subsequent events noted.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used as of June 30, 2025 and 2024.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-Directed BrokerageLink Investments: Valued based on quoted market prices in active markets.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its evaluation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Related Party Transactions and Party In Interest Transactions

The employer entities pay certain administrative costs on behalf of the Plan and those costs are not included as deductions of the Plan.

Certain Plan investments are shares of mutual funds managed by Fidelity Investments. Fidelity Investments is the Trustee as defined by the Plan and, therefore, these transactions qualify as exempt party in interest transactions. Fees incurred by the Plan for investment management services are included in net depreciation in fair value of investments as they are paid through revenue sharing, rather than a direct payment.

5. Tax Status

The Plan adopted a volume submitter plan offered by Fidelity. The volume submitter plan received an IRS Determination Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code ("IRC"). The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

7. Priorities Upon Termination of the Plan

It is the intent of the trustees of NEBF to continue the Plan in full force and effect. However, to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the trustees of NEBF. In the event of termination of the Plan, each participant in the employ of NEBF, NREA or NREADS on the date of termination would have a 100% vested interest in his or her account balance.

Any unallocated funds or assets remaining after satisfaction of all liabilities of the Plan shall be allocated among participants who are employees of NEBF, NREA or NREADS on the date of termination in proportion to the value of each participant's account to the total value of all participant accounts.
