Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of **Rainbow of Challenges, Inc. Retirement Plan (the Plan)**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended June 30, 2025, and the related notes to the financial statements.

Management has obtained certifications from qualified institutions as of June 30, 2025 and 2024, and for the year ended June 30, 2025, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTE 1: DESCRIPTION OF PLAN

The following description of the Rainbow of Challenges, Inc. Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Nature of Operations

The Plan, which was established September 1, 1994, is a defined contribution plan for the benefit of employees of Rainbow of Challenges, Inc. (the Employer, Plan Sponsor and Plan Administrator) and certain other affiliated companies. Collectively, Rainbow of Challenges, Inc. and its affiliated companies are hereinafter referred to as "the Employers". Generally, employees who work more than 20 hours per week are eligible to participate in the Plan upon the first day of employment with the Employer.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Empower Retirement ("Empower" or "Plan Recordkeeper"), serves as the recordkeeper of the Plan and is responsible for the overall administration of the Plan, including maintaining participant account balances. Additionally, the Plan has prior contracts issued by Metropolitan Life Insurance Company (MetLife) and the Variable Annuity Life Insurance Company (VALIC), a member of Corebridge Financial, Inc., as well as an account with the American Funds Service Company (American Funds). The contracts and accounts held with MetLife, VALIC and American Funds are not active with the only activity being investment earnings, administrative expenses and distributions.

Certain duties related to the administration of the Plan are performed by employees of the Employer; however, the Employer does not charge the Plan for the estimated cost of such services.

Contributions

Participants may contribute up to 100% of annual compensation, as defined in the Plan agreement, not to exceed limitations imposed by the Internal Revenue Service (IRS). Participants may also contribute amounts representing distributions from other qualified plans and certain IRAs (rollovers).

The Employer may make a discretionary matching contribution on behalf of eligible participants equal to a percentage of each participant's salary deferral. The amount of matching contributions are determined annually by the Employer and may only be received by eligible participants who have completed six months of service. Employer contributions are also subject to limitations imposed by the IRS.

NOTE 1: DESCRIPTION OF PLAN (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions, the Employer matching contributions and allocations of Plan earnings, net of certain administrative expenses. Allocations are generally based on participant account balances, as specified in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are fully vested at all times in their own contributions and earnings thereon. A participant is one hundred percent vested in Employer contributions, plus earnings thereon, when the participant attains retirement age or dies. If a participant terminates employment for any other reason, including disability, he or she will vest in contributions made by the Employer, plus earnings thereon, according to the following schedule:

Investment Options

Contributions to the Plan are invested as directed by participants. Participants may invest in one or more mutual funds and the fixed account offered by the Plan, and they may change their investment options at any time.

Forfeitures

The nonvested portion of a participant's account to which he or she is not entitled upon termination is deemed a forfeiture. Forfeitures may be used to reduce Employer contributions. During the year ended June 30, 2025, forfeitures totaling approximately \$14,600 were used to reduce the Employer's contributions. As of June 30, 2025, forfeitures totaling approximately \$800 were available for future allocation. There were no forfeitures available for future allocation at June 30, 2024.

Payment of Benefits

Upon retirement or other termination of service, a participant (or his or her designated beneficiary) may elect to receive a distribution of their entire accumulated Plan balance, subject to the terms of the funding vehicles. Distribution options include lump-sum payments, a direct transfer of an eligible rollover distribution, or a partial payment. In the event a participant's account balance does not exceed \$5,000, a distribution shall be made in the form of a lump-sum payment.

NOTE 1: DESCRIPTION OF PLAN (Continued)

Hardship Withdrawals

In case of immediate and heavy financial hardship, a participant may withdraw all or a portion of the vested account balance. A withdrawal shall be deemed for purposes of an immediate and heavy financial hardship if the withdrawal is necessary for certain eligible expenses, such as medical care, the purchase of a principal residence for the participant, payment of tuition and related education fees for the next twelve months of post-secondary education, payments necessary to prevent eviction of the participant from his or her principal residence or to avoid foreclosure on said residence, payments for funeral or burial expenses, or expenses to repair damage to the participant's principal residence.

Termination of the Plan

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly fashion between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by investment advisers and the trustee. See Note 4 for further discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes realized and unrealized gains and losses on investments bought and sold, as well as those held during the year.

Payment of Benefits

Benefits are recorded when paid. There were no amounts allocated to withdrawing participants that have not been paid at June 30, 2025 and 2024.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

NOTE 3: INVESTMENT INFORMATION CERTIFIED BY THE CUSTODIANS

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, all information pertaining to the Plan's investments and related investment activity reflected in the financial statements and supplemental schedule was certified by the Plan's custodians, Empower Trust Company, LLC and Empower Annuity Insurance Company of America, Metropolitan Life Insurance Company, and the Variable Life Insurance Company, as a member of Corebridge Financial, Inc., as of June 30, 2025 and 2024, and for the year ended June 30, 2025. This information was not subject to audit procedures except for comparing it to the related information included in the financial statements and supplemental schedule.

The following information included in the accompanying financial statements, related notes and supplemental schedule was obtained from data that has been prepared and certified as complete and accurate.

NOTE 4: FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2 Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2025 and 2024:

Mutual Funds

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts

The pooled separate accounts are valued at the net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Fixed Accounts

The fixed accounts are valued at contract value which approximates fair value. Contract value represents contributions made under the contract, plus interest at the credited rate, less funds used to pay benefits and administrative expenses charged. The fixed accounts cannot be sold to a third-party; thus, the only option to exit the fixed accounts is to withdrawal the funds prior to maturity. Therefore, the fair value of the fixed accounts is determined using a market approach and is the amount Plan participants would receive currently if they were to withdraw or transfer funds within the Plan prior to their maturity for an event other than death, disability, termination or retirement.

NOTE 5: EXCESS CONTRIBUTIONS PAYABLE

The Plan failed the discrimination test for the year ended June 30, 2024. Excess contributions of \$3,827 are recorded as liabilities in the accompanying statement of net assets available for benefits as of June 30, 2024.

NOTE 6: PARTICIPANT LOANS

The Plan document currently provides no provision for participant loans. However, loans have previously been available to participants through custodians MetLife and VALIC, subject to certain limitations. MetLife issues loans directly from funds owned by MetLife and loan proceeds are not removed from a participant's account balance. VALIC issues loans directly from funds owned by VALIC and loan proceeds are reclassified from a participant's investment account balance to loan collateral or escrow fund account for tracking purposes. Issuance of these plan loans has no impact on the statements of net assets available for benefits as of June 30, 2025 and 2024. At June 30, 2024, participants had outstanding plan loan balances of \$8,683. There were no outstanding participant loans at June 30, 2025.

NOTE 7: TAX STATUS

The Plan executed an adoption agreement for the Volume Submitter 403(b) Plan (the Prototype) sponsored by Great-West Trust Company, LLC (a member of the Empower Trust Company). As an adopter of the Prototype, the Plan is not subject to tax under present income tax law. The Prototype obtained its latest opinion letter on March 31, 2017, in which the IRS informed the Great-West Trust Company that the Prototype, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting standards require the Plan Sponsor to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Sponsor has analyzed the tax positions taken by the Plan and has concluded that as of June 30, 2025 and 2024, there are no uncertain positions taken or expected to be taken that would require the recognition of a liability or disclosure in the financial statements. The Plan may be subject to audit by the IRS; however, there are currently no audits for any tax periods in progress.

NOTE 8: RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in various investment options managed by the custodians. These transactions qualify as exempt party-in-interest transactions. Fees for investment management services are not paid by the Plan from Plan assets, but reduce the amount of income available for distribution to the Plan.

NOTE 9: RISKS AND UNCERTAINTIES

The Plan's investments are exposed to various risks such as interest rate, market and credit risks. In addition, certain investment options may invest in foreign securities. There are certain additional risks involved when investing in foreign securities that are not present with investments in domestic securities. These risks may involve foreign currency exchange rate fluctuations, adverse political and economic developments and the possible prevention of currency exchange due to foreign governmental laws or restrictions. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the Plan's financial statements.

NOTE 10: SUBSEQUENT EVENTS

Management has evaluated subsequent events through January 22, 2026, the date that the financial statements were available to be issued.
