## INDEPENDENT AUDITOR'S REPORT

To the Pension Committee of the  
Beverly Hospital Employees' Retirement Plan:

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the Beverly Hospital Employees' Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of June 25, 2024 (in liquidation), December 31, 2023 (ongoing) and 2022 (ongoing), and the related statements of changes in net assets available for benefits for the period ended June 25, 2024 (in liquidation) and for the year ended December 31, 2023 (ongoing), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency ("qualified institution"), provided that the investment information regarding assets so held is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from qualified institutions as of June 25, 2024, December 31, 2023 and 2022 and for the period ended June 25, 2024 and the year ended December 31, 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meet the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the *Auditor’s Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting***

As discussed in Note 1 to the financial statements, the plan sponsor filed for protection under Chapter 11 of the Bankruptcy Code in 2023. On September 7, 2023, the Company was acquired by Adventist Health. As further discussed in Note 1 and Note 7 to the financial statements, the Bankruptcy Trustee of the Organization signed a resolution directing that the Plan be terminated effective January 31, 2024, and management determined liquidation is imminent. In accordance with U.S. GAAP, the Plan has changed its basis of accounting from the ongoing plan basis used in presenting the December 31, 2023 and 2022 financial statements to the liquidation basis used in presenting the June 25, 2024 financial statements. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern within one year after the date the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor’s Responsibilities for the Audit of the Financial Statements***

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor’s report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher

than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information and to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that were identified during the audit.

***Other Matter – Supplemental Schedule Required by ERISA***

The supplemental schedule of Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2023 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The

information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to, or is derived from, the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by qualified institutions agree to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

### 1. PLAN DESCRIPTION

The following description of the Beverly Hospital Employees' Retirement Plan (the "Plan") provides only general information. Participants and other interested parties should refer to the Plan document for a more complete description of the Plan's provisions.

**General** - The Plan is a noncontributory money-purchase defined contribution plan covering all employees, as defined by the Plan, who were employed by Beverly Hospital (the "Organization" and the "Plan Sponsor"), who had completed at least 750 hours of service in a 12-month period and were over the age of 18 years. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Effective January 1, 2007, the Organization elected to freeze the Plan, and is no longer accepting any contributions or new participants into the Plan.

On April 19, 2023, the Organization filed for reorganization under the protection of Chapter 11 of the Bankruptcy Code. On September 7, 2023, the Organization was acquired by Adventist Health.

Effective January 31, 2024, the Bankruptcy Trustee of the Organization signed a resolution directing that the Plan be terminated. The Organization began liquidating the Plan assets during 2024 and the Plan was fully liquidated as of June 25, 2024.

**Contributions** - The Plan is frozen and no contributions are being accepted. Participants direct their accounts into various investment options offered by the Plan.

**Participant Accounts** - Each participant's account is credited with allocations of Plan earnings and charged with any withdrawals or distributions requested by the participant, investment losses and allocation of administrative expenses, if applicable. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants are vested immediately in their contributions and the Organization's contributions plus actual earnings thereon.

**Participant Loans** - The Plan does not permit participant loans.

**Payment of Benefits** - On termination of service for any reason, a participant may receive the value of the vested interest in their account as a lump-sum amount or an annuity, as permitted under the Plan. The Plan provides for a mandatory cash-out following severance of employment for account balances less than \$5,000.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** - The accompanying financial statements have been prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"). Effective January 31, 2024, the Bankruptcy Trustee of the Organization signed a resolution directing that the Plan be terminated.

As a result, the Plan's financial statements as of and for the period ended June 25, 2024 have been prepared on the liquidation basis, in accordance with U.S. GAAP. This basis of accounting is considered appropriate when, among other things, liquidation of an entity is probable, and the net realized value of assets are reasonably determinable. Under the liquidation basis of accounting, assets are stated at their estimated net realized cash value and liabilities are stated at their anticipated settlement amounts. The estimated net realizable cash value for investments as of December 31, 2023 and 2022 would be fair value.

**Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** - The Plan's investments are stated at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Investments are valued daily. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recognized on the accrual method. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Administrative Expenses** - Certain administrative expenses incidental to the administration of the Plan may be paid by the Plan, unless otherwise paid by the Organization. Administrative expenses paid by the Organization are excluded from these financial statements.

Most investment options have fees that reduce the overall return on assets. The net appreciation of investments is reflected net of these fees.

According to the pension services agreement made between the Organization and Transamerica Retirement Solutions Corporation ("TRSC"), TRSC was required to make contributions to an expense budget account ("EBA") in the amount of the expected fund revenue, as defined in the pension services agreement, based on certain expenses charged to the Plan by the Plan's mutual fund investments. The net appreciation of investments is inclusive of these contributions. The EBA must first be used to pay the required revenue to TRSC, quarterly, in an amount equal to 0.1425 percent of the Plan's assets (0.57 percent annually). Any excess funds in the EBA may be used to pay Plan administrative expenses or allocated to participants at the discretion of the Organization. During the period ended June 25, 2024 and year ended December 31, 2023, TRSC contributed \$9,696 and \$32,086, respectively, to the EBA, and \$26,457 and \$35,063, respectively, was used to pay Plan administrative expenses. As of June 25, 2024; and December 31, 2023 and 2022, there was \$0, \$16,759, and \$19,736, respectively, available in the EBA.

**Benefits Payable to Participants** - Benefits are recorded when paid.

**Subsequent Events** - The Organization has evaluated subsequent events through January 26, 2026, which is the date that the financial statements were available to be issued, and determined that there were no subsequent events or transactions that required recognition or disclosure in the financial statements.

**3. FAIR VALUE**

The Plan accounts for its financial instruments using a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are the following:

- Level 1 – Inputs to the valuation methodology that are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in markets that are inactive; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3 – Inputs to the valuation that are unobservable and significant to the fair value measurement.

A financial instrument’s categorization within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

Due to the termination of the Plan (see Note 1), there were no Plan assets as of June 25, 2024.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

*Mutual Funds* – This category consists of publicly traded funds of registered investment companies. The net asset value of the mutual fund’s shares is quoted on the exchange where the fund is traded and therefore classified as Level 1 within the valuation hierarchy.

*Guaranteed Interest Contract (“GIC”)* – Valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer and therefore classified as Level 2 within the valuation hierarchy.

#### 4. FINANCIAL DATA CERTIFIED BY THE CUSTODIANS

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was obtained by management and agreed to or derived from information certified as complete and accurate by State Street Bank and Trust Company, Transamerica Financial Life Insurance Company ("TFLIC"), and Transamerica Life Insurance Company ("TLIC") (collectively, the "Custodians"), and was not subjected to any auditing procedures performed by the independent qualified public accountants:

- a. Investments, at fair value and contract value, as shown in the accompanying statements of net assets available for benefits as of June 25, 2024 (in liquidation), December 31, 2023 (ongoing) and December 31, 2022 (ongoing).
- b. Net appreciation of investments and interest and dividend income on investments as shown in the accompanying statements of changes in net assets available for benefits for the period ended June 25, 2024 (in liquidation) and the year ended December 31, 2023 (ongoing).
- c. Investments and fully benefit-responsive investment contract as listed in the accompanying Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2023.

#### 5. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with TLIC totaling \$0 as of June 25, 2024, \$6,859,755 as of December 31, 2023, and \$7,729,640 as of December 31, 2022. TLIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. TLIC is contractually obligated to repay the principal and specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with TLIC. Such interest rates are reset on a semi-annual basis.

The Transamerica Guaranteed Investment Option meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by TLIC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on TLIC's ability to meet its financial obligations. TLIC's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

### **6. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **7. PLAN TERMINATION**

The Organization has the right under the Plan to terminate the Plan, subject to the provisions of ERISA. Effective January 31, 2024, the Bankruptcy Trustee of the Organization signed a resolution directing that the Plan be terminated. Upon termination of the Plan, participants were given the option to elect an individual rollover to a qualified institution or plan, a lump sum payment, or an annuity. For participants who did not elect a payment method or were unable to be located, account balances were transferred to the Missing Participants Program account with Pension Benefit Guaranty Corporation. The Plan was fully liquidated as of June 25, 2024.

### **8. TAX STATUS**

The Plan Sponsor received a determination letter dated April 7, 2016 in which the IRS stated that the Plan as designed was in compliance with the applicable requirements of the IRC. The Plan has been subsequently amended and the plan administrator believes that the Plan currently is being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is tax-exempt. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate uncertain tax positions taken by the Plan and recognize a tax liability (or asset) if the Organization has taken a significant uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 25, 2024 and December 31, 2023, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **9. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS**

TRSC manages certain Plan investments and the Custodians hold the Plan's assets. Transactions with TRSC and the Custodians qualify as party in interest transactions for which exemptions exist. During the period ended June 25, 2024, TRSC received \$22,637 in fees, of which \$22,077 was paid by participants through the Plan and \$560 from the EBA. During the year ended December 31, 2023, TRSC received \$64,010, all of which was paid by participants through the Plan. TRSC also received indirect compensation based on a formula. For the period ended June 25, 2024 and the year ended December 31, 2023, the Plan paid fees of \$8,938 and \$20,563 to the Plan's investment advisor, respectively, and \$16,959 and \$14,500 to the independent qualified public accountants, respectively, all of which was paid from the EBA. In addition, the Plan's broker received indirect compensation based on a formula.
