We are writing to respectfully request relief from the penalties associated with the late filing of our Form 5500 for the plan year ending [date]. Our company has maintained a strong history of compliance, having filed all required Forms 5500 on time for the past ten years. Unfortunately, due to a series of unforeseen and unavoidable circumstances, we missed this year's filing deadline.

As a small business, our administrative and compliance functions are handled by a single internal controller. During the filing period, our business experienced significant and unexpected staffing and medical-related disruptions that left us temporarily unable to coordinate with our third-party administrator (TPA) to complete the filing by the October 15 deadline. These circumstances were outside of our control, and once identified, we acted promptly to correct the issue.

We have now completed the Form 5500 and are submitting the filing immediately. We have also taken steps to ensure timely filing in the future, including improved calendaring, internal compliance procedures, and earlier coordination with our TPA for upcoming plan years.

Given our long history of timely compliance, the short duration of the delay, our good-faith efforts to correct the error as soon as possible, and the extraordinary circumstances affecting our small administrative staff, we respectfully request that the Department of Labor abate the penalties associated with this late filing.

We value the importance of regulatory compliance and remain committed to fulfilling all future filing obligations on time. Thank you for your consideration. Please let us know if any additional information is required.
