Basis for Opinion

NOTE A - Description of Plan

The following description of Seeds of Health, Inc. 403(b) Savings Plan provides general information. Participants should refer to the plan document for a more complete description of the plan.

General

Seeds of Health, Inc. (the Organization) established a 403(b) Plan for the benefit of its employees. The Plan is a defined contribution plan established by the Organization and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

All permissible employees of Seeds of Health, Inc., as defined in accordance with the universal availability standards, are eligible to enroll on their date of hire. All employees who are enrolled in the Plan, having completed three months of service and actively employed on the last day of the Plan year, are eligible to receive a discretionary contribution. A year of service is defined as a period of 12 consecutive months in which the employee completes 1,000 hours of service.

Ascensus Trust Company and Newport Trust Company, LLC serve as the custodians of the Plan and provide recordkeeping services.

Contributions

Participants may elect to reduce compensation by a specific percentage or dollar amount and have that amount contributed to the Plan as an elective deferral in accordance with a procedure established by the Plan. Participants are permitted to designate portion or all of their deferral contributions as Roth 403(b) contributions. Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions.

Contributions are subject to certain limitation as mandated by the Internal Revenue Code (IRC).

The Plan does not include an auto-enrollment provision.

The Organization provides a matching contribution equal to up to 25% of the first 4% of compensation that an employee contributes to the Plan. If an employee contributes less than 4% of their compensation, the Organization's matching contribution is reduced proportionally.

The Organization may make discretionary non-elective contributions to the plan. For the years ended June 30, 2025 and 2024, the Organization made discretionary contributions to eligible employees of 5.5%.

NOTE A - Description of Plan (continued)

Investment Options

Participants may direct all their contributions among one or more funds subject to the allocation limitations set forth in the Plan. Changes in allocation of future contributions and transfers among funds of presently invested contributions are permitted pursuant to the Plan's provisions. The participants currently have 29 investment options available.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Organizations contributions and (b) plan earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on participant earnings (losses), account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are immediately 100% vested in all contributions, plus earnings thereon.

Participant Loans

Participants may borrow from their accounts up to 50% of their total vested account balance. The maximum aggregate dollar of loans outstanding to any participant may not exceed \$50,000, reduced by the excess of the participant's highest outstanding participant loan balance during the 12-month period ending on the date of the loan over the participant's current outstanding loan balance on the date of the loan. The maximum term of any loan is five years or fifteen years if the loan proceeds will be used to acquire a principal residence of the participant. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1.0%. Principal and interest are due at least quarterly. The participants loans receivable are valued at their unpaid principal plus any accrued but unpaid interest, which approximates fair value. For the years ended June 30, 2025 and 2024, the participant loan balances are \$179,536 and \$32,501, respectively.

Payment of Benefits

Participants are eligible to receive benefits upon termination, disability, death or reaching Normal Retirement Age, which is defined by the Plan as 65 years. Payments may be paid in either a single lump sum or installments over a period of time not more than assumed life expectancy. Benefits are recorded when paid.

NOTE B - Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting and present the assets available for Plan benefits and changes in those assets.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America (US GAAP) and requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plans valuation policies utilizing information provided by the custodian. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest Income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Participant Loans

Participant loans are measured at their unpaid principal balance plus any accrued but unpaid interest less amounts defaulted (if any). Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expensed when they are incurred.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Organization and are excluded from these financial statements. Loan administration and distribution fees are charged directly to the participant account and are included in administration expense. The Plan also pays certain investment advisory and plan administration fees from plan assets. For the years ended June 30, 2025 and 2024, administrative fees of \$53,506 and \$46,740 respectively, were paid out of Plan assets.

The Organization has adopted the Financial Accounting Standards Board guidance on fair value measurements. A three-tier hierarchy is used to maximize the use of observable market data inputs and minimize the use of unobservable inputs and to establish classification of fair value measurements for disclosure purposes. The three levels of the hierarchy are described as follows:

- Level 1 Quoted prices in active markets for identical assets or liabilities.
- Level 2 Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3 Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2025 and 2024.

Shares of registered investment companies: Shares of registered investment companies are valued at the daily closing price as reported by the fund. Shares of registered investment companies held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are deemed to be actively traded, and are required to publish their daily net asset value (NAV) and to transact at that price.

NOTE E - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments at June 30, 2025, may not necessarily be indicative of amounts that could be realized in a current market exchange.

NOTE F - Plan Termination and Amendments

While the Organization has not expressed any intend to terminate the Plan, it has the right to do so, subject to the provisions of ERISA.

The Plan may be amended at any time by the Organization.

NOTE G - Party-in-Interest Transactions

Certain plan investments are managed by Ascensus Trust Company and Newport Trust Company, LLC, the custodians, as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Ascensus Trust Company and Newport Trust Company, LLC also perform administrative and recordkeeping services for the Plan. The transactions are not, however, considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations.

Certain employees of the Organization provide trustee and administrative services for the Plan and are not reimbursed for their services from the Plan. Certain other administrative expenses are paid by the Organization on behalf of the Plan.

NOTE H - Tax Status

The Plan terms have been drafted in reliance with the sample language provided by the Internal Revenue Service in Revenue Procedure 2007-71. The Plan Administrator intends to apply for a determination letter on the Plan when the government opens such program. The Plan is required to operate in conformity with the Code to maintain its tax exemption. Plan management believes the Plan is currently designed and operated in compliance with the applicable requirements of the Code. Therefore, no provision for income tax has been included in the Plan's financial statements.

NOTE I - Subsequent Events

The Organization evaluated subsequent events and transactions for possible adjustments to the financial statements and disclosures. The Organization has considered events and transactions occurring after June, 30 2025, the date of the most recent balance sheet, through January 22, 2026, the date the financial statements are available to be issued. It has been determined that no subsequent events need to be disclosed.
