Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Our House, Inc. 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Our House, Inc. 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTES TO THE FINANCIAL STATEMENTS FOR THE YEARS ENDED JUNE 30, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of the Our House, Inc. 401 (k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan Document for more complete description of the Plan's provisions.

General --- The Plan is a contributory, defined contribution prototype plan established on April 1, 1988 and restated February 22, 2019. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Board of Trustees of Our House, Inc., the Plan administrator and sponsor (the "Organization") is responsible for oversight of the Plan and they determine the appropriateness of the Plan's investment offerings and monitors investment performance. Michele Delcorsano and Natalie Tortorello serve as the trustees for the plan. Among other things, the trustees are charged with holding and directing the assets for the Plan. Effective November 20, 2023, the trustees directed a change in service providers from Empower Retirement ("Empower") to Mutual of America Financial Group ("Mutual of America"). Mid Atlantic Trust Company ("MATC") is the custodian for the plans offered by Mutual of America and the responsible party for certification. Mutual of America serves as the recordkeeper and provides supporting, non-certified participant level reports. MATC has certified the information for the year ended June 30, 2024 and Empower has certified the information for the year ended June 30, 2023.

CARES and SECURE Act --- The Plan has implemented certain requirements by the Coronavirus Aid, Relief, and Economic Security Act (the CARES Act) and the Setting Every Community Up for Retirement Enhancement Act of 2019 (the SECURE Act), which laws change the Plan to, among others, allow certain eligible individuals to receive coronavirus-related relief for loan repayment, suspend required minimum distributions, and delay the commencement date for required minimum distributions.

Eligibility --- All employees who have completed one year of service and are 21 years of age or older are eligible to participate in the Plan and make elective deferrals. Employees may enter the Plan on the first day of the calendar month coinciding with meeting all eligibility requirements. Employees must complete 1,000 hours of service in an eligibility computation period to received matching and discretionary contributions.

Contributions --- Each year, participants may voluntarily contribute both pre-tax and/or Roth contributions to the maximum allowable amount as mandated under the Internal Revenue Code. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Organization contributes 2.5% of each active participants pay each payroll into the plan. The Organization also makes matching contributions equal to a percentage of the participant's voluntary contribution (elective deferral). During the year the Organization contributed 25% of each participants elective deferral up to a maximum match of 4%. Additionally, per the Plan document, the Organization may elect to make a discretionary contribution to the Plan, which is divided amongst active participants based on a formula specified in the Plan document. Contributions are subject to certain limitations. No discretionary contribution was elected by management for the Plan years ended June 30, 2024 and 2023.

NOTES TO THE FINANCIAL STATEMENTS FOR THE YEARS ENDED JUNE 30, 2024 AND 2023 (CONTINUED)

1. DESCRIPTION OF PLAN (CONT.)

Participant accounts --- Each participant's account is credited with the participant's voluntary contributions, employer contributions of 2.5% of his or her pay per pay period, matching contributions, discretionary contributions, investment earnings and is charged with withdrawals, an allocation of investment losses and administrative expenses. The amount of investment income a participant's account earns is contingent upon the nature of the investments chosen by the participants. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting --- Participants are fully vested immediately in their own contributions made into the plan, plus actual earnings thereon. Vesting in the Organization's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after three years of credited service. Moreover, participants are fully and automatically vested in their accounts after becoming eligible for retirement, incurring a disability prior to termination, or upon death.

Notes receivable from participants --- Participants may borrow from their accounts a minimum of \$1,000 up to a maximum amount that may be borrowed from a qualified plan without being subject to income tax (currently, \$50,000 or, if less, 50% of the value of a participant's non-Roth vested account balance). The loans are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 6.50%, which is commensurate with local prevailing rates. Principal and interest is paid ratably through semi-monthly payroll deductions. During the years ended June 30, 2024 and 2023, \$7,434 and \$9,865 of defaulted loans were deemed distributions.

Payment of benefits --- Terminated participants may receive the value of their vested account upon the date of severance from employment. Normal retirement age to withdraw money is 65 years. However, participants may elect to receive a retirement benefit any time on or after the date he or she reaches age 55 and is credited with 3 years of vested service. On termination due to death, disability or retirement, a participant or his or her beneficiary will receive payment equal to the value of the participant's vested interest in his or her account. Upon becoming eligible to receive benefits, participants with a value in their vested accounts of greater than \$5,000 may elect to receive a lump-sum benefit or choose from a number of guaranteed annuities offered by Mass Mutual of America. Participants with a vested value of less than \$5,000 will receive a lump-sum payment.

Hardship withdrawals --- Participants may withdraw any part of their vested account balance in the event of an undue financial hardship. Proof of the hardship must be provided to Plan management and approved by Plan management in order to obtain this benefit.

Forfeited accounts --- Forfeitures arising from the termination of participants who were not fully vested shall be reallocated to pay administrative expenses of the Plan and may be applied to offset employer contributions. Total forfeitures and earnings for the plan years ended June 30, 2024 and 2023 were \$28,711 and \$10,356. At June 30, 2024 and 2023, forfeited non-vested accounts totaled \$-0-, respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting --- The accompanying financial statements of the Plan are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America.

Use of estimates --- The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets available for benefit and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition --- Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisor and trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net (depreciation) appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments are deducted from income earned and are not separately reflected. Consequently, management fees and operating expenses are reflected in a reduction of investment return for such investments.

Contributions --- Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which participant compensation is earned.

Notes receivable from participants --- Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced, and a deemed distribution is recorded. No allowance for credit losses has been recorded as of June 30, 2024 and 2023.

Excess participant contributions payable --- Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to contributions. Excess contributions are further detailed in Note 10.

Payment of benefits --- Benefits are recorded when paid.

Expenses --- Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net (depreciation) appreciation of fair value of investments.

3. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

3. FAIR VALUE MEASUREMENTS (CONT.)

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Mutual funds: The fair value of mutual funds is based on quoted net asset values of the shares Held by the Plan at year end. The fair values of common stock, corporate bonds, and U.S. Government securities are based on quoted market prices. Level 1 inputs are considered "observable" inputs.

Common collective trust: These inputs are "observable for the asset or liability, either directly or indirectly", including quoted prices for similar securities, interest rates, credit risk, etc. that are determined for an asset based on independent market data. These investments have net asset values that are considered published.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. COMMON COLLECTIVE TRUSTS

The Plan offers funds, for which Mid Atlantic Trust Company serves as custodian and Mutual of America serves as the recordkeeper and investment manager for the year ended June 30, 2024. Empower served as custodian and investment manager for year ended June 30, 2023. Mid Atlantic Trust Company has certified the information for the year ended June 30, 2024 and Empower has certified the information for the year ended June 2023. The investments of the common collective trusts may consist of fully benefit-responsive investment contracts, fixed income securities, pooled separate accounts and other low risk securities. While the fund seeks to preserve the account holders principal investment, it is possible to lose money by investing in this fund, as the funds have net asset values that are considered published. Total amounts of collective investment trusts were \$89,611 and \$6,154,927, respectively for the years ended June 30, 2024 and 2023.

5. ANNUITY INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has a traditional fully benefit-responsive guaranteed investment contract with Mutual of America for the years ended June 30, 2024 and 2023. Contributions were maintained in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The credit rate is based on a formula established by the contract issuer. The credit rate is based on a formula established by the contract issuer but may not be less than 3%. The credit rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. As of June 30, 2024 and 2023, the guaranteed investment contracts totaled \$180,929 and \$226,420.

5. ANNUITY INVESTMENT CONTRACT WITH INSURANCE COMPANY (CONT.)

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value.

Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Mutual of America, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the Plan to transact at contract value with the issuer.

6. RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are shares of funds managed by Mutual of America and Empower for the years ended June 30, 2024 and 2023, respectively. Therefore, these transactions qualify as party-in-interest transactions. Purchases and sales of these funds are open market transactions at fair market value. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA and applicable exemptions promulgated thereunder. Investment management fees paid by the Plan to the custodians are included as a reduction of the return earned on each fund. Administrative fees paid by the Plan to the custodian for services are presented on the Statements of Changes in Net Assets Available for Benefits accordingly.

7. PLAN TERMINATION

Although it has not expressed intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions in ERISA. In the event of the Plan termination, participants would become 100% vested in their employer contributions.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the statements of net assets available for benefits.

9. TAX STATUS

The Organization adopted a pre-approved prototype plan offered by the Plan's custodian. On March 14, 2014, the Internal Revenue Service determined that the prototype plan is designed in accordance with applicable sections of the Internal Revenue Code.

9. TAX STATUS (CONT.)

Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and currently operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor or Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the plan and has concluded that as of June 30, 2024 and 2023 there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan is subject to tax examinations generally three years from its latest filing.

10. EXCESS PARTICIPANT CONTRIBUTION PAYABLE

The Plan failed the discrimination test for the year ended June 30, 2023. Excess contributions amounting to \$21,438 are recorded as a liability in the statement of net assets available for benefits and as a reduction of participant-directed contributions for the year then ended. Excess contributions for the year ended 2023 were refunded in 2024.

11. INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN

Certain information in the accompanying financial statements and ERISA required supplemental schedules related to investments and notes receivable from participants held as of June 30, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended June 30, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Mid-Atlantic Trust Company and Empower Retirement, qualified institutions.
