Opinion

We have audited the financial statements of ***The Bostwick-Braun Company Employee Stock Ownership Pension Plan*** (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements (the "financial statements").

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2023 and 2022, and the change in net assets available for benefits for the year ended December 31, 2023 in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Independent Auditors' Responsibilities for the Audit of the Financial Statements section of our report. 1. DESCRIPTION OF THE PLAN

The following description of *The Bostwick-Braun Company Employee Stock Ownership Pension Plan* (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a non-contributory defined contribution plan of *The Bostwick-Braun Company* (the "Company") that covers employees of the Company and its eligible wholly-owned subsidiaries, as determined by the Board of Directors, who are 21 years of age or older, not members of a collective bargaining unit and have completed 1,000 hours of service during the Plan year. The Plan assets are under the control of and are monitored by the Employee Stock Ownership Pension Plan Administrative Committee ("ESOPAC"), whose members are appointed by the Company's Board of Directors. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

The Company, at the discretion of the Board of Directors, elected to contribute 7.5% of participants' eligible compensation, less forfeitures, to the Plan in 2023. Participants are eligible for the Company contribution only if they are employed on the last day of the Plan year, or if they retired, died or became disabled during the year and completed 1,000 hours of service during the Plan year.

Participant Accounts

It is the Plan's policy to invest in the Company's common stock. Each participant's account is credited with the Company's contribution which is based on the participant's eligible compensation. Unrealized gains or losses on the shares held are credited to the accounts of the remaining participants at the end of the Plan year. Participants are allowed to diversify a portion of their vested shares once they have reached certain ages, as defined in the Plan agreement.

Vesting

Participants begin vesting after two years of service, and become fully vested after six years of service.

Payment of Benefits and Diversification

Upon retirement, death or disability, benefits are distributed in cash no later than sixty days after the following Plan year-end, unless the participant elects otherwise. Benefits greater than \$100,000 are to be paid out in substantially equal installments over 5 years, plus interest at a reasonable rate determined by the Plan Administrator, unless the Company determines otherwise. Under these circumstances, the entirety of all payments are treated as a repurchase of common stock from the Plan at the time of initiation, with the remaining payments treated as notes payable from the Company to the participant. If termination is for other reasons and the participant requests payment, benefits are distributed no later than the Plan year end occurring after the participant has a one-year break in service. Hardship distributions are allowed under circumstances defined in the Plan agreement. In addition, participants who meet certain age and service requirements may elect to redeem up to 50% of their vested account balance and transfer the proceeds into The Bostwick-Braun Company Retirement Savings Plan or a self-directed individual retirement account, or receive a direct distribution of cash.

Effective January 1, 2024, the benefit payment policy was amended. Following the amendment, all benefit payments will be made entirely in cash. Payments less than \$7,000 will be lump sums, while payments over \$7,000 will be paid in five annual installments. The portion of participant shares of Company common stock which are not yet paid out will continue to be invested in common stock and are subject to changes in the value of the stock until the date of distribution.

Forfeited Accounts

Forfeitures are used to reduce Company contributions for the current or succeeding Plan year. Company contributions were reduced by \$36,821 in 2023 by using forfeited nonvested accounts. There were no forfeited nonvested account balances at December 31, 2023 and 2022.

Voting Rights

Each participant is entitled to exercise voting rights attributable to the shares allocated to their account and is notified by the ESOPAC prior to the time that such rights are to be exercised. The ESOPAC is not permitted to vote any allocated shares for which written instructions have not been given by a participant. The ESOPAC is required, however, to vote any unallocated shares on behalf of the collective best interest of Plan participants and beneficiaries.

Put Option

Under federal income tax regulations, the Company common stock that is held by the Plan and its participants and is not readily tradable on an established market includes a put option. As defined in the Plan document, the put option is a right to demand that the Company buy any shares of its common stock distributed to participants for which there is no market. The put price is representative of the current fair market value of stock, appraised by an independent third party. The purpose of that put option is to ensure that the participant has the ability to ultimately obtain cash for the value of their shares.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("US GAAP").

Use of Estimates

The preparation of financial statements in conformity with US GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. The fair value of The Bostwick-Braun Company common stock is one such significant estimate. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The investment is reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The ESOPAC utilizes fair value measurements to record fair value adjustments to its investment and to determine fair value disclosures. See Note 4 for discussion of fair value measurements.

The change in fair value of the Plan's investment is included in the statements of changes in net assets available for benefits as unrealized loss on investment in the Company's common stock.

Contributions

Employer contributions are recorded in the period in which they become obligations of the Company.

Benefits Paid to Participants

Benefit payments to participants are recorded when paid.

Administrative Expenses

The Plan's administrative expenses, including salaries related to Plan administration and audit and legal fees, are paid by the Company and qualify as party-in-interest transactions which are exempt from prohibited transaction rules. Expenses that are paid directly by the Company are excluded from these financial statements.

Subsequent Events

In preparing these financial statements, Plan management has evaluated, for potential recognition or disclosure, significant events or transactions that occurred during the period subsequent to December 31, 2023, the most recent statement of net assets available for benefits presented herein, through the date of the accompanying Independent Auditors' Report, the date these financial statements were available to be issued.

3. INVESTMENTS

The Plan's investment is held by the ESOPAC. The Plan's investment in common stock of the Company experienced realized and unrealized loss of \$8,854,104 in 2023. The fair value of the investment was \$4,235,645 at December 31, 2023 and \$15,829,362 at December 31, 2022.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of fair value hierarchy under Accounting Standards Codification 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurements. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for the asset measured at fair value. For the financial asset recorded at fair value, the description includes an indication of the level of the fair value hierarchy in which the asset is classified. There have been no changes in the methodology used at December 31, 2023 and 2022.

The Bostwick-Braun Company common stock: The fair value of the Company common stock is determined annually by an independent appraiser and is based on significant unobservable inputs, as defined in the appraiser's valuation report. This appraisal was based upon a combination of several different approaches for valuation of common stock; specifically, income, asset and market based approaches. In substantiating the reasonableness of the pricing data provided by the appraiser, the ESOPAC evaluates a variety of factors including a review of methods and assumptions used by the appraiser. See Plan Administrator for additional information regarding the independent valuation report.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although Plan management believes its valuation method is appropriate and consistent with methods used by others, the use of different methodologies or assumptions to determine the fair value of the Company common stock could result in a different fair value measurement at the reporting date.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. Plan management evaluates the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. There were no transfers of assets into or out of Level 3 in 2023 and 2022.

5. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan's investment consists of shares of the Company's common stock. This investment, with a fair value of \$4,235,645 and \$15,829,362 at December 31, 2023 and 2022, respectively, qualifies as a party-in-interest investment which is exempt from the prohibited transaction rules.

6. TAX STATUS

The Plan has received a favorable determination letter dated July 15, 2014 from the Internal Revenue Service ("IRS"), that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving this determination letter, the Plan Administrator and the Plan's legal counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Additionally, the Plan Administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC, and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

US GAAP requires Plan management to evaluate and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. While the Plan may be subject to routine audits by taxing jurisdictions, there are currently no audits for any tax periods in progress.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

8. RISKS AND ECONOMIC UNCERTAINTIES

Due to the level of risk associated with this investment and the level of uncertainty related to changes in the value of the Company's common stock, it is at least reasonably possible that changes in the fair value of this investment will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and changes in net assets available for benefits.
