## INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Centro de la Familia de Utah 401(K) and Profit-Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended June 30, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Centro de la Familia de Utah 401(K) and Profit-Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2025 and 2024, and for the year ended June 30, 2025, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

## 1. DESCRIPTION OF PLAN

The following description of the Centro De La Familia De Utah 401(K) and Profit-Sharing Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

### **General**

The Plan is a defined contribution plan covering all full-time employees of the Sponsor ("Company") who have twelve months of service, reach minimum age of 21 and worked at least 1,000 hours in the previous 12 months. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees oversees the governance of the Plan.

### **Contributions**

The Company may elect to make a profit-sharing contribution. Company contributions are discretionary and will be announced when made. Each year, participants may contribute a percent of annual compensation towards pretax 401K or after-tax Roth contribution, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. Contributors are automatically invested in a designed balanced fund until changed by the participant.

### **Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) Company's contribution (b) Plan earnings (losses) and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Company contributions, if any, are based upon years of service, and vest at the following rate:

<u>Years of Service</u>	<u>Vested Percentage</u>
Less than 2 years of service	0%
At least 2 years of service	50%
At least 3 years of service	100%

Participants receive a year of service credit for purposes of vesting for each Plan year during which they work at least 1,000 hours for the Sponsor. If a participant dies, becomes disabled, or reaches the normal retirement age of 65 while employed by the Sponsor, the participant's interest in the Plan becomes 100 percent non-forfeitable without regard to the graduated vesting schedule.

### **Payment of Benefits**

On termination of service due to death, retirement, severance of service, attainment of age 59 ½ or disability, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount, lump sum and installments, or in

annual installments over a period not to exceed the life expectancy of the participant or the beneficiary. Benefits are recorded when paid.

#### **Hardship Distributions**

The Plan permits hardship distributions for medical expenses, purchase of a principal residence, tuition, burial or funeral expenses. The distributions are distributed in the same manner as regular distributions and are controlled by IRS regulation.

## **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### **Basis of Accounting**

The financial statements of the Plan are prepared using the accrual method of accounting.

#### **Estimates**

The preparation of financial statements, in conformity with generally accepted accounting principles, requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is defined as the amount that would be received to sell an asset in an orderly transaction between market participants at the measurement date.

#### **Investment Options**

A participant has the right to direct the trustee with respect to the investment or reinvestment of the assets comprising the participant's individual account only if the trustee consents in writing to permit such direction. The trustee will maintain a segregated investment account to the extent a participant account is subject to participant self-direction.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Notes Receivable from Participants**

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

#### **Plan Termination**

Although it has not expressed an intent to do so, The Plan Sponsor has the right under the plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

#### **Forfeitures**

Any money left behind by a terminated participant who is not fully vested, will be used to either pay for plan expenses or offset future Company contributions. The Company had forfeitures totaling \$1,861 during the year ended June 30, 2025. As of June 30, 2025 and 2024, the Company has \$4,596 and \$2,735, respectively in forfeitures to be used to offset future employer contributions.

#### **Administrative Expenses**

The Company absorbs a significant amount of Plan expenses including the cost to audit the Plan.

### **Date of Management’s Review and Subsequent Events**

Management has evaluated subsequent events through December 9, 2025, the date which the financial statements were available to be issued.

### **3. INVESTMENTS**

The Plan’s investments as of June 30, 2025 and 2024 consisted of mutual funds that are held in an investment company-administered trust fund and totaled \$2,417,832 and \$1,811,300, respectively. Expenses are netted against investment gains. Investments are reported at fair value in the accompanying statement of net assets available for benefits.

The following presents investments that represent 5 percent or more of the Plan’s net assets available for benefits as of June 30, 2025:

During the year ended June 30, 2025, the Plan’s investments, including investments bought, sold, and held during the year, appreciated in value by \$251,421 as determined by quoted market prices.

### **4. TAX STATUS**

The Plan was created on July 1, 2019, and was amended during that initial year (year ended June 30, 2020). The Plan administrator and the Plan’s tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize tax liability (or asset) if the Plan has taken an uncertain tax position that would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **5. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amount reported in the statement of net assets available for benefits.

## 6. FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels. The following hierarchy prioritizes the inputs to valuation methodologies used to measure fair value:

- Level 1 inputs, which have the highest priority, are quoted prices for identical assets in active markets. The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan or funds register with the U.S. Securities and Exchange Commission. The mutual funds held by the plan are considered to be actively traded.
- Level 2 inputs are observable inputs other than quoted prices included in Level 1, such as quoted prices for similar assets in active markets or quoted prices for identical or similar assets in markets that are not active.
- Level 3 inputs, which have the lowest priority, are unobservable inputs that reflect the Plan's own assumptions, consistent with reasonably available assumptions made by other market participants.

These party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.
