### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, on the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## **Other Matters**

### *Basis of Accounting*

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

### *Supplemental Schedules Required by ERISA*

The supplemental schedule of assets (held at end of year) and the schedule of delinquent participant contributions are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or are derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedules related to assets held by and certified to by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (the "Trustee"), agrees to, or is derived from, in all material respects, the information prepared and certified by the Trustee that management determined meets the requirements of ERISA Section 103(a)(3)(C).

*Note 1. Description of the Plan*

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan was originally a part of the Waupaca Foundry, Inc. Consolidated Retirement Plan ("Waupaca"), and was spun out effective January 1, 2023. Waupaca was adopted on November 1, 1957 with the new Plan being restated effective January 1, 2023 and again on January 1, 2024. The Plan covers all employees of Effingham Machining & Assembly Components, Inc. (the "Plan Sponsor") who meet the service requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan management is currently evaluating the provisions of the SECURE Act to determine which amendments will be made, if any, and how the Plan will adopt controls for mandatory provisions as applicable.

**Age and service requirements:** For salary deferral contributions, participant's become eligible to enter the Plan upon hire. For all other contributions, employees must have complete 6 months of service, with a yearly entry date of January 1. The Plan recognizes service with the predecessor employers (see Plan document for the full listing of predecessor employers). Effective January 1, 2024, the Plan was amended to remove the service requirement and allow for immediate entry for all contribution types.

**Contributions:** Under the Plan, participants may elect to make pre-tax 401(k) contributions ("deferrals") to their employee accounts in amounts up to maximum amount of 75% and minimum of 1% allowed under Sections 415(c), 402(g) and 401(k) of the Internal Revenue Code. Participants may also elect to make after-tax Roth elective deferrals and rollover contributions. Effective January 1, 2024, the Plan was amended to allow the Plan Sponsor to make a discretionary matching contribution on a pay period basis. During the Plan year ended December 31, 2024, contributing participants were matched at 100% of the first 6% of compensation for a total of \$475,286.

Furthermore, the Plan Sponsor may make an annual contribution on a discretionary basis to employees meeting certain eligibility requirements. For the plan year ended December 31, 2024, \$516,220 of discretionary contributions were deposited into the Plan. No additional discretionary contributions were made subsequent to year end.

**Participant accounts:** Each participant's account is credited with the participant's salary deferral and allocations of (a) the Plan Sponsor's profit-sharing contribution, if any, and (b) plan earnings and charged with an allocation of administrative expenses, if any. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Income taxes:** The Plan adopted a restated pre-approved plan document, and the IRS has determined and informed the sponsor of the pre-approved plan document by a letter dated June 30, 2020, that the pre-approved plan document is designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the opinion letter. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

The Plan adopted the provisions of FASB ASC 740, Accounting for Uncertainty in Income Taxes. Accordingly, management has evaluated the Plan's tax positions and concluded the Plan had maintained its tax-exempt status, does not have any significant unrelated business income and had taken no uncertain tax positions that require adjustment or disclosure in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the Federal authorities for years before 2021.

**Vesting:** Participants in the Plan are 100% vested in the current value of their pre-tax 401(k) deferrals, Roth elective deferrals, and Rollover contributions plus earnings thereon. Vesting in employer contributions is based on hours of service with 1,000 hours of service per year requirement. A participant is 100% vested after six years of credited service according to the following schedule:

**Forfeitures:** If upon termination of employment a participant is not fully vested in their employer contribution, all non-vested amounts shall be retained by the Plan. Per the Plan Document, the Plan Administrator may elect to use forfeitures to pay plan expenses then reduce employer contributions. For the year ended December 31, 2024, \$206,899 in forfeitures were used to reduce employer contributions. Total unallocated forfeitures at December 31, 2024 and 2023, were \$46 and \$111,021, respectively.

**Unallocated assets:** The Plan held assets in an unallocated account which received a deposit related to the spinoff as a result of a transition holding agreement with Delaware Charter Guarantee & Trust d/b/a Principal Trust Company. During the year ended December 31, 2024, there were no deposits into the account and no funds allocated to participants. Total unallocated assets at December 31, 2024 and 2023 were \$396 and \$378, respectively.

**Investment options:** Upon enrollment in the Plan, a participant may direct all contributions into various registered investments, pooled separate accounts, and fixed accounts with varying amounts of investment risks. Participants may change their investment options and transfer funds between investment options daily.

**Payment of benefits:** The Plan permits participants to withdraw funds at any time after age 59 ½. The Plan also provides for withdrawals in the event of death, disability, hardship and termination. Benefit payments can be in the form of a lump-sum amount equal to the value of the participant's vested interest in his or her account, as provided in the Plan document.

**Notes receivable from participants:** As permitted under the terms of the Plan's participant loan policy, participants may borrow from the fund accounts a minimum of \$1,000 to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms range from one to five years. Participants may not have more than one loan outstanding at any time. The loans are collateralized by the balance in the participant's account and bear interest at a reasonable rate that is commensurate with the prime rate plus 1% (8.50% at December 31, 2024). Principal and interest is paid ratably through payroll deductions.

**Funding policy:** Deferrals are withheld from eligible participants' wages and are remitted bi-weekly or monthly (dependent upon eligible participant's position) to the Plan Trustee. Discretionary employer matching contributions are remitted bi-weekly or monthly (dependent upon eligible participant's position). Employee and employer contributions are invested based on the instructions provided by the participant.

*Note 2. Significant Accounting Policies*

**Valuation of investments:** The Plan invest in registered investment companies and a pooled separate account that are reported at fair value. See Note 3 for discussion of fair value measurements. Additionally, the Plan holds a guaranteed investment contract held at contract value as described in Note 4.

The changes in the difference between the value and cost of investments and realized gains and losses are reflected in the statement of changes in net assets available for plan benefits - modified cash basis, as an increase or decrease in net realized and unrealized appreciation or depreciation in the value of investments.

**Accounting method:** The Plan prepares its financial statements on a modified cash basis of accounting, which is a basis of accounting other than U.S. generally accepted accounting principles. This basis is an acceptable method of reporting under the Department of Labor regulations. Under this method, contributions, interest and dividends and other amounts are recognized only when actually received by the Plan. Investments are stated at fair value and contract value.

**Payment of benefits:** Benefits are recorded when paid.

**Estimates and assumptions:** Management uses estimates and assumptions in preparing financial statements. Those estimates and assumptions affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities, and the reported revenues and expenses. Accordingly, actual results may differ from these estimates.

*Note 3. Fair Value Measurements*

The Fair-Value Measurements topic of the FASB ASC 820-10 defines fair value, establishes a framework for measuring fair value in generally accepted accounting principles and expands disclosures about fair-value measurements. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs are other than quoted prices that are observable for the asset or liability. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

*Registered investment companies and money market funds:* Valued at the net asset value (NAV) of shares held by the Plan at year end.

*Pooled separate accounts:* The pooled separate accounts are stated at fair value and represent the number of participation units owned by the Plan. Quoted market prices of the underlying investments are used to value each fund and are based on the net asset value of the shares held at the end of the year.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### Note 4. Investments at Contract Value

The Plan holds investment contracts issued by Principal Life Insurance Company (“the contract issuer”). The contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. At December 31, 2024 and 2023, the total contract value of this investment amounted to \$2,655 and \$5,505, respectively.

The investment contracts held by the Plan are guaranteed investment contracts. These contracts are designed to accrue interest based on crediting rates established by the contract issuers. The contract issuers are contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan.

The crediting rate is based on a formula established by the contract issuer but may not be less than 1% for the contract with Principal Life Insurance Company. Such interest rates are reviewed on an annual basis and quarterly basis, respectively, for resetting. The contracts do not have a maturity date.

The Plan must provide 90 day written notice to redeem its interest in the investment at contract value. Withdrawals from the contract may be subject to a surrender charge and a 6-month notice period.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under Employee Retirement Income Security Act at 1974.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that would also limit the ability of the Plan to transact at contract value with the participants.

#### *Note 5. Costs and Expenses*

Certain costs and expenses associated with the operations of the Plan for the year ended December 31, 2024 were paid by the Plan Sponsor.

#### *Note 6. Plan Termination*

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan document to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants will become 100% vested in their accounts.

#### *Note 7. Transactions with Parties-In-Interest*

Effingham Machining & Assembly Components, Inc. provides to the Plan certain accounting and administrative services for which no fees are charged. The employees that provide these services, such as trustees and other employees, are also contributing participants in the Plan. These transactions qualify as party-in-interest transactions. Notes receivable from participants are also considered party-in-interest transactions. However, under the provisions of ERISA these transactions meet the criteria for exemption, are not considered prohibited transactions, and do not need to be reported in the supplementary schedules of Form 5500.

The Plan invests in shares of registered investment companies and the common collective trust are managed by an affiliate of Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company ("Principal"). Principal acts as trustee for only those investments as defined by the Plan. Transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

#### *Note 8. Risk and Uncertainties*

The Plan provides for any combination of various investment options. Investments are exposed to various risks, such as interest rate, credit and market risk. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amount reported in the statements of net assets available for benefits – modified cash basis and the statement of changes in net assets available for benefits – modified cash basis.

#### *Note 9. Information Certified by the Plan's Trustee*

The Plan Administrator has elected the methods of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal as of December 31, 2024 and 2023 and for the year ended December 31, 2024, has certified that the following data included in the accompanying financial statements and supplemental schedules is complete and accurate.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information with the related information included in the financial statements and supplemental schedules.

#### *Note 10. Prohibited Transactions*

For the Plan year ended December 31, 2023, the Plan Sponsor failed to deposit certain contributions and loan repayments within a timely manner. Because of this, \$41,222 in contributions and loan repayments were deemed late. Of those contributions, \$4,525 were caught by the Plan Sponsor and have been corrected through the self correction program as of December 31, 2024. Management is currently in the process of correcting the remaining late remittances.
