Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2025 Financial Statements

We have performed an audit of the financial statements of Maine Dartmouth Family Medicine Residency 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of June 30, 2025, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

1. Description of Plan

The following description of the Maine Dartmouth Family Medicine Residency 403(b) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions, including vesting and benefit provisions.

The Plan is a tax-exempt defined contribution plan covering substantially all employees of Maine Dartmouth Family Medicine Residency (the Company). The Plan is a volume submitter plan sponsored by the Plan's third-party administrator (TPA). The Internal Revenue Service has determined and informed the Plan's TPA, by a letter dated March 31, 2017, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since the Plan's TPA received the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Participants should refer to the Summary Plan Description previously provided to them for a description of vesting and benefit provisions.

Contributions

Participants may voluntarily contribute up to the maximum amount allowed by law under the IRC Sections 402(g) and 415. The Company contributes an employer match which is equal to 50% of each eligible participant's elective deferral which does not exceed 5% of compensation. The Company may contribute a discretionary contribution. In 2025, the Company made a discretionary contribution equal to 3% of compensation. Contributions are subject to certain limitations.

Forfeitures

Forfeitures of nonvested employer contributions, resulting from terminated participants, can be used to pay Plan expenses or may be allocated as additional employer contributions or used to reduce other employer contributions under the Plan. As of June 30, 2025 and 2024, there was \$18,031 and \$89,771 in forfeitures, respectively. In 2025, the Company applied \$111,794 in forfeitures toward eligible purposes.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities, at the date of the financial statements. Accordingly, actual results could differ from those estimates.

Investments

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Administrative Expenses

Certain administrative expenses for the Plan are paid by the Company.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued, but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document. Interest income on notes receivable totaled \$2,599 and \$265 for the years ended June 30, 2025 and 2024, respectively.

Payment of Benefits

Benefits paid to participants are recorded when amounts are distributed.

Subsequent Events

Management has considered transactions or events occurring through January 19, 2026, which is the date that the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

3. Information Certified by Ascensus, LLC

Information included in the financial statements and supplemental schedule, relating to investments, investment and notes receivable from participants' income, and notes receivable from participants was obtained by the plan administrator and agreed to or derived from the information certified to be complete and accurate by Ascensus, LLC, as an authorized representative of Ascensus Trust Company. This information is included in the following:

4. Party-in-Interest Transactions

Certain Plan investments are units of mutual funds managed by Ascensus Trust Company. Ascensus Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as transactions with a party-in-interest. Administrative expenses paid by the Plan totaled \$107,995 and were paid to the Plan trustee and financial advisor.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

7. Fair Value Measurement

The Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at June 30, 2025 and 2024:

Mutual funds and money market fund: Valued at the quoted net asset value of units held by the Plan at year-end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
