NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the SSF Imported Auto Parts LLC Profit Sharing and Incentive Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

(a) GENERAL

The Plan is a defined contribution 401(k) plan, which covers all eligible employees of SSF Imported Auto Parts LLC (the Company). An employee must be at least 18 years old and must have at least one month of service in order to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan became effective on July 1, 1980. The Plan was most recently amended effective February 1, 2025 to increase the automatic deferral rate from 3% to 4%.

(b) CONTRIBUTIONS

The Plan permits the automatic enrollment of eligible employees in the Plan with a contribution of 4% of eligible compensation, unless the employee affirmatively elects otherwise. A participant may elect to contribute their eligible compensation up to the amount allowable under the Plan document, subject to IRS regulation limitations. The Company makes a discretionary matching contribution of 50% of the employee's first 8% of eligible compensation contributed during the Plan year. This match is paid on a quarterly basis. The Plan also allows for a discretionary profit-sharing contribution. The Company made \$417,317 in discretionary matching contributions for the year ended June 30, 2025.

(c) PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contributions, the Company's matching contributions, and an allocation of Plan earnings. The benefit to which a participant is entitled is the vested benefit that can be provided from the participant's account.

(d) VESTING

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the remainder of their accounts increases by 20% per year after completion of two years of continuous service then vests at a rate of 20% for the next four years. A participant is 100% vested after six years of continuous service.

NOTE 1 - DESCRIPTION OF THE PLAN (continued)

(e) NOTES RECEIVABLE FROM PARTICIPANTS

A participant may borrow up to 50% of their vested account balance subject to a minimum amount of \$1,000 and a maximum amount of \$50,000. Loan terms range from one to five years, or longer for the purchase of a primary residence. These loans bear interest at a rate which is comparable to commercial lending institutions. Loans are secured by the participant's vested interest in the Plan. At June 30, 2025, interest rates on loans ranged from 5.25% to 10.50% per annum. Principal and interest are paid through payroll deductions.

(f) PAYMENT OF BENEFITS

On termination of service, a participant may elect to receive all or any part of his or her vested balance paid at any time. In-service distributions of vested account balances are permissible under the Plan if the participant incurred a financial hardship. Benefits are recorded when paid. There were no benefit claims for participants who have elected to withdraw from the Plan but have not yet been paid as of June 30, 2025.

(g) FORFEITURES

Forfeitures of terminated participants' non-vested accounts can be used to reduce administrative expenses. Any excess forfeiture can be used to reduce future employer contributions. During the year ended June 30, 2025, the Company used \$80,883 of available forfeitures to reduce employer contributions of the Plan and \$141 of available forfeitures to reduce plan expenses. Total available forfeitures at June 30, 2025 and 2024 amounted to \$75,888 and \$77,576, respectively.

(h) ADMINISTRATIVE EXPENSES

The Company incurs certain expenses in administering the Plan, which are not passed on as expenses of the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

(a) BASIS OF ACCOUNTING

The financial statements of the Plan are prepared under the accrual method of accounting.

(b) USE OF ESTIMATES

The preparation of financial statements in accordance with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions. Those estimates and assumptions affect the reported amounts of assets and liabilities, and the reported revenues and expenses during the reporting period. Although the Plan administrator believes its estimates are appropriate, changes in assumptions utilized in preparing such estimates could cause these estimates to change sometime in the future.

(c) RISKS AND UNCERTAINTIES

The Plan utilizes various investment instruments, including a stable value fund and mutual funds. Investment instruments, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment instruments, it is reasonably possible that changes in the values of investment instruments will occur in the near term and that such changes could materially affect amounts reported in the financial statements.

(d) INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investments are valued at fair value as determined by Principal Life Insurance Company and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal) as of June 30, 2025 and 2024.

(e) NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expensed when they are incurred. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of June 30, 2025 or 2024.

(f) SUBSEQUENT EVENTS

The Plan has evaluated events and transactions occurring subsequent to the statement of net assets available for benefits date of June 30, 2025, for items that should potentially be recognized or disclosed in these financial statements. The evaluation was conducted through January 29, 2026, the date these financial statements were available to be issued. No such material events or transactions were noted to have occurred.

NOTE 3 - INVESTMENTS

The Plan's funds are maintained by Principal. The Plan's funds are credited with contributions and actual earnings on the underlying investments and charged for Plan withdrawals. The Plan's funds in the financial statements as of June 30, 2025 and 2024 are the values as reported to the Plan by Principal.

The following was certified as to being complete and accurate by Principal:

- Investment accounts and notes receivable from participants as shown in the statements of net assets available for benefits as of June 30, 2025 and 2024.
- Net appreciation in fair value of investments, dividend income, and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended June 30, 2025.
- Supplementary schedule of assets (held at end of year) at June 30, 2025.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the statements of net assets available for benefits and statement of changes in net assets available for benefits and supplementary schedule of assets (held at end of year).

Participants may change their investment options at their discretion.

NOTE 4 - FAIR VALUE MEASUREMENT

The Plan adopted the fair value accounting standard for those assets that are re-measured and reported at fair value at each reporting period. This standard establishes a single authoritative definition of fair value, sets out a framework for measuring fair value based on inputs used, and requires additional disclosures about fair value measurements. This standard applies to fair value measurements already required or permitted by existing standards.

The three levels of the fair value hierarchy under the standard are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

- (a) In accordance with Financial Accounting Standard Board Accounting Standard Codification Subtopic 820-10, certain investments that were measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits. There are no participant redemption restrictions for these investments, the redemption notice period is applicable only to the Plan. The investments have no unfunded commitments as of June 30, 2025 and 2024. The redemption frequency and redemption notice period is daily.

The following is a description of the valuation methodologies used for assets measured at fair value:

- **Mutual Funds:** Fair values are based on quoted prices (unadjusted) in active markets for identical assets that the Plan has the ability to access at the measurement date.
- **Pooled Separate Accounts:** Valued at the Net Asset Value ("NAV") of shares held by the Plan at year end. The NAV is based on the underlying assets owned by the Fund, less its liabilities, and then divided by the number of shares outstanding. The pooled separate accounts each invest in a single mutual fund which is valued using quoted pricing in active markets for identical assets.
- **Stable Value Fund:** Valued at the Net Asset Value ("NAV") of shares held by the Plan at year end. The NAV is based on the underlying assets owned by the Fund, less its liabilities, and then divided by the number of shares outstanding. There are no significant redemption restrictions or unfunded commitments on these investments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - TAX STATUS

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan Administrator and Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with applicable requirements of the IRC, and therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 - EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain investment instruments are managed by Principal. Principal is a trustee as defined by the Plan; therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

In the event the Plan is terminated, all assets shall become 100% vested and the assets will be allocated to each participant in the proportion each account balance bears to the total of all account balances.
