## INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of the  
IUPAT District Council No. 21  
of Northeastern PA Annuity Plan

### Opinion

We have audited the financial statements of the IUPAT District Council No. 21 of Northeastern PA Annuity Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of May 31, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of May 31, 2025 and 2024, and the changes in its net assets available for benefits for the years then ended in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

**NOTES TO FINANCIAL STATEMENTS**

MAY 31, 2025 AND 2024

**NOTE 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Method of Accounting** - The financial statements are prepared using the accrual basis of accounting.

**Investment Valuation and Income Recognition** - Investments in equity mutual funds, fixed income mutual funds, and the money market mutual fund are carried at fair value as provided by the investment custodian which represents quoted market prices or the net asset value of the mutual funds as of the last business day of the year. The common collective trusts are carried at Net Asset Value (NAV) as reported by the respective trusts. The Plan's investment in the Guaranteed Income Fund is reported at contract value as provided by the custodian. Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Funding Policy and Revenue Recognition** - The Plan is funded by contributions from participating employers under the terms of collective bargaining agreements (CBA). Employer contributions are accounted for as exchange transactions. The contributions are due on a monthly basis. It is the policy of the Trustees to pursue monies due.

**Employer Contributions Receivable** - Contributions due but not paid prior to year end are recorded as contributions receivable. The Plan believes that the receivables are fully collectible; therefore, no allowance for credit losses is recorded.

**Estimates** - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures in the financial statements. Actual results could differ from those estimates.

**Payment of Benefits** - Benefit payments to participants are recorded when paid.

**NOTE 2. DESCRIPTION OF PLAN**

The Plan is a multiemployer, participant directed defined contribution plan and is subjected to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan is a 404(c) plan where the participants select the investments, from a list of investment options made available to the participants by the Plan, for all of their participant accounts under the Plan.

**NOTE 2. DESCRIPTION OF PLAN (continued)**

The Plan covers all eligible members in northeastern Pennsylvania (participants) pursuant to a collective bargaining agreement between IUPAT District No. 21 (the District Council), and P.D.C.A. of Northeast Pennsylvania, representing affiliated employers.

The participating employers contribute to the Plan for each hour the participant works as specified in the collective bargaining agreements. The employer contribution rate for Journeymen ranges between \$2.80 to \$7.98 per hour for the year ended May 31, 2025 and between \$2.80 to \$7.95 per hour for the year ended May 31, 2024. Apprentices receive approximately 50% of the Journeymen rate. The Plan allows for participants to rollover contributions from another qualified retirement or annuity plan. No voluntary contributions may be made by participants.

A member becomes a participant in the Plan on the first day of their covered employment with a participating employer within the jurisdiction and in accordance with the terms of the collective bargaining agreement. The member, as described above, becomes a participant regardless of age or length of service. Participants are immediately 100% vested in their account.

Participants may elect to receive a distribution of their participant account upon reaching normal retirement age (age 55), if the participant has become disabled, or upon death. A participant may also elect to receive a distribution six months after employment terminates. The Plan also allows in-service withdrawals of the account value of their rollover contributions.

Each participant's account is credited with employer contributions and investment earnings on the investments elected by the participant. Participant accounts are charged with investment and recordkeeping fees and a quarterly administrative charge used to pay administrative expenses of the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Benefits may be distributed either as a single lump sum payment, through installment payments, through the purchase of an annuity contract, as a single life annuity, as a 50% qualified joint and survivor annuity, or as a direct rollover to another eligible retirement plan.

Effective June 1, 2021, the Plan was amended to become a profit sharing plan. Account balances including interest earned for amounts contributed for employment prior to June 1, 2021 will follow the money purchase plan rules of the Plan. Account balances including interest on amounts contributed for employment on or after June 1, 2021 will be eligible for the profit sharing plan rules adopted by the Plan.

Participants should refer to the Plan Document or Summary Plan Description (SPD) for complete information.

### **NOTE 3. TAX STATUS**

The Plan obtained its latest determination letter on March 10, 2003 in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements under Sections 401(a) of the Internal Revenue Code and was, therefore, exempt from Federal income taxes under the provisions of Section 501(a). The Plan has been amended since receiving the determination letter. The Plan's administrator and the Plan's counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the U.S. Federal, state, or local taxing authorities. The Plan is subject to routing audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Typically, plan tax years will remain open for three years; however, this may differ depending upon the circumstances of the Plan.

### **NOTE 4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

#### **Basis of Fair Value Measurement:**

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

**NOTE 5. GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan's Guaranteed Income Fund is maintained pursuant to a traditional fully benefit-responsive guaranteed investment contract with Prudential Retirement Insurance and Annuity Company (Prudential) and Transamerica Investors Securities Corporation (Transamerica).

The account is credited with earnings on the underlying investment and charge for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the Statements of Net Assets Available for Benefits at contract value.

Contract value, as reported to the Plan by Prudential and Transamerica, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issue or otherwise. The guaranteed investment contract does not contain a schedule maturity date. The contract value of the investment contract at May 31, 2025 and 2024 was \$241,783 and \$204,042, respectively.

Generally, there are not any events that could limit the Plan's ability to transact the guaranteed investment contract at contract value paid within 90 days or in rare circumstances, contract value paid over time. There are not any events that allow the issuer to terminate the contract and which require the plan sponsor to settle at an amount different than contract value paid within 90 days or over time.

**NOTE 6. RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS**

The Plan has common Trustees and shares office facilities and staff with other District Council No. 21 Benefit Plans (DC 21 Benefit Plans). The operating expenses of the common facilities and staff are initially paid by the IUPAT District Council No. 21 Welfare Fund (the Welfare Fund). During the years ended May 31, 2025 and 2024, the Plan reimbursed the Welfare Fund \$34,086 and \$61,409, respectively, for administration fees. As of May 31, 2025 and 2024, the Plan owed the Welfare Fund \$9,644 and \$33,780, respectively. The employer contributions for all DC 21 Benefit Plans are initially deposited into the Administrative Account and then transferred to the respective plans on a monthly basis. As of May 31, 2025 and 2024, the Plan's share of the Administrative Account was \$35,885 and \$53,039, respectively.

**NOTE 6. RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS  
(continued)**

Certain investments of the Plan are investments managed by Transamerica. Transamerica is the custodian and recordkeeper for the Plan, and therefore, these transactions qualify as party-in-interest transactions. These investments have been denoted as such on the supplemental Schedule of Assets Held at End of Year as of May 31, 2025.

The above qualify as party-in-interest transactions which are exempt from the prohibited transaction rules of ERISA.

**NOTE 7. PRIORITIES UPON TERMINATION**

Although it has not expressed an intention to do so, the Board of Trustees have the right under the Plan to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Should the liquidation value of the assets on the date of termination be less than the total of the participants' accumulated shares plus expenses, each participant shall receive that part of the total remaining assets in the same ratio as their accumulated share bears to the aggregate amount of the accumulated shares of all participants.

**NOTE 8. RISKS AND UNCERTAINTIES**

The Plan's investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonable possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 9. INTERNAL REVENUE SERVICE EXAMINATION**

In September 2021, the Plan was issued a request for its records by the Department of the Treasury Internal Revenue Service Tax Exempt and Government Entities (IRS) department. The Plan believes it was selected for the audit as part of the IRS's routine, random examination process. The Plan believes that no issues exist that would have an adverse impact on the Plan.

**NOTE 10. SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through October 23, 2025, the date the financial statements were available to be issued, and they have been evaluated in accordance with relevant accounting standards.
