Re: Reasonable Cause Letter for Late Filing of Form 5500 for the 2023 and 2024 Plan Years

Dear Sir or Madam,

I am writing on behalf of Assurance Hospice to explain the circumstances that led to the late filing of our Form 5500 for the 2023 and 2024 plan years, which pertains to our 401(k) plan. We are requesting that the IRS consider our situation as reasonable cause for the delay in filing and that any associated penalties be abated.

We sincerely apologize for the delay in filing and would like to provide an explanation of the circumstances that led to the late submission:

1. **Reason for Delay:**

I purchased the Company in May of 2023. At the end of 2023 or the beginning of 2024, I spoke with the previous owners regarding filing of tax returns. They assured me that that was completed by our plan administrator, ADP. I called ADP at that time and spoke with a spokesperson that confirmed that ADP would be responsible for filing the Form 5500. I relied on these representations.

2. **Steps Taken to Correct the Issue:**

The issue of non-filing was just brought to my attention by the plan administrator, ADP. As soon as I was aware of the situation, I authorized the filing of the Forms 5500 for the subject years.

3. **Efforts to Prevent Future Occurrences:**

The Company is closing and I have authorized ADP to assist me in filing the 2025 Form 5500 as well as the final return for 2026, if required.

4. **Good Faith Efforts:**

We have always strived to maintain compliance with all regulatory requirements for our 401(k) plan and have consistently filed our Form 5500 on time in prior years. This situation is an isolated incident, and we ask that you consider our past history of compliance and the good faith efforts we have made to resolve this matter.

We respectfully request that the IRS consider this explanation and grant relief from any penalties associated with the late filing of our Forms 5500. If you require additional information or documentation to support our request, please do not hesitate to contact me at (801) 554-9985.
